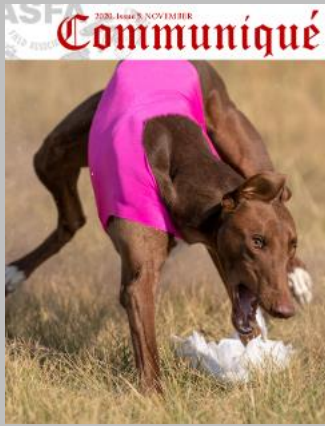

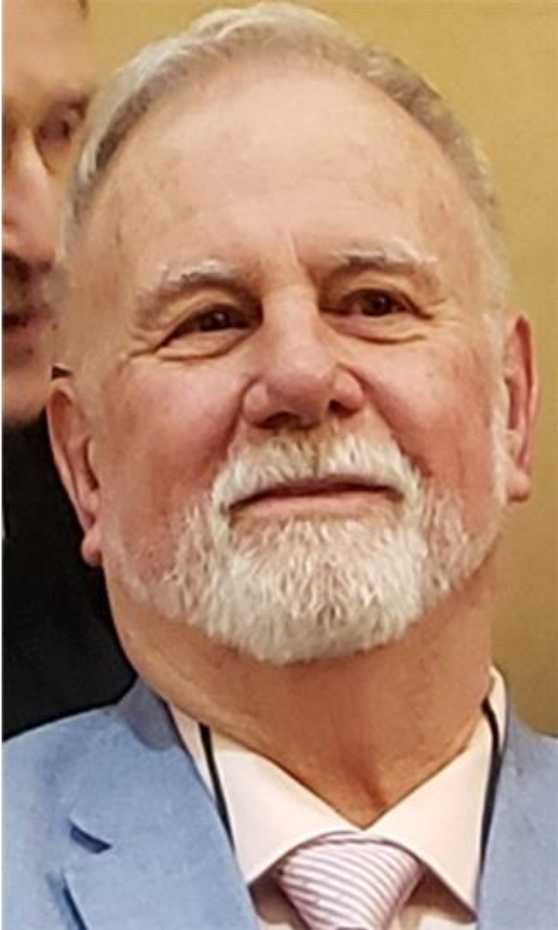

# President's Report

*... together we are improving our ASFA*

I want to thank everyone associated with our ASFA for your work during this difficult year of 2020, that has been like no other, and that will change our world forever. I am so pleased that through the shutdowns and restrictions that people were able to find ways to safely carry on.

Initially, we had many trial cancellations in April & May when people were unable to gather. The ASFA Board braced itself for a 90% drop in entries from the 5,670 entries that we had in 2019. But then, clubs began to step up and figure out how to safely hold trials during a pandemic. We started to see strong entries; and to our surprise, ASFA did much better than expected, with almost half the number of entries that we would have in a good year. I thank everyone for this. Below are the Top Ten clubs for entries through October 17<sup>th</sup>.

# Trial Records Submission Changes for 2021

**AS OF 01 JANUARY 2021, THE FOLLOWING CHANGES APPLY TO THE TRIAL RECORDS THAT FIELD TRIAL SECRETARIES MUST SUBMIT TO THE ASFA RECORDS COORDINATOR FOR EACH TRIAL.**

## **PREMIUM LIST IS REQUIRED ONLY IN LIMITED CIRCUMSTANCES**

A copy of the approved premium list is required only when there was a course plan or judge change. A LETTER OF EXPLANATION of these changes must accompany the submission.

## **ALL RECORD SHEETS ARE REQUIRED *along with certain notations.***

All record sheets for every course, including re-runs and runoffs are required. Notations are required of reasons why hounds that were entered did not run (e.g., absent, bitch in season, lame, dismissed, disqualified under the ASFA breed disqualifications, excused by the Field Trial Chairman, etc.).

## **ENTRY FORMS MUST BE SUBMITTED ONLY IF ONE OF THE FOLLOWING APPLIES:**

1. Entry forms will still be required for hounds that are entered for the first time, along with proof of registration and certification.
2. Entry forms are required that include notations for hounds working off a dismissal.
3. Entry forms are required that include any indicated change of information (e.g., new titles, or change of address or ownership).

## **PER CAPITA REPORT AND FEES**

FORM - A Per Capita Report (RECo1 rev 06/17) will be required.

FEES AND RECORDS - All per capita fees and records program surcharges are set by the Board of Directors and are payable to the ASFA in USD. (See schedule of fees on the ASFA website).

Per capita fees are required for each hound that was a paid entry in a regular stake and for each paid entry in the non-regular stake. Per capita fees are also due for any entry, regular or non-regular, that was fully refunded to the exhibitor.

All per capita fees shall be paid with a club check, certified check, money order, or through an electronic funds transfer (EFT). **Do not send cash or personal checks.**

Points will not be recorded by the Records Coordinator until either this per capita fee is received, or the Board of Directors has determined that there is an overriding reason to record the trial without fees being paid.

A penalty will be charged for late receipt or postmark of records which shall not exceed the per capita fee, subject to review by the ASFA Board of Directors. When paying electronically, the date of receipt will be the date on which ASFA is notified the payment has been received by the EFT system.

## 2021 Online ACoD

**Be Sure To Join Us - 20 & 21 March 2021**

The 2021 Annual Convention of Delegates and board meeting will be conducted online. This time we have much more time to prepare, and we will have a new even better system in place.

Most importantly for you or your club, the cost to attend this online event will be much less than attending in person - no air fares or hotel bills. We hope this will increase attendance and participation.

We are also going to have fun with some social events as we would have if we were all gathered in one hotel.

I am sure many of you will have participated in some online meetings, and you recognize that there are differences that you need to take into account. Everyone except the speaker and a few board members will have their microphones muted, but you will be able to raise your hand to be recognized to speak.

Things take a bit longer in an online meeting, so it is imperative that you take the time to read your delegate's packet **before** the meeting and take notes. The online platform will allow you to vote.

### **Some Online Meeting Hints**

There will be 2 practice sessions scheduled in March, just before the ACoD during which you can try out the online meeting system, check your internet connection and get comfortable with the software.

At your end, you will need to find an area in your home with few distractions and background noise. Set aside the meeting day as if you were away from your regular household responsibilities. I like to have some snacks and a notepad on hand. I also arrange for someone else to take care of the dogs that day.

We will be scheduling brief breaks and a time for lunch.

You can use a computer or phone to join the meeting, but I suggest you use your computer so you can see what is going on. Also, the length of this meeting means that it will use a large amount of data on your phone plan.

Your computer or laptop should have at least 4Gigs of RAM, a microphone (so you can speak to everyone), a camera would be nice but is not required. I get best results from a headset with a microphone that I can plug into my laptop (a Bluetooth headset also works). A headset cuts down on a lot of background noise! You also need to have a good, solid internet connection. This might mean you have to move closer to your router or use a cable to plug into your router. You might have to consider going to a different location if your home internet is not strong enough. If you have any questions regarding the logistics for your computer or the meeting, please let me know so that I can help. My email address is: [Reg9Dir@asfa.org](mailto:Reg9Dir@asfa.org).

Clubs or small groups of people might want to consider gathering (safely) in a central location for a “watch party”. Perhaps a hotel room or community center. It is not hard to attach a laptop to a large screen TV.

### **BIF Points**

I want to remind hound owners about possible extra points when running/winning BIF. Please stay on top of your dogs' points. The time lapse from a trial to me notifying hound owners averages 3 weeks, depending on how quickly the FTS submits and UPS delivers the records to me.

### **Registration Numbers**

I would like to remind FTSs to make sure that the registration numbers are accurate and legible. And I would like to remind hound owners that when they check the record sheets for scores, to make sure that the registration number listed for their dog is correct. If it is not correct, please make the FTS aware.

**Do you have a remarkable hound or person in mind** to nominate for the Hall of Fame? This is how it works. All nominees – hounds and persons - must have been out of the sport for at least 5 years to be considered. Hound nominations are made through the ASFA clubs. Persons are nominated through the Regions. So, to nominate a hound, you will need to work through your club. To nominate a person, you will need to work with your Regional Director. The Hall of Fame Committee will select up to 5 nominated hounds and 3 nominated persons to present for consideration at the 2021 ACoD. The ACoD Delegates will then vote to induct 1 person and up to 3 hounds into the Hall of Fame for 2021. The purpose of the ASFA Hall of Fame is to honor in perpetuity those hounds that have achieved outstanding performances or records in the sport of lure coursing. This fosters the continued remembrance of remarkable individual coursing careers and sets a high standard to help new hounds and owners achieve their goals.

The Hall of Fame shall also honor those individuals who have donated a great part of their life to improve and promote the sport of lure coursing for sighthounds. Since its inception, the sport of lure coursing has continually evolved. That evolution has taken place through the vision and energy of people who should be honored for their efforts on behalf of the sport. We shall endeavor to remember those individuals who have given their time and energy to make lure coursing what it is today. Their commitment serves as an inspiration to those who would, in turn, take the sport to greater heights.

The Hall of Fame was instituted in 1998. The 1998 Annual Convention of Delegates elected into the Hall of Fame the first Field Champion of each breed; the first Lure Courser of Merit of each breed; the first AKC

conformation champion of each breed to become an ASFA Field Champion; the only three hounds to obtain the Grand Field Champion title; and the following people: Lyle Gillette, Tom Leone, Betz Leone and Gary Forrester. These hounds and individuals are the Charter members of the ASFA Hall of Fame.

## **Procedures for Nominations:**

### **Hounds:**

Any ASFA club may recommend one hound on an annual basis to be considered for the Hall of Fame. Recommendations should be submitted on the form provided for this purpose and signed by a club officer.

Submit two photos of the nominated hound if possible. It is preferred that one photo be a still, standing or "stacked" photo and the other be a running or action photo of the dog.

The form should be submitted to the Hall of Fame Committee Chair no later than the date selected by the committee and published on the ASFA.org website for that year.

The hound should be retired and have not entered a trial in the last five years. To get the correct date of the last trial a hound entered, please contact the ASFA Records Coordinator at [records@asfa.org](mailto:records@asfa.org).

The hound should have great coursing accomplishments, including a long coursing career with a top-winning record, however, great achievement in a short time span will be considered.

The committee will then select ten hounds to be voted on by delegates convening at the ensuing Annual Convention of Delegates (ACoD).

In the event that there are not at least ten hounds nominated by clubs, the Hall of Fame Committee may nominate additional hounds to bring the total to ten. The Committee will first consider hounds previously nominated and not elected, but may also nominate hounds not previously nominated.

Three hounds will be chosen for the Hall of Fame by written ballot. A picture and biographical sketch of each hound elected into the Hall of Fame will be entered into the appropriate historian's album. The Hall of Fame Committee shall award each year at the ACoD certificates for hounds inducted into the ASFA Hall of Fame.

### **Hounds Not Elected:**

If a hound nominated to the Hall of Fame is not elected, it shall automatically be placed on the ballot for the following year. If the hound is not elected in its second year on the ballot, the nomination process must be repeated to place them on the ballot again.

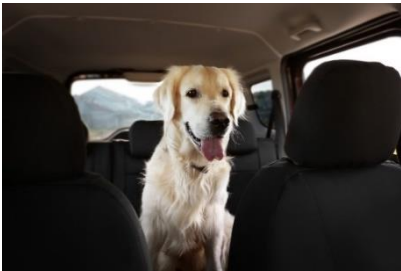
