One key area we'd like to highlight is the search for a new Records Program Programmer. Much of the groundwork of the program and database has already been laid, and we're eager to find someone who can pick up where we left off and help us complete the initial phase and build on it for future phases. The committee, led by Phil Fullam (Chair), along with Cathy Sanderson, Phil Dean, and myself, has been working diligently to define the process and goals for selecting a new programmer. Have you heard of the International Invitational (II)? I hope your answer is a resounding "yes!" The 2025 II will take place in Bainbridge, Georgia, on the weekend of October 11th and 12th. Once again, the ASFA board will host this prestigious event. We are hard at work putting everything together. We'll be releasing more details soon, so stay tuned for the premium list. This is the site of the 2017 II, and I've heard great things about the fields which are perfect for such an event. As many of you know, hosting an event of this magnitude requires a lot of support, and we'll be

reaching out for volunteers shortly. If you'd like to contribute in any way, please let me know at president@asfa.org!

This is also the year for the board to appoint a committee to submit nominations for the 2026 officer elections. I'm pleased to announce that Holy Hamilton, Ben Brodeur, and Justin Dannenbring have agreed to take on this important task and will be working on preparing a slate of nominees. If you know of anyone interested in serving on the board, please reach out to Holly at Reg6Dir@asfa.org or encourage them to have their club nominate them. There are three ways to be nominated for an ASFA Board position (President, 1st Vice President, 2nd Vice President, Chief Financial Officer, Corresponding Secretary, and Recording Secretary). The most common method is for the nominating committee to nominate individuals and submit the slate for election at the ACoD. This slate is published and submitted to the clubs 150 days before the ACoD. After publication, clubs have 45 days to submit additional nominations. These names will also be published and submitted to the clubs. The final way is through nominations from the floor at the ACoD. In all cases, nominees must consent to the nomination.

Lastly, the 2026 ACoD will once again be a virtual event. This decision comes as a result of feedback from the delegates, aiming to save costs and minimize the impact on our overall budget. As a nonprofit organization, ASFA, like many others, faces financial challenges and a budget that often leaves us in the red. This has been a recurring theme for many organizations this year, and we are actively working to turn things around. Your participation is essential to ensuring that ASFA remains financially healthy and continues its vital work.

new! Records Search Committee

Report by Phil Fullam

As many of you know, ASFA has been using a commercial database to maintain event records, titles, overall standings, and annual statistics such as number of dogs enters, number of events by region, and other important information. These records go back over three decades.

In 2022 ASFA signed a contract for a new online records program. Progress was initially hampered due to data integrity issues, as some of the older records contained invalid characters or information. These problems were corrected and development continued.

We had all hoped that the new program would be completed quickly, but sometimes life gets in the way of what we would like to happen. The initial contract between ASFA and Eddie Kominek anticipated a 2-to-3-year development effort. Unfortunately, Eddie determined last year that he did not have the personal resources to complete the work and exercised the termination clause in the contract. He has continued to support ASFA's efforts to move forward, providing documentation and access to the work that has been accomplished.

A search committee was formed in February to find a professional individual or organization that is capable of completing the Records Program. We will emphasize the selection of an individual or organization with experience developing database systems, with an established

track record and the resources to complete the task in a reasonable time. Additionally, the IT committee will be working closely with the contractor to ensure milestones are achieved, provide support as needed, and that effective testing is performed on the product as it is being developed.

The search committee has developed a Request For Proposal (RFP) for this effort. A copy has been posted on the ASFA website. Questions or comments can be sent to The Search Committee at asfarfp@gmail.com.

We welcome anyone to submit a statement of interest in this project. Please note that we are requiring a high professional level of skill, and the ability to work with ASFA personnel. Additionally, we will weigh the long-term support capability as part of the selection process.

Ridgeback Rescue, Inc. "Clifford" was a three-legged dog who made our family appreciate the breed. I continued rescue work by transporting, fostering, and reviewing adoptee applications for years. I have served on national rescue boards and was the National Director for Ridgeback Rescue of the United States.

I met Teri Olson at a Rhodesian Ridgeback National Specialty, and the next summer I received a performance girl "Libby" from her. Libby is well known on the coursing field. In 2018, she was the #2 ASFA RR, and combined #3 RR nationally. She has been in the top 10 multiple times and also competes in LGRA, NOTRA, rally, and agility. Libby has certified more than 20 dogs (of various breeds) for lure coursing. She loves to run!

After assisting Teri and Wayne Olson with several litters, in 2024 our girl Eve's litter became the first Azize litter to be whelped at my house. We are proud of all Eve has done - showing, coursing, LGRA, NOTRA, agility, rally - and we are especially proud of her 10 wonderful puppies! Already one is a finished conformation champion, and recently another (Sammy) won her first Best in Field.

I look forward to many more years in the field, and I am pleased to be the Region 5 Director. I would love to see Region 5 welcome more people and dogs to this awesome sport. — Shellie Marvin

Michele Bisbee new Region 3 Director

I am honored to be the new Regional Director for the Rocky Mountain area, covering Colorado, New Mexico, Utah, and Wyoming. Although I have 9 years of experience with Sighthounds and 6 years in lure coursing, I still definitely consider myself a newbie. I own Azawakh Ramisi, Saluki Syan, and Taigan Jayyl (pictured right with me), who is the first of his breed to earn an ASFA Championship title (LCC) while competing as an LCI-Sighthound Mix. I succeed Tom Golcher as our Regional



Director, which is an honor in itself as he is one of my main mentors in the sport.

I have taken particular interest in rare and 'primitive' sighthound breeds. Sighthounds are amazing creatures, but there is something about living with hounds so close to their origins that is very rewarding for me. My Azawakh are Gen 2 & Gen 4 out of Africa; my Saluki is a Gen 0 rescue from Qatar; my Taigan is Gen 1 from what is believed to be the third litter born in the US. I visited Kyrgyzstan in January, and I am in the process of importing a Gen 0 Taigan from Kyrgyzstan.

There is an additional feeling of responsibility for stewardship, protection, and preservation of these breeds. To me 'primitive' is a misnomer because as soon as they are removed from their countries of origins they are already adapting to the lifestyle and expectations of the Western world. Still, I believe a successful relationship with these dogs does not rely on an 'owner/dog' model but rather building a partnership. Each party has to work harder and give a little to come to a point of balance for the relationship to work, but it is exceedingly rewarding when it does.

I value ASFA for taking a role in allowing a greater variety of sighthounds to compete in lure coursing events, whether through Provisional status or through the LCI-Sighthound Mix stake. I look forward to representing Region 3 and advocating for rare breeds and the LCI community while learning the sport from a new angle. Tallyho! -Michele Bisbee



MARCH JUDGES LICENSING REPORT – March 2025

Notes from Judges Licensing:

In 2024 there were 87 active judges. A listing of judges and number of dogs judged is included on the next page.

One item which makes it hard for the committee is when individuals do not take their time filling out their judging confirmation sheets. Sheets are received with incorrect number of entries and at times numbers which are illegible. These sheets are to be done at the completion of the trial, numbers verified against the posted record sheets and should be legible so that guessing of what the numbers are is not a game. Understanding that not everyone has crystal clear handwriting, it also should not be illegible. Take time after the trial to complete the forms and use that opportunity to discuss with the licensed judge how the day unfolded and how to make yourself better judges. Validating the information presented on the sheets is done upon publication of the trial results on the ASFA website.

Another reminder is that upon becoming a provisionally licensed judge, you are automatically given the ability to judge LCI, Singles and Provisional breeds. Thus, these breeds do not count towards the number of breeds to obtain an all-breed license.



UNOFFICIAL HIGHLIGHTS FROM MOTIONS ADOPTED BY THE ACOD

Below is an <u>unofficial</u> rundown of some motions that were adopted at this year's ACoD. Not included are the procedural motions and those that are too "inside baseball" for general interest. The approved list of motions will be provided through official ASFA channels.

When Do Changes Go Into Effect? Importantly, whenever a change is made to the constitution or the rule book, the precise language used to make the change is important. Also important, is whether the change to one provision will affect related provisions. So, motions made at the ACoD frequently direct the REC (Rules Evaluation Committee) or the CRC (Constitution Review Committee) to come up with appropriate language to make the change. After the REC or CRC does its work, it brings its proposed final version back

to the ACoD in the following year for approval. As a result, some changes may not go into effect until 12-17 months after the initial motion was approved. Other motions, those that do not require the work of the REC or CRC, may go into effect immediately or on August 1st of the current year.

2023 ACoD Audit

A motion was adopted requiring that a detailed financial analysis of the 2023 ASFA II be provided to the board and ASFA liaisons within the next 30 days. *This requirement has immediate effect.*

ASFA Forms and the ASFA Store

A motion was adopted that requires the ASFA store to sell its inventory of forms at either the current prices or the actual cost to print, plus the actual cost of shipping. Up to date forms and all other information will remain on the ASFA website for clubs and individuals to download and print. *This goes into effect immediately*.

A further motion was adopted to update or create a "forms" policy consistent with the above motion. The language of the new policy will be voted on at next year's ACoD.

Virtual ACoD in 2026 and Beyond

A motion was adopted requiring a virtual ACoD in 2026, based on saving expenses and to allow increased participation. *This requirement has immediate effect.*

An additional motion was adopted to direct the CRC to revise the constitution to permit virtual conventions as the default position. *The language of this change to the constitution will be voted on at next year's ACoD.*

Adjusting the LCI Veterans Points Required for VLCC and VLCE Titles

A motion was adopted requiring the REC to review the LCI veteran points required for VLCC and VLCE titles and the consistency of that point structure compared to that of the ASFA sighthound veteran titles. The language of this rule change will be voted on at next year's ACoD.

Timeline in Disciplinary Matters

A Motion was adopted directing the CRC to clarify the timeline for action referred to in Article IX Discipline, Section 1. *The language of this change to the constitution will be voted on at next year's ACoD.*

Handler's Meeting

A motion was adopted to direct REC to amend Chapter II Officials, Section 2. Field Trial Chairman, of the ASFA running Rules as follows:

The field trial chair shall conduct a handlers meeting, after roll call in which the following is discussed:

- Safety and general orientation to the grounds and event.
- Identifying the field committee.
- Referring new handlers to mentors or those willing to help them with their hounds.
- Any other information the field committee deems important to the event.

The language of this rule change will be voted on at next year's ACoD.

USEFUL INFORMATION FOR EVERYONE WHO ENTERS A FOUR-LEGGED FAMILY MEMBER IN AN ASFA TRIAL

INTRODUCTION TO RECORDS 101 -

Record 101 was originally written for the Field Trial Secretaries (FTS) and Field Clerks (FC), but I now realize that everyone who enters a four-legged family member in an ASFA trial should read it because each of us plays an important role. Here are some points to consider.

- UNDERSTAND THE FIELD TRIAL SECRETARY'S JOB You will learn that it is not the FTS trying to give you a hard time when requesting you to submit the required paperwork, but that it is part of the rules/policies of ASFA. It is also me in the background hounding the FTS for the required paperwork -- so you will be helping both of us.
- A LITTLE EMPATHY OR AT LEAST PATIENCE Hopefully it will give you some empathy and/or patience when you feel like you have been waiting forever for the draw or results to be posted.
- Mostly I hope it might spark some interest in learning how to "do the paperwork".
- BE SURE YOUR ENTRIES ARE COMPLETE AND CORRECT I would encourage you to always review your entries for accuracy. It is amazing how many entries are incorrect. Here are some examples:
 - The registration number is incorrect. It maybe a littermate's number, house-mates number, or just incorrect/missing number.
 - The registered name does not match the registration number listed.
 - Some breeds have a registration number from more than one organization and do not consistently use the same number. The program can only recognize one.
 - Not marking on the entry that there are changes that need to be submitted to me.
- CHECK THE SCORE SHEET When you go to look at you dog's score, make sure the information listed
 on the record sheet for your dog is correct. Check the math for your dog. We are all human we
 all make mistakes but we can all work together to make the information as accurate as possible.
- HELP NEWBIES For those of us that have been around forever, when you see someone new, introduce yourself and ask if they need any help or have any questions.
- KEEP AN EYE ON YOUR HOUND'S RECORD There is no restriction on how often you request your hound record! So, if you think your hound may be close to a title that requires them to be moved to a different stake (Open to FCh) request the hound record before you attend the next event, so you know how many points and/or placements you need. If you are not certain how many points

the hound gets at that next event ask the FTS. It goes both ways - don't want to move to FCh too soon or too late. Either way you will most likely lose some points.

• ASK FOR HELP Finally, there are a lot of knowledgeable people at every trial who will be more than happy to explain something. The only stupid question is the one you didn't ask.

COVER LETTER - RECORDS 101 (update 03/25)

We have been following the protocol for trial submissions for a couple of years. The biggest problem continues to be missing First Time Entered (FTE) entries. For the most part it is because the owner did not mark the entry as such. Thus, the required copy of registration and certification (if required) are not attached. The USPS continues to be a problem. I will continue to rely on each FTS to question the owner of each unfamiliar entry. Also, please make sure you list an email address that you check frequently in case I need to reach you. The longer it takes me to get needed information, the longer it takes for results to be posted.

I would like to say a big Thank You to all the FTSs who have responded quickly to my email requests for information.

Some suggestions:

When making your roll call sheet if you have any unfamiliar entries, mark their name and have the person(s) doing roll call direct the owner to see FTS to confirm that this is not an FTE. Also, have the persons doing roll call ask each unfamiliar person if they have competed in ASFA previously. We need some method to cut down on missing information, so if you have any suggestions, please let me know. Also, for those clubs that hold a handler meeting prior to running. It is another great time to ask around to see if there are any new people that may need a helping hand or an FTE that wasn't marked as such.

If you have an FTE that did not bring all the required information, have them email the information directly to me. This will expedite your ability to submit the results instead of waiting for them.

I am requesting that you list the breed initials by the call name on the Single Record sheet. If one of the entries is missing information, I now have a breed by which to search.

If you plan to submit the results via email, please minimize the number of files you send and try to keep in the same order that you would always use to submit. Scan each day with required paperwork into a single PDF file.

Please submit results as soon as you can. The quicker I have them, the sooner I process and post the results. Recently the USPS has been very slow.

As always, please contact me should you have any question(s). Email is always the best way to reach me, but you can call me if you need an answer quickly. But if you do call, I typically do not pick up if I do not recognize the number so leave a message. I may be listening and will pick up immediately.

On August 1, 2023, ASFA began to offer a discount in the per capita rate to any club that submitted their results electronically within 7 days from the last day of trial. (This reduces their per capita rate from \$4.00 to \$3.50 per entry for regular trials and for regional invitationals from \$5.00 to \$4.50. The II is not included in this cost reduction). The results MUST be submitted in the following format to get reduction. If the records are not submitted as required I will be emailing the FTS for the remainder of the per capita.

Submitting electronic results -

Submit each day as one PDF file which should include:

- FTS report & per capita sheet
- Record sheets in the breed alphabetical order
- Any FTE with required paper or entries that are required to be submitted behind breed record sheet
- Any judges sheets reflecting excusal, dismissal or disqualification behind record sheet
- A copy of premium is not required but is appreciated.

I have been generous with the interpretation of procedure to start but have begun enforcing the real expectation as of Jan. 1, 2025. So please, if you have any questions as to how to submit, reach out to me sooner than later.

RECORDS 101 (update 03/25)

Daily Requirement

- A completed copy of the FTS Report (example included) completed in entirety.
 - Available on the ASFA Website at: Rec 25--FIELD TRIAL SECRETARY REPORT (3).pdf (asfa.org)
- Per capita sheet for each day.

Per Capita Sheet

- There must be a sheet completed for each day.
- If you are paying the fee by PayPal send it to treasurer@asfa.org. Put PayPal transaction ID on allotted space.
- Otherwise, the check should be submitted with the trial records and sent to me.

Premiums

- An updated copy of the premium list is required only if there were any changes to the course plan or change to judges panel from what was posted on the ASFA website.
- For changes to the judges panel the Chair of Judges must be notified of change and reason.
- Although it is not required a copy of premium is appreciated.

Entries that must be submitted with your trial results

- Entries for all hound(s) that are marked as FTE (First Time Entry). This must be accompanied by proof of registration, not printout of points from another organization or copy of certificates I need owner's name(s) & hound information (examples AKC, UKC or CKC), waived for NGA registered hounds & proof of certification if entered in a regular stake. Any FTE in the Single Stake and the LCI stakes require a copy of registration unless the LCI is requesting registration with ASFA then the form to request number must be attached. If proof of certification has been waived, a copy of the signed waiver and proof of the title must be included.
- Entry forms that indicate a change in the information (titles, address, etc.).
- If the change is in ownership an updated copy of registration reflecting said change must be attached.
- Entry forms that reflect that said hound is working off a dismissal.

Record Sheets

- All record sheets completed in entirety that includes the BIF sheet. All information needs to be legible and as accurate as possible.
- O-TRIALS15 When two judges are used, they shall be designated on the record sheet as Judge 1 and Judge 2, alphabetically by last name. This is for all judges whether Provisional or full judge.
- O-TRIALS04 The Field Clerk's name shall be indicated on each record sheet, but the Field Clerk's signature is not required.

- Per Ch V Sec 6 (g) hounds can no longer be left tied. There must be a runoff or a forfeit. The only tie that can stand is if it is the result of an error found during post trial review by the FTS and then a note must be attached explaining the problem.
- Any hound listed but did not run will need to have an acceptable reason (per ASFA Running Rules Ch VI Sec 1(b)) listed on the record sheet. If nothing is noted or it just says pulled, the hound will count for per capita.
 If an owner is unable to separate their hounds and decides to pull an entry there is no refund for this!
- On the Single sheet I would like the breed initials placed in the section with the call name. It is helpful to me if I have questions and am trying to search the database.

Additional Info

Trial results can be submitted by email if you are able to scan all record sheets, required FTS paperwork, all
entries that are required to be submitted along with any required registration, certifications, etc. that you
need to send to Records into a file (suggestion is to put it all in a single PDF file) and submit the payment via

Special Note for Invitationals

The Regional Director is responsible for ordering the Rosettes and Medallions from the Awards Chairperson a minimum of 2 weeks prior to the trial. An estimate of the number of items required as close as possible is required. After the trial all remaining Rosettes and Medallions are to be returned to the Awards Chairperson within 2 weeks after the trial.

Most Frequent Records Errors

- 1. FTE entries not submitted, typically because owner has not marked as such.
- 2. Incomplete Records sheets. Must have call name & registration number.
- 3. Not marking forfeits, just marking the placement(s).
- 4. The name (not signature) of the field clerk is missing (required to be listed on the Record sheet).
- 5. Giving hounds placements that have not earned total 50% of possible combined score.
- 6. Per capita difference between check submitted and my count. Without some sort of per capita break down I have nothing to try to figure out where the error might be.
 - Organization of Trial Records for Submission *previously listed in the rulebook

The following required items must be promptly sent to the Records Coordinator following each trial, indicated in Ch. VI:

- 1. Proper per capita fees made payable to the ASFA in USD. Current fee for each hound entered on the Record sheet which has not been excused as lame or in season at or prior to roll call. Only lame, in-season, hounds pulled due to change of judge/lure operator or hounds determined to have a breed disqualification are eligible for refund of the entry fee. **Ch. I Section 3** The record sheet should reflect the refund was given. All other hounds listed will count toward per-capita. Just writing PULLED is not acceptable and will be counted. All per capita fees shall be paid with a club check, certified check, money order or through an electronic funds transfer (EFT). Do not send cash or personal checks. If you use PayPal send to treasurer@asfa.org and mark on the per capita sheet.
- 2. A copy of the approved premium list only if there are any course plan changes or changes to the judging panel. A letter of explanation of these changes.
- 3. All record sheets for every course, including re-runs and runoffs if required. Notations of reasons why hounds who were entered did not run, e.g., absent, bitches in season, lame, dismissed, disqualified under the ASFA breed disqualifications, excused by the Field Trial Chairman, etc. filled out and written legibly.

The following must also be included:

- 1. Proof of registration, completed certification and entry forms for hounds entered for the first time.
- 2. Entry forms that include notations for hounds working off a dismissal.
- 3. Entry forms that include any indicated change of information (e.g. new titles, address change or change of ownership [changes to ownership require and updated copy of registration showing the change]).
- 4. Per Capita Report Sheet

The preferred order to use in organizing this material for submission is:

1. Per capita payment and worksheet showing entries for per capita. If submitted by EFT please mark the amount and date submitted on the worksheet. There is a space for the transaction number

- 2. Premium list if needed
- 3. Record Sheets in the alphabetical breed order: Best in Field/Event record sheet (filled out completely).
- 4. Any entries should be in the same alphabetical breed order.

Chapter VI Section 3: The host club shall maintain a completed set of all the records submitted for a period of one year following the lure field trial(s).

• Filling in the Trial Record Sheets

The record sheets must be completely and legibly filled out. This includes the complete names of the judges, the call names and registration numbers of the hounds, etc. If an entered hound is not competing, the reason should be entered on the record sheet, as should the reason for any excusal, dismissal, or disqualification. For tie runoffs, the blanket color and total score only should be entered in the "Runoff" column; similarly, for Best of Breed runs, enter only these items in the "BOB Runoff" column. This becomes even more important since not all entries will be submitted with the results.

The winner of Best of Breed receives the higher number of points available from the Open, Field Champion or Veteran stake, but must defeat the winner of the other stake(s) in a run-off.

Note: A hound must defeat a qualifying hound to count as a qualifying placement towards title requirements.

The hound winning BIF now gets 4 points for each hound that has competed in BIF in addition to the points earned in the regular stake up to a maximum of 40 points.

^{*} Example: a hound places second in a stake/flight of 3 = 9 points.

Pal's first love was chasing rabbits, although he did enjoy lure coursing. I am convinced he knew the difference and loved both games. Of Pal's many accomplishments, his 1991 Grand National win will always bring a special burst of pride to me. I

can still see him pushing the lure across the hill at the end of the mile long course and coming in with a huge smile. Pal and I traveled from California to New Jersey to attend ASFA International Invitationals and Afghan Hound Nationals. He never disappointed me. No matter what - he gave it his all.

Pal was a beautiful soul bred by Connie Sullivan. He was a free spirit that lovingly allowed me to care for him.

In April of 1991 we entered an Open Field event in the Shirley Basin of Wyoming. He drew a Whippet and a Borzoi to run with. A jack rabbit jumped up and gave the dogs a good look at his backside and took off over the hill. After several minutes the Borzoi and Whippet came back, but no Pal. He had been known to take his time coming back, always looking for the next jack. Minutes turned into hours. Connie Sullivan and I scoured the hills looking for him. At the end of the day, we were able to find someone in the little town of Medicine Bow with a Polaroid Camera (no cell phones back then) and took pictures of Sherman (Pal's brother) with a blue blanket on and posted them in the local post offices, schools, and anywhere we could think of. After days of searching, we had to return home without him, planning to return over the following weekend.

During that week, a security guard from a non-working uranium mine called Connie to say that Pal had wandered into his guard shack. He had seen the picture of Pal in the Medicine Bow Post Office earlier, so he called the sheriff and asked him to get our phone numbers from the post office so he could call us and we could come get Pal. Over that week, Pal traveled 15 miles and was still wearing his blue coursing jacket. When I finally set eyes on him, he gazed at me as if to say, "Where have you been?"

Also in 1991, the Rocky Mountain Sporting Whippets started to hold NOTRA race meets - something new and exciting for breeds other than whippets. This allowed Pal and his brother, Sherman, to become the first Afghans in our region to earn racing titles.

One thing Pal did not enjoy was Obedience. He would find entertaining ways to fail, from almost knocking me down during recalls, to stopping at a floor vent to let the air blow his hair. He also could see no good reason to sit when lying down was much more comfortable. He completed his CD with the scores of 170, 171 and 171.5. Good boy! Pal's life was too short. He passed away due to an aneurysm after a beautiful run, doing what he loved. He made a lasting impact on my life and the lives of others. --Deann Britton

Dior always displayed elegant athleticism. He had remarkable speed and follow throughout his career. He earned his ASFA LCM title, and also earned 621 points in the ASFA Limited Stakes. He holds an LCM3 from the International Silken Windhound Society, which is the Silken Windhound sister program. All those points were earned in ASFA lure coursing field trials, but prior to being counted toward his titles in ASFA Provisional and Regular Stakes.

Dior was the first Silken Windhound to win BOB at an ASFA II (2010). He won breed at the II again two years later. Dior and his daughter, Sahara, also won the first Kennel Stake for Silken Windhounds at an II. Dior was the first Silken Windhound to win Best of the Best in the four day lure coursing continuum competition — The Turkey Run (2010), and he was first to win Best of the Best in the inaugural Southern California Cup Invitational (2013).

In 2010 Dior became the first Number One Silken Windhound in ASFA's Top Twenty



rankings. He was in the ASFSA Top Twenty for seven years. For five of those years, he was in the Top Ten. Dior was the Number One ASFA Lifetime Top Silken Windhound for ten consecutive years. Currently, he is Number Two on that list. Three of his sons and daughters and one granddaughter (a BII winner) are also in the ASFA Lifetime Silken Windhound Top Twenty. Dior is the leading Silken Windhound sire of ASFA FChs and LCMs. He is also a racing champion in ISWS and LGRA straight line racing.

Eunice was a most remarkable Deerhound. The favorite hound of Anastasia Noble of Scotland, she coursed on hare in Great Britain. Because of her enthusiasm for dispatching sheep, she was offered to me at age 3. Her first trial in the States was in Virginia at Haines farm in 1981 where she won BOB over a good entry, going BIF the following day. I have a photograph from the event of Eunice taking a turn, bent in half right on the pulley with both her front and rear facing the camera. She finished 1981 ranked the #1 lure coursing Deerhound. Eunice delivered eight pups in 1982. She was #2 in 1983 and became the third Deerhound LCM by winning the Field Champion stake at the Deerhound National Specialty, where she was also Winners Bitch. Despite just two full years of competition, she was rated #5 Deerhound in overall rankings from 1972 to 1982. All told, I think she had 43 Bob and 4 BIF, but her performances in the field paled before her exceptional character. She died in 1984. – *Stan Fisher*





THE HARDEST JOBS FOR A LURE OPERATOR

- 1. The safety of the hounds.
- 2. Keep the hounds following.
- 3. Work the hounds into and out of the corners.
- 4. Make every hound look as good as possible.
- 5. Give the judges something to judge. This is the hardest job at a trial, but the most rewarding when you do a good job.
- 6. Know when you've made a mistake. Learn from your mistakes. It can be argued that the only way to improve is from the mistakes you make. A good lure operator knows when they made a mistake and can learn from it.
