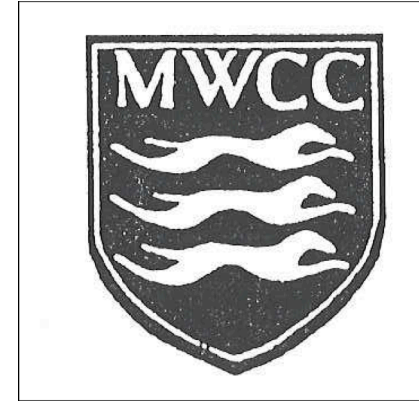

**AWARDS:** Ribbons will be awarded for all placements - 1st through NBQ. Rosettes will be awarded for Best of Breed.

**TRIAL HOURS:** 6:30 AM each day until one hour past the completion of the last scored course of the day.

**ROLL CALL AND INSPECTION: 8:00 AM BOTH DAYS.** Hounds not present at roll call will be marked absent and are not eligible for refund of entry fee.

**ELIGIBILITY-**Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, and Whippets may be entered in the regular stakes. All entries shall be individually registered with the American Kennel Club, the National Greyhound Association, the Federation Cynologique Internationale, an ASFA-recognized foreign or ASFA board approved registry, or possess a Critique Registration Number (CRN) from the Society for the Perpetuation of the Desert-Bred Saluki (SPDBS). Limited and/or Provisional Stakes entries shall be individually registered with the appropriate registry. Only purebred, Chart Polski, Galgo Espanols, and Magyars Agars, Peruvian Inca Orchid, Silken Windhound, and Portuguese Podengo are eligible for entry.

**STAKES OFFERED** (A photocopy of acceptable registry must be submitted with a hound's first ASFA field entry in any stake. This requirement is waived for greyhounds registered with the NGA.)

**Singles** Any eligible sighthound including novice hounds and hounds with breed disqualifications and/or hounds that have been disqualified from competition in other stakes are eligible to enter. Not eligible for Best of Breed competition.

Limit of 9 entries per day.

**Open** Any eligible sighthound that has met certification requirements, excluding ASFA Field Champions of record.

**Field Champion** Any ASFA Field Champion.

**Veteran** Any eligible sighthound that has met certification requirements whose age exceeds six years, except Irish Wolfhounds whose age shall exceed five years and Afghan Hounds, Rhodesian Ridgebacks and Whippets whose age must be 7 years.

**Limited** Any eligible sighthound as defined, one year or older on the day of the trial that has met certification requirements.

**Best in Field** Will **NOT** be offered ~ see information on Best In Event.

- All entries must be one year or older on the day of the trial.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.
- Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
- Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- Hounds not present at the time of roll call will be scratched
- All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.
- Muzzles are not required. It is the responsibility of the owner to determine if their hound needs to be muzzled.
- Lure machine is battery powered, continuous loop. Back up equipment is available.
- Lure will consist of highly visible plastic strips.
- There will be a \$5 fine for any loose hound on the field that is not part of the course in progress.
- There will be a \$35 fee assessed for any returned checks
- Course will be reversed for finals and again for run-offs and Best of Breed.
- **Checks must be in U.S. Funds drawn on U.S. Banks.**
- **MWCC assumes no liability for injury to any hound or person, before, during or after the trial.**

Entries will **NOT** be acknowledged by mail. Incomplete, unsigned, conditional, or late entries will NOT be accepted. Email and fax entries will **NOT** be accepted. Substitutes for lame or in-season hounds are allowed if substitute has same owner and the Field Secretary is notified by 7:00 AM the day of the trial.

### HOUND CERTIFICATION

Certification: Except those entering in Singles. Any entry marked **First Time Entered** must present a completed ASFA hound certification form to the Field Secretary BEFORE entries close. See the back of the entry form for certification forms and make extra copies if needed. Certification runs will be offered at a cost of \$5.00 per run on Saturday only after the completion of the trial. It is the responsibility of the entrant to find another hound of the same breed or similar running style to run with his/her hound for the certification. A sign-up sheet will be available on the day of the trial.

Practice: Limited practice runs will be allowed after the certification runs on Saturday, weather and equipment permitting. A sign-up sheet will be available from the Field Secretary.

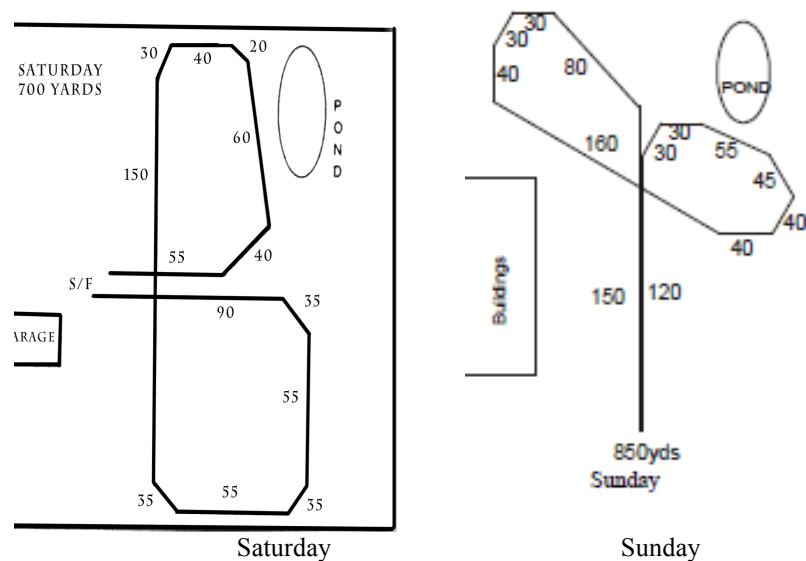
