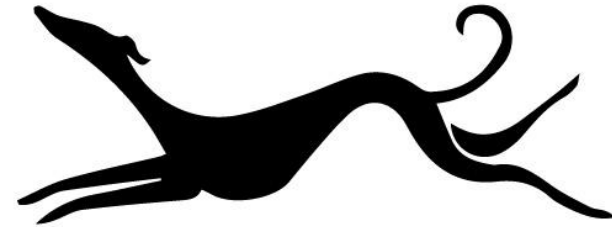

## ELIGIBLE BREEDS & REGISTRY

Only purebred Italian Greyhounds may be entered in the regular stakes.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

### REGULAR STAKES OFFERED

**OPEN STAKE:** Any eligible Italian Greyhound, excluding ASFA Field Champions of record.

**FIELD CHAMPION STAKE:** Any ASFA Field Champion Italian Greyhound

**VETERAN STAKE:** Any eligible Italian Greyhound whose age is at least six years. Points go toward V-FCh or V-LCM titles.

**SINGLE STAKE:** Any eligible Italian Greyhound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed. Hounds are eligible to earn TCP and CPX titles from the Singles stake.

### FIRST TIME ENTERED HOUNDS

1. **ALL first time entered hounds** must attach and a copy of the hound's AKC registration or ILP/PAL papers to the entry form.
2. **First time entered hounds entering the Open, Field Champion, or Veteran stake** must also include the **hound certification form** (*not required for Single stake*).

### BEST IN FIELD WILL NOT BE OFFERED

**Conditions of Entry:** All entries must be one year or older on the day of the trial • Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more • Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. • Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake • Hounds not present at the time of roll call will be scratched • All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

**Equipment:** Type of lure machine: battery-powered continuous-loop system. • Type of lures: highly-visible white plastic strips • Back-up equipment will be available.

# GENERAL INFORMATION

- ❖ There will be a \$5.00 fine assessed for any loose hound not taking part in course in progress. IGCA will strictly enforce this assessment.
- ❖ Field Committee reserves the right to bar aggressive dogs from the event site.
- ❖ Muzzles are not required, but are permitted at the handler's discretion.
- ❖ When the entry in any regular stake reaches 20 or more, the stake will be split. The stake will be divided as evenly as possible by random draw. There must be a minimum of 10 in each flight.
- ❖ No entry fees will be refunded if the Trial cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God, public emergency, act of a public enemy, strikes, or any other cause beyond the control of the Club or the Field Committee.
- ❖ The Club, Field Committee, their agents, employees, etc., assume no responsibility for any loss, theft, damage, injuries or death sustained by exhibitors or handlers to any dog or property, and further assume no responsibility for injury to children while at or on the Trial grounds, or in transit to/from the Trial grounds.
- ❖ Dogs must be ready for judging. Judges need not wait for dogs holding up a stake.
- ❖ Entry fees shall not be refunded in the event that a dog is absent, disqualified or dismissed by a judge, barred from competition by action of the Field Committee, or because the dog is ineligible to compete due to a check being returned. The returned check must be made good by cash or money order before the dog will be entered correctly. Returned checks do not constitute a valid entry fee.
- ❖ Any entry found unfit to compete, lame, or to have a breed disqualification, or bitches in season shall be barred from competition and entry fees shall be refunded.
- ❖ The Club and/or Trial Secretary assume no responsibility for wrong or incomplete information given on the entry form by the owner or agent of the owner. The Club and/or the Trial Secretary assume no responsibility for the owner or owner's agent for entering a dog in a stake in which the dog is not eligible to compete.
- ❖ Changes, additions or corrections to entry forms must be received in writing or by electronic mail prior to the close of entries. Those received by telephone are not acceptable.
- ❖ If hounds owned or co-owned by the same person are not to run together, the owner must state this on the entry form.
- ❖ Porta potties will be available at the venue.
- ❖ All trophies and prizes must be claimed the day of the Trial; none will be mailed.
- ❖ Please bring plenty of water & shade!
- ❖ Lunch will be available for purchase, please use order form.
- ❖ Practice will be offered after the completion of the trial.
- ❖ Please cleanup after your dogs and yourselves!
- ❖ **Please have copies of rabies certificates of all dogs traveling with you.**
