ELIGIBILITY FOR THE INTERNATIONAL INVITATIONAL

Any sighthound that has earned at least 20 ASFA points, or equivalent points in its country of residence, or is an AKC or equivalent foreign Field Champion of Record in another lure coursing field trial-sanctioning organization or has placed in a Regional Invitational (with competition) is eligible to enter. Proof of non-ASFA title and non-ASFA points for hounds should be in the form of a photocopy of the certificate or page of formal printing/publication and be included with the entry. For a Limited breed to be eligible, the entry must have one first placement, or two second placements, with competition in the Limited Stake.

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, and Whippets may enter in the regular stakes. All entries in the regular stakes shall be individually registered with the AKC, NGA, the Federation Cynologique Internationale, an ASFA-recognized foreign registry or ASFA Board approved registry, or possess a CRN from the Society for the Perpetuation of Desert Bred Salukis. Limited Stake entries shall be individually registered with the appropriate registry (Chart Polskis, Galgo Espanols, Magyar Agars, Peruvian Inca Orchids, and Portuguese Podengos are eligible).

ELIGIBILITY FOR THE GILLETTE STAKE

Eligible sighthounds must have **ALL** of the following: 1) an AKC or foreign bench championship, 2) ASFA Field Champion, 3) have earned 20 ASFA points in the 12-month period preceding close of entries, and 4) be entered in the Field Champion or Veteran Stake on Saturday. Requirements must be met prior to the close of entries. Proof of non-ASFA title and non-ASFA points should be in the form of a photocopy or page from formal printing and **MUST BE** included with the entry. NO exceptions will be made. The Field Trial Secretary must receive the special entry form for the Gillette Stake and the supporting paperwork by the closing date of entries. There is no additional fee for an entry in this stake.

REGULAR STAKES OFFERED (BOTH DAYS)

Open: Any eligible sighthound that has met the eligibility requirements above, excluding ASFA Field Champions of record.

Field Champion: Any ASFA Field Champion that has met the eligibility requirements above.

Veteran Stake: Any eligible sighthound that has met the eligibility requirements above, and that is six years of age or older (5 years or older for Irish Wolfhounds; 7 years or older for Afghan Hounds, Rhodesian Ridgebacks, Salukis, and Whippets).

Single: Any eligible sighthound including those disqualified to run in the other stakes. Each sighthound runs alone. Entrants in the Singles stake are barred from competition in Open, Field Champion, Veteran, Breeder, Kennel, and Bench stakes. Singles are NOT eligible to run in Best of Breed, Gillette Cup, or Best in International Invitational competition. Entrants are eligible to earn TCP and CPX titles from the Singles Stake.

NON-REGULAR STAKES OFFERED (BOTH DAYS)

Limited Stake: Any sighthound of an eligible miscellaneous breed that has met certification requirements and eligibility requirements as listed above (regular sighthound entry fees apply).

Breeder Stake: For two sighthounds of the same breed, designated at the time of entry, entered in one of the regular stakes, bred by the same individual (\$5 per pair).

Kennel Stake: For two hounds of the same breed, designated at the time of entry, entered in one of the regular stakes, owned and kenneled by the same person (\$5 per pair).

Bench Stake: For sighthounds of any individual breed; an entry shall consist of a single sighthound with proof on file with the ASFA of a conformation champion title from the AKC or CKC or both or a conformation Grand Champion title from the UKC. A copy of the sighthound's championship certificate must accompany each Bench Stake entry. To enter the Bench Stake, check the appropriate box on the entry form AND include a copy of the sighthound's Championship certificate with the separate entry form (\$5 per entrant).

Note: An owner/breeder may have more than one pair entered in the kennel or breeder stakes as long as the two sighthounds comprising each entry are properly identified at the time of entry. A sighthound may only be part of any one kennel and one breeder stake entry. Please send in Breeder/Kennel Stake forms indicating pairs along with properly marked entry forms.

GILLETTE STAKE – SATURDAY ONLY

The Gillette Stake competition will be run on Saturday, following the same procedures as a Best in Field. The eligible hound in each breed (having been pre-entered, and meeting all requirements for eligibility) that receives the highest qualifying combined score during competition in the Field Champion or Veteran Stake on Saturday will be randomly drawn to run in the Gillette Stake.

Any ties to determine the eligible hound for a given breed will be run-off.

BEST IN INTERNATIONAL INVITATIONAL – SUNDAY ONLY

The Best in International Invitational (BII) competition is run on Sunday, following the same procedures as a Best in Field, except that all Best of Breed winners from Saturday and Sunday are eligible to compete provided they have been entered and received qualifying scores both Saturday and Sunday. The sighthound that wins BII will be credited with winning a Best in Field.






Field A

900 Yards




Field C

905 Yards




