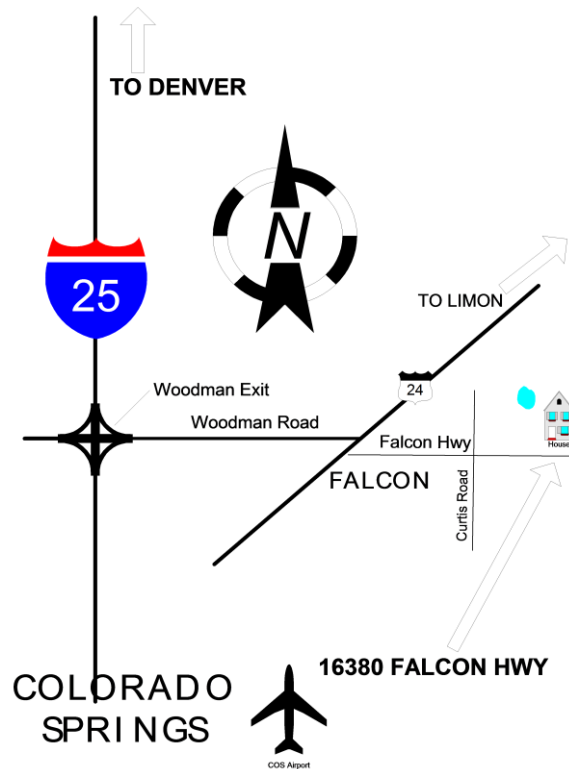

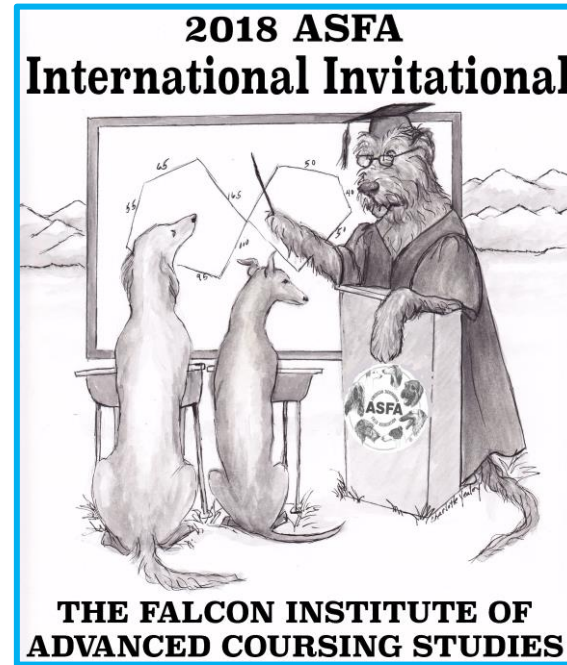

- **Mailing entries:** DO NOT send entries overnight with signature required.
- **Payments Accepted:** Check, MoneyOrder, PayPal. If paying by check, make checks payable to ASFA.
- Incomplete, unsigned, conditional, or late entries will NOT be accepted.

ALL ENTRIES MUST BE RECEIVED BY September 24th, 2018 8PM MST

ELIGIBILITY FOR THE INTERNATIONAL INVITATIONAL

- Any sighthound that earned at least 20 ASFA points or equivalent points in its country of residence
- Any sighthound is an ASFA, or AKC or equivalent foreign Field Champion of Record in another lure coursing field trial-sanctioning organization
- Any sighthound that has placed at an ASFA Regional Invitations (with competition)
- Proof of non-ASFA title and non-ASFA points MUST be submitted with the entries; proof must be submitted in the form of a photocopy of the certificate or page of formal printing/publication.
- For a Limited breed to be eligible, they must have one first placement, or two second placements, with competition in the Limited Stake.

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis, and Whippets. Limited breeds may be entered in the Limited Stake or the Singles Stake.

Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry. All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

ELIGIBILITY FOR THE GILLETTE STAKE

Eligible sighthounds must have **ALL** of the following:

1. An AKC or foreign Bench Championship
 2. ASFA Field Championship
 3. Earned 20 ASFA points in the 12-month period preceding close of entries
 4. Be entered in the Field Champion or Veteran Stake on Saturday, October 13th, 2018
- Requirements MUST be met prior to the CLOSE of entries! No exceptions!
 - Proof of non-ASFA title and non-ASFA points should be in the form of a photocopy or page from formal printing and MUST BE included with the entry. No exceptions!!
 - The FTS MUST receive the special entry form for the Gillette Stake and the supporting paperwork by the closing date of entries. There is no additional fee for an entry in this stake.
 - FTS may verify eligibility with the ASFA Records Coordinator in order to accept entry in this stake.

REGULAR STAKES OFFERED:

OPEN - Any eligible sighthound, that has met the eligibility requirements noted above, excluding ASFA Field Champions of record.

FIELD CHAMPION - Any ASFA Field Champion, that has met the eligibility requirements noted above.

VETERAN - Any eligible sighthound, that has met the eligibility requirements noted above, which is 6 years or older on the day of the trial, except Irish Wolfhounds whose age shall be at least 5 years; and Afghans, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least 7 years of age.

SINGLE STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Entrants in the Singles stake are barred from competition in Open, Field Champion, Veteran, Breeder, Kennel, and Bench stakes. Singles are NOT eligible to run in Best of Breed, Gillette Cup, or Best in International Invitational competition. Entrants are eligible to earn TCP and CPX titles from the Singles Stake.

NON-REGULAR STAKES OFFERED:

LIMITED - Any eligible sighthound of an eligible Limited stake that has met the eligibility requirements noted above. Not eligible for Best of Breed, Gillette Cup, or Best in International Invitational competition.

Breeder Stake – For two hounds of the same breed, designated at the time of entry, entered in one of the regular stakes, bred by the same individual. (\$5 per pair.)

Kennel Stake – For two hounds of the same breed, designated at the time of entry, entered in one of the regular stakes, owned and kenneled by the same individual. (\$5 per pair.)

Bench Stake – For sighthounds of any individual breed; an entry shall consist of a single sighthound with proof on file with ASFA of a conformation title from the AKC or CKC or both, or a conformation Grand Champion title from the UKC. A copy of the sighthound's championship certificate MUST accompany each Bench Stake entry. To enter the Bench Stake, check the appropriate box on the entry form AND include a copy of the sighthound's Championship certificate with the separate entry form (\$5 per entrant.)

Note: An owner/breeder may have more than one pair entered in the kennel or breeder stakes as long as the two sighthounds comprising each entry are properly identified at the time of entry. A sighthound may only be part of any one kennel and one breeder stake entry. Please send in Breeder/Kennel Stake forms indicating pairs along with properly marked entry forms

GILLETTE STAKE – SATURDAY ONLY:

The Gillette Stake competition will be run on Saturday, following the same procedures as a Best in Field. The eligible hound in each breed (having been pre-entered, and meeting all requirements for eligibility) that receives the highest qualifying combined score during competition in the Field Champion or Veteran Stake on Saturday will be randomly drawn to run in the Gillette Stake. Any ties to determine the eligible hound for a given breed will be run-off prior to the Gillette Stake run.

BEST IN INTERNATIONAL INVITATIONAL – SUNDAY ONLY:

The Best in International Invitational (BII) competition will be run on Sunday, following the same procedures as a Best in Field, except that all Best of Breed winners from Saturday AND Sunday are eligible to compete, provided they have been entered and received qualifying scores both Saturday and Sunday. The sighthound that wins BII will be credited with winning a Best In Field.

GENERAL INFORMATION

EQUIPMENT: Type of lure machine: battery-powered continuous-loop system. Back-up equipment will be available. Type of lures: highly-visible plastic strips.

A \$20.00 fee will be assessed for any returned checks. Persons exhibiting conduct detrimental to ASFA/CLCA/ any hound(s)/other person(s) will be asked to leave the trial site.

A penalty of \$10.00 will be assessed for any loose hound not competing in the course in progress.

ROSETTES AND TROPHIES:

ASFA will provide rosettes for all placements: 1st place: **Blue**, 2nd place: **Red**, 3rd place: **Yellow**, 4th place: **White**, NBQ (Next Best Qualified): **Dark Green**, High Scoring Single: **Navy/Gold**, Best of Breed: **Purple/Gold**, Non-Regular Stakes: Pink/Green, Gillette Stake: Gold/Green/Black, Best in II: Red/White/Blue.

Trophies will be awarded for Best of Breed, Gillette Stake, and Best in II.

Prizes will be awarded for all placements 1st through NBQ and any Non-Regular Stake Winners. ASFA will provide ASFA medallions for BOB winners each day. The Gillette Stake winner be awarded a pewter silver-plated ASFA medallion on a walnut base. The BII winner will be awarded a pewter gold-plated ASFA medallion on a walnut base. The BII winner will also receive a "Link to the Past" like the links in the BII Chain.

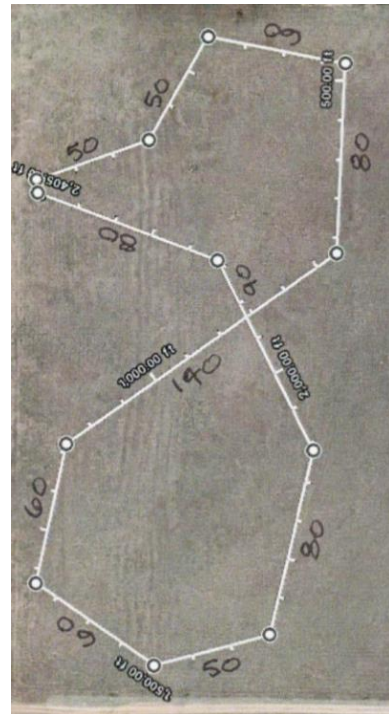
