BOB: Purple & Gold Rosette and ASFA BOB plaque, High Scoring Singles: Navy & Gold Rosette, First: Blue Rosette, Second: Red Rosette, Third: Yellow Rosette, Fourth: White Rosette, NBQ: Dark Green Rosette; Kennel Stake, Breeder Stake & ISWS Conformation Stake: Rosettes.

All placements receive a prize in addition to rosette.

ELIGIBILITY REQUIREMENTS:

Only purebred Silken Windhounds individually registered with the United Kennel Club (UKC) and/or International Silken Windhound Society (ISWS) may be entered.

Incomplete, unsigned, conditional or unpaid entries will not be accepted. NO LATE ENTRIES will be accepted.

Changes of stake and substitutions for lame or in season hounds may be made by notifying the Field Trial Secretary. Substitutions must be made no later than close of entries. Substitutions must be from the same owner & household only. Entries will not be acknowledged by mail.

STAKES OFFERED:

Open Stake: Any eligible Silken Windhound who has met certification requirements, excluding ASFA Field Champions of record.

Field Champion Stake: Any ASFA Silken Windhound Field Champion. **Veteran Stake**: Any eligible Silken Windhound whose age is at least six years and who has met certification requirements.

Singles: Any eligible Silken Windhound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Kennel or Breeder stakes or Best of Breed. Hounds are eligible to earn TCP and CPX titles from the Singles stake.

Kennel Stake: two Silken Windhounds, designated at time of entry, owned and kenneled by the same person. Hounds must be entered in one of the regular stakes.

Breeder Stake: two Silken Windhounds, designated at time of entry, bred by the same individual. Hounds must be entered in one of the regular stakes.

ISWS Conformation (Bench) Stake: an individual hound, in one of the regular stakes, with proof on file with the ISWS of an ISWS conformation championship.

* Please Note: For Breeder & Kennel Stake, entries may consist of the identical pairing of dogs, but each dog may only be entered once in each stake. Hounds must be named at time of entry.

CONDITIONS OF ENTRY:

- All entries must be one year or older on the day of the trial.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, lame hounds and hounds with breed disqualifications will be scratched at roll call/inspection and entry fees refunded. Spayed, neutered, monorchid or cryptorchid hounds may be entered.
- Hounds not present at time of roll call will be scratched.
- All hounds will run twice, in trios if possible, or braces (except in the Single Stake), unless excused, dismissed or disqualified.
- Certification runs will be offered ***after*** the trial, pending condition of the equipment, time and weather. **Certifications will be by pre-entry only.** Be sure to arrange your own by-dog.
- A \$5.00 penalty will be collected for any loose hound not in competition.
- Persons exhibiting unsportsmanlike conduct detrimental to ASFA, this club, any hound or person will be asked to leave the trial site.

GENERAL INFORMATION:

- Please bring your own food, shade and water.
- No one, except Field Committee members, will be allowed on the field without the expressed permission of the Field Committee.
- There will be a \$10.00 fine for anyone not picking up after their own dog.
- ISWS assumes no liability for injury to any person or dog before, during or after the trial.

Please DO NOT send entries with 'signature required'.

All first time entries MUST include a copy of the hound's registration certificate. The entry for each hound entering the Open or Veteran Stake for the first time MUST include a completed & signed ASFA Certification Form or Waiver Form (with proof of title) and a copy of the hound's registration certificate (ASFA certification waived for Single Stake entries only).

- Be accompanied by all associated required paperwork (e.g., certification forms/waivers, proof of waiver, and UKC registration for FTEs).
- ✓ Be emailed with a date/time stamp before the entry deadline (Sunday, May 5th, 2024 at 9 PM PST).

REFUNDS:

100% of entry fees will be refunded if a written request is received by the trial secretary on or before the entry closing date. After entries close, a refund will be given for a bitch in season, or an ill or injured dog or handler, if the trial secretary is notified prior to close of roll call for the trial. No refunds will be given if a request is presented after the close of roll call for the trial.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, public emergency, natural disaster, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.




- Turn Right onto US-15 BUS N.
