Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Silken Windhounds, Salukis, Scottish Deerhounds, Sloughis, Whippets.

Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

REGULAR STAKES OFFERED

OPEN STAKE: Any eligible sighthound, excluding ASFA Field Champions of record.

FIELD CHAMPION STAKE: Any ASFA Field Champion

VETERAN STAKE: Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

LIMITED STAKE: Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

SINGLE STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

Qualified Courser (QC) Ceertificate (test). Open to a hound of an eligible breed, at least 12 months of age (Qualifying Hound running with another hound of the same breed – or another breed with a similar running style (Testing Hound) – shall receive certification from a licensed judge. The hound must complete the course with enthusiasm and without interruption, sufficiently course the lure and not course the Testing Hound. The judge will certify that the Qualifying Hound ran cleanly and did not appear to present a hazard to the Testing Hound at any point in the qualifying course. This certificate is required to enter a hound in an Open Stake. The handler presenting the Qualifying Hound shall be responsible for providing the Testing Hound for the certificate and awards it to the handler. This certificate must be submitted to the host club with the hound's first entry in an Open Stake. The certificate must be included when the results of the trial are sent to the ASFA. IT IS STRONGLY RECOMMENDED that every Qualifying Hound have been run previously alone and that to the handler's satisfaction runs cleanly and keenly. It is additionally recommended that every Qualifying Hound practices with other hounds prior to being presented for a qualifying courser test. It is to be understood by all that training prior to running a hound with other hounds in competition is essential to ensure that the hound is prepared to run safely and with other hounds.

Hound Certification runs will be offered 1 hour prior to close of entries.

BEST IN FIELD WILL BE OFFERED SATURDAY ONLY

Conditions of Entry: All entries must be one year or older on the day of the trial ● Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more ● Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. ● Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake ● Hounds not present at the time of roll call will be scratched ● All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.




Terrain is a mowed field, gently rolling, with pond area.
