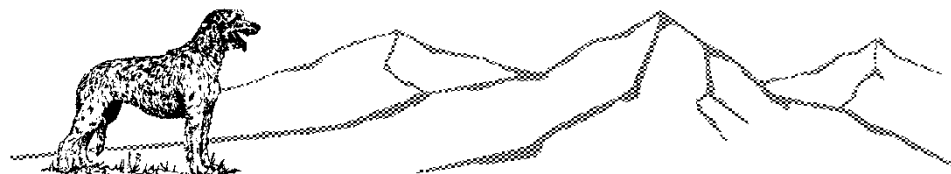

LIST OF BREEDS ELIGIBLE TO ENTER: Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Whippets, and Provisional breeds October be entered in the regular stakes. Current Provisional breed: Silken Windhound. Limited breeds October be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry. All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

ENTRIES WILL NOT BE ACKNOWLEDGED BY MAIL OR TELEPHONE. LATE, INCOMPLETE, UNSIGNED OR CONDITIONAL ENTRIES WILL NOT BE ACCEPTED.

REFUND POLICY: Refunds will be allowed for lame hounds, bitches in season and breed disqualifications as determined at the trial inspection. Full refunds are allowed for entries cancelled for ANY reason prior to the Early entry Closing Date and Time.

NO REFUNDS AFTER THE EARLY CLOSING TIME EXCEPT FOR THE REASONS LISTED ABOVE

STAKES OFFERED

OPEN STAKE: Any eligible sighthound, excluding ASFA Field Champions of record.

FIELD CHAMPION STAKE: Any ASFA Field Champion.

VETERAN STAKE: Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least 5 years, and Afghans, Ridgebacks and Whippets who shall be at least 7 years. Points & placements go toward V-FCH & V-LCM titles.

LIMITED STAKE: Any eligible sighthound of a Limited stake breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

SINGLE STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

BEST IN FIELD WILL NOT BE OFFERED

Conditions of Entry:

- All entries must be one year or older on the day of the trial.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.
- Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
- Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- Hounds not present at the time of roll call will be scratched.
- All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.
- All Hounds entering Open, Veteran or Limited Stakes for the first time MUST include a completed ASFA Certification Form or Waiver Form (with proof of coursing title) and a copy of the hound's registration certificate (registration proof waived for NGA Greyhounds only; ASFA certification waived for Single Stake entries only).

Equipment:

- Battery powered continuous loop machine will be used. Lure will consist of white plastic strips or a combination of black and white plastic strips.
- Back-up equipment will be available.

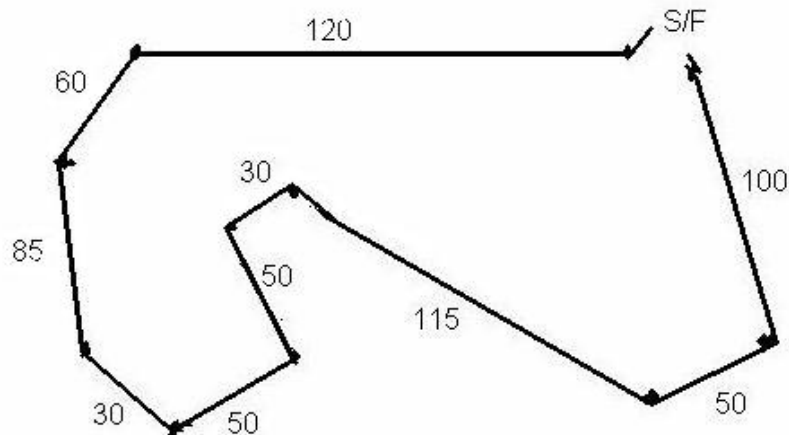
BRING WATER AND SHADE FOR YOUR HOUNDS. Restrooms on-site

WARNING: Due to the altitude and natural terrain of the course all hounds entered must be in top physical condition. **ALL HOUNDS RUN AT THE OWNER'S SOLE RISK.**

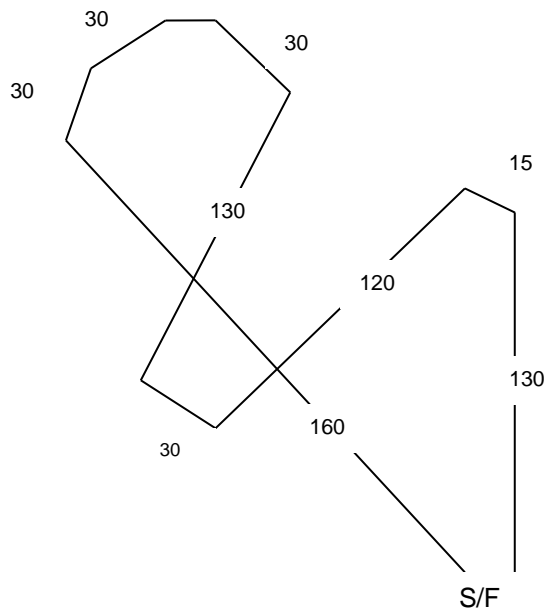
ALL DOGS RUNNING IN THE TRIAL OR PRACTICE MUST HAVE AN OFF LEASH PERMIT. \$2.00 PER DAY FOR UP TO 3 HOUNDS OR \$20.00 for an annual pass. All entrants will be required to show their off leash pass at inspection.

COURSE PLAN: Course will be reversed for finals and again for run-offs or at the discretion of the judges.. The RMIWA reserves the right to alter the course diagram as required by weather and/or field conditions on the day of the trial.

Practice and Certifications

Certifications offered each morning 8-8:30 Cost \$5.00 per dog. No charge for RMIWA Members. Certification fee may be applied towards an entry that day. Owners of certifying dog are responsible for arranging another hound of the same breed (or another breed with a similar running style).

Practice will be held following the trial on Saturday (weather and equipment conditions permitting) \$3.00 per hound. No charge for RMIWA Members. Any breed may practice.

Directions to Trial Site –

Chatfield State Park 11500 N Roxborough Park Road, Littleton, CO (This address is the Park Headquarters Office address. Do not go to the Park HQ.) Get to the West entrance to Chatfield, turn left or north on the park drive. Follow the Perimeter drive around the north side of the park to the Owl Glenn off leash dog area parking. The Sporting Dog Training Area is across the road on the south of Owl Glenn parking. GPS Coordinates 39.561453,-105.054725

From the Denver metro area:

Take C-470 West to Wadsworth (CO-121) exit. Go South on Wadsworth about 1 mile to the West Chatfield Park entrance. Once in park, turn left or north to follow the perimeter road about 2 miles. The Owl Glenn Off Leash Dog area will be on the right. Park there, trial will be across the road in the Sporting Dog Training area.
