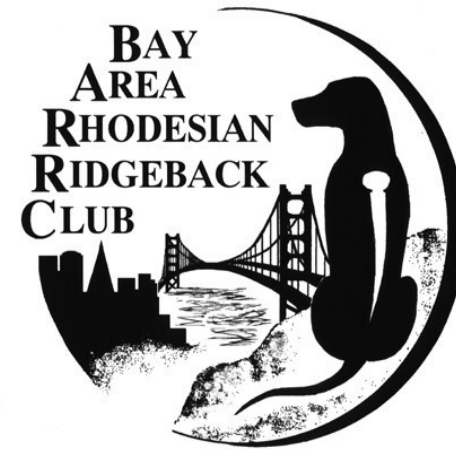

ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, and Whippets may be entered in the regular stakes. All entries in the regular stakes shall be individually registered with the American Kennel Club (ILP and PAL included), the National Greyhound Association, the Federation Cynologique Internationale, an ASFA-recognized foreign or ASFA Board approved registry or possess a critique registration number (CRN) from the Society for the Perpetuation of Desert Bred Salukis (SPDBS).

Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

1st Place · Blue **2nd Place** · Red **3rd Place** · Yellow **4th Place** · White **NBQ** · Green

High Scoring Single · Navy/Gold **BOB** · Purple/Gold **BIF** · Red/White/Blue

Trophies will be offered for BOB and BIF

REGULAR STAKES OFFERED:

OPEN STAKE: Any eligible sighthound that has met the certification requirements, excluding ASFA Field Champions of record.

FIELD CHAMPION STAKE: Any ASFA Field Champion.

VETERAN STAKE: Any eligible sighthound that has met the certification requirements and is 6 years of age or older (5 years for Wolfhounds, 7 years for Afghans, Rhodesian Ridgebacks, Salukis, & Whippets).

SINGLE STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

LIMITED STAKE: Any eligible sighthound of a Limited breed. Not eligible for BOB or BIF.

BEST IN FIELD will be offered.

Entry for each hound entering Open, Veteran or Limited Stake for the first time MUST include a completed & signed ASFA Certification Form or Waiver Form (with proof of title) and a copy of the hound's registration certificate (this requirement is waived for hounds registered with the NGA)

CONDITIONS OF ENTRY:

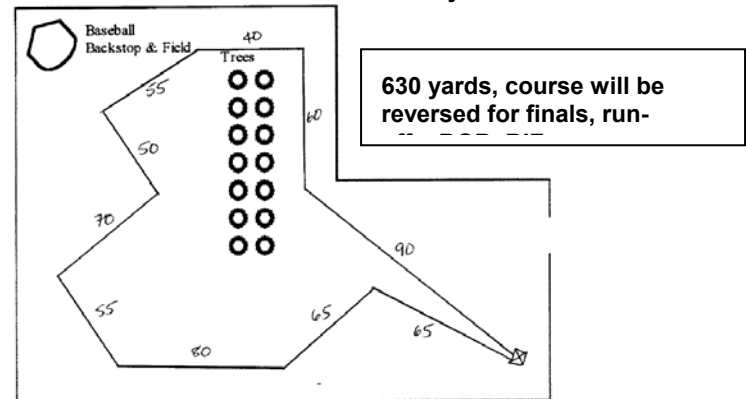
All entries must be one year or older on the day of the trial • Bitches in season, lame hounds and hounds with breed disqualifications will be excused and entries refunded • Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake • Any hound not present at roll call will be scratched • Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more • All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified

Please bring a dish for pot luck. Bathrooms will be available. BARRC assumes no liability for injury to any person or dog before, during or after this trial.

EQUIPMENT:

A battery powered, continuous loop system will be used with white or colored plastic streamers for the lure. Back-up equipment will be available.

COURSE PLAN: BARRC reserves the right to alter the course plan as required by weather and/or field conditions on the day of the Trial.
