

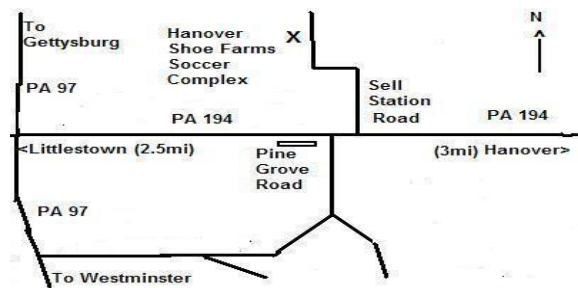
Directions to Hanover Shoe Farms, Sells Station Road Site:

From West or South: Rt. 97 to Littlestown. At the traffic light take Rt. 194 North to Sell Station Road. Left on Sell Station; 1.3 miles to site.

From East and North: Rt. 194 South out of Hanover. Sells Station Road is 0.8 miles past the main entrance to Hanover Shoe Farms. Turn right on Sell Station; 1.3 miles to the site.

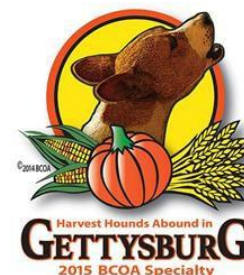

ELIGIBILITY

Only purebred Basenjis may be entered in the regular stakes. All entries in the regular stakes shall be individually registered with the AKC(ILP/PAL included), the UKC, an ASFA-recognized foreign or ASFA Board approved registry.

STAKES OFFERED:

Open: Any eligible Basenji, excluding ASFA Field Champions of Record that has met certification requirements.

Field Champion: Any ASFA Field Champion.

Veteran: Any eligible Basenji whose age is at least six years of age. Points & placements go toward V-FCH & V-LCM titles.

Single Stake: Any eligible Basenji including those disqualified to run in other stakes. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; Basenjis with breed disqualifications are not eligible to enter except in the Single Stake. Not eligible for Best of Breed or Best in Field. Basenjis are eligible to earn TCP and CPX titles from the Singles stake.

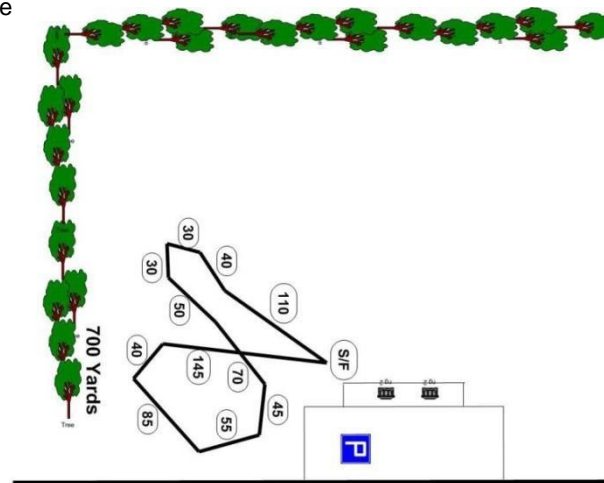
KENNEL STAKE: Open to 2 entries owned by the same person and kenneled together.
Must be indicated on entry. NOT RUN AS A SEPARATE STAKE

BREEDER STAKE: Open to 2 entries bred by the same person. Must be indicated on entry.
NOT RUN AS A SEPARATE STAKE.

BEST IN FIELD WILL NOT BE OFFERED

Conditions of Entry: Basenjis must be 1 year of age or older on the day of the trial. A stake will be split if 20 or more entries are present in any one stake at the time of the draw. All hounds will run twice, in trios if possible or braces unless excused, dismissed or disqualified. Bitches in season, Basenjis with breed disqualifications and lame Basenjis will be excused. Hounds not present at roll call will be scratched. Each entry will be examined at inspection for breed disqualifications. Spayed, neutered, cryptorchid, and monorchid Basenjis (without breed disqualifications) may be entered.

Battery powered, continuous loop lure machines will be used. The lure will consist of white plastic strips. Backup equipment will be available. The course will be reversed for the finals, runoffs and Best of Breed. The members of BCOA reserve the right to alter the course plan as required by weather and/or field conditions on the date of the trial. Exhibitors are requested to not bring bitches known to be in season to the field. There will be a \$5.00 fine assessed for any loose hound not participating in the course. Any person may, upon reasonable complaint, be asked to leave the grounds of the field trial by the Field Trial Committee
