EARLY ENTRY FEES AND PAYMENTS

MAIL ENTRIES to the Field Secretary's address above and make checks payable to "CCA". FAX ENTRIES will not be accepted. E-MAIL ENTRIES (to jennifergysler@gmail.com) will be accepted provided the Field Secretary receives payment before 8:00 pm on Thurs, March 24, and the entry form is signed. If paying by PayPal, send payment to socalcoursing@gmail.com only, and **pay for your own transaction fees**. Do not defer the Pay Pal fees to the club or your entry will be declined.

ENTRY INFORMATION

1. All entries must be one year or older on the day of the trial.
2. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
3. Bitches in season, lame hounds and hounds with breed disqualifications will be excused at rollcall.
4. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
5. Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
6. Hounds not present at the time of roll call will be scratched.
7. All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.
8. Hound certification runs will be offered a half hour prior to rollcall.

OPERATIONAL INFORMATION

1. Each course will be reversed for the final runs and reversed again for the Best of Breed run.
2. Gasoline powered continuous loop lure machines will be used. The lures will consist of plastic strips. Backup equipment will be available.

GENERAL INFORMATION

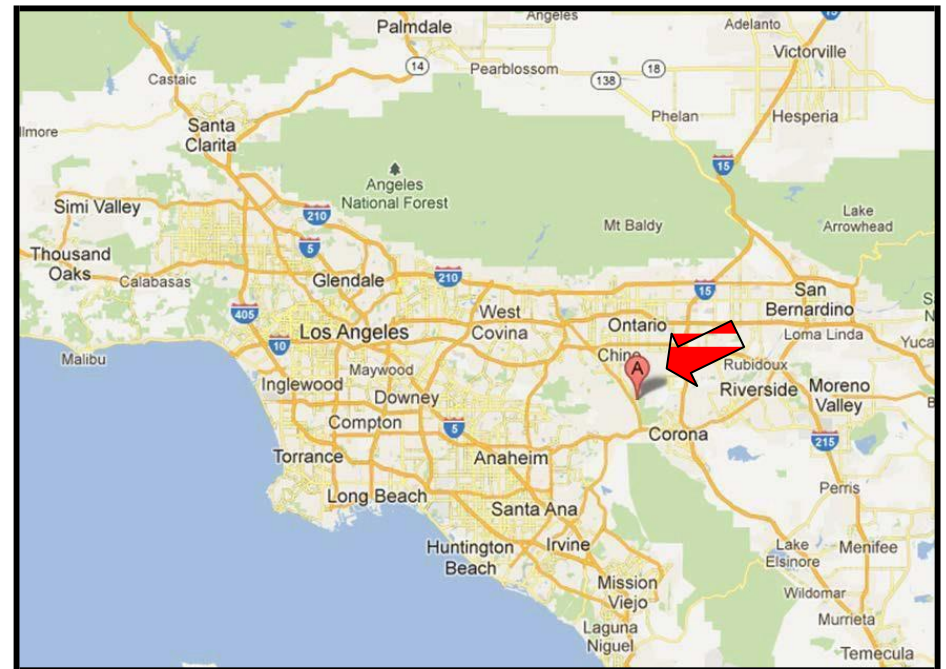
1. Please bring your own food, shade and water.
2. A restroom will be available.
3. No one, except Field Committee members, will be allowed on the field without the expressed permission of the Field Committee.
4. A \$5 fine will be assessed for loose hounds during courses in progress.
5. Anyone failing to clean up their dogs' waste will be excused from the field for the day.
6. Anyone exhibiting unsportsmanlike conduct will be excused from the field for the day.
7. CCA assumes no liability for injury to any person or dog before, during or after the Trial.

DIRECTIONS

From Orange County: Take the 55 North to the 91 East. Next, merge onto the 71 North. Then, take the Butterfield Ranch Road/Euclid Avenue (CA-83) exit. Turn right and the facility will be located on the right side 1/10 of a mile down Euclid Avenue.

From the Inland Empire: Take the 91 West onto the 71 North. Exit Butterfield Ranch Road/Euclid Avenue (CA-83) and make a right. The facility will be located on the right side 1/10 of a mile down Euclid Avenue.

From San Gabriel Valley: Take the 210 East to the 57 South. Then, transition on the 71 South towards Corona. Take the Butterfield Ranch Road/Euclid Avenue (CA-83) exit and turn left. The facility will be located on the right side 1/3 of a mile down Euclid Avenue.



PARK ADMISSION - IMPORTANT

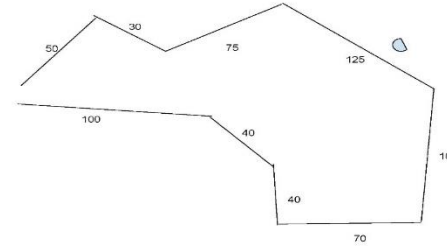

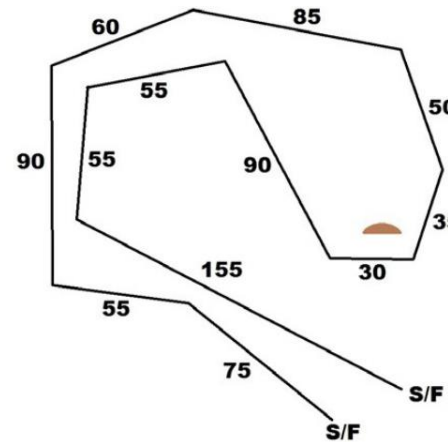

CALIFORNIA COURSING ASSOCIATION PROCEDURES

We will follow State and local guidelines.

1. All participant will wear facial coverings over nose and mouth and maintain social distancing of 6 feet.
2. Please bring your own food, water and shade for yourself and your dogs. None will be available at the trial.
3. We ask that you park 6 feet away from each other.
4. Roll Call will be done at everyone's car, instead of at the secretary's table area. The roll call committee will wear gloves and facial coverings. We will ask the owners of females to wipe their dogs and show the inspection committee the tissue.
5. Wickets will be wiped down after each dog is measured.
6. We will have instant hand sanitizer and wet wipes in several locations for your use.
7. Restrooms: We must use the restroom at the kennel area where you check-in and pay to enter. Please keep in mind you will likely want to drive to this area as it is uphill from the field.
8. Huntmasters will stand 6 feet from the dogs after inspecting blankets and slip leads.
9. Dogs will be run in braces to ensure social distancing at the line and will be 6 feet apart.
10. Practice social distancing the best you can. Please act responsibly.
