Directions to the Field

GPS Address: Camden Polo Field, Polo Lane, Camden, SC

From the north ~ Follow Hwy 97/521/601 into Camden. In Camden, Hwy 97/521/601 south becomes Broad Street. Pass the railroad tracks. Take the 2nd street on the RIGHT. Polo lane, a very narrow street (about one car width) beside a historical landmark sign. Follow polo lane to the field (watch for signs)

From the south ~ On I-20 in SC, Take exit 92 onto US 601 north toward Camden. Travel about 5.5 miles and turn left onto 601 North Truck/Springdale Drive (1st traffic light past Wal-Mart. Turn right onto Hwy 97 which blends into Broad Street. Pass the railroad tracks. Take the 2nd street on the right. Polo Lane (a very narrow street) with a historical landmark sign. Follow Polo Lane to the field. Watch for sign.

ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis and Whippets breeds may be entered in the regular stakes.

Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

REGULAR STAKES OFFERED

OPEN STAKE: Any eligible sighthound, excluding ASFA Field Champions of record that have met certification requirements.

FIELD CHAMPION STAKE: Any ASFA Field Champion

VETERAN STAKE: Any eligible hound that has met certification requirements whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

LIMITED STAKE: Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

SINGLE STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

BEST IN FIELD WILL NOT BE OFFERED

BEST IN EVENT WILL BE OFFERED.

Best of Breed winners from both days may compete for Best In Event on Sunday, "Stewart Holcomb Memorial Trophy"

Conditions of Entry: All entries must be one year or older on the day of the trial • Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more • Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. • Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake • Hounds not present at the time of roll call will be scratched • All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

Equipment:

Type of lure machine: battery-powered continuous-loop system.

- Type of lures: highly-visible white plastic strips and/or fur
- Back-up equipment will be available.

Only the Lure Operator, Huntmaster, Judges and Handlers of the hounds running in the course in progress will be permitted near the lure machine. The members of Carolina Lure Coursing Society reserve the right to alter the course plan as required by weather and/or field conditions on the day of the trial. The field will be reversed for finals, runoffs, Best or Breed and Best In Event.

Children must be under control of their Parent(s) or Guardians(s) at all times.

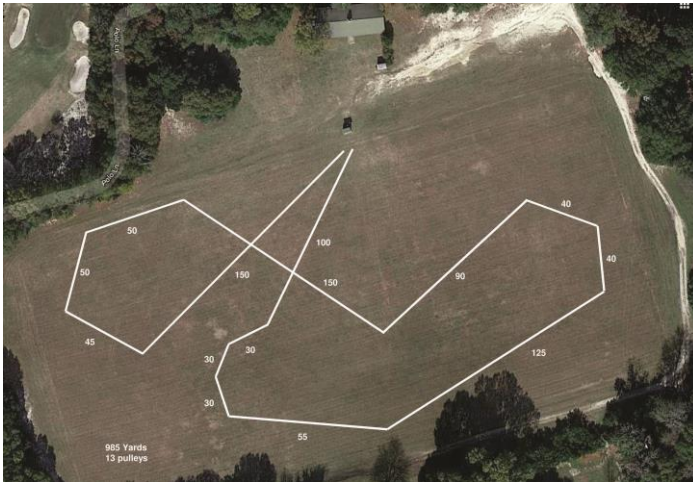
There will be a \$10.00 fine for any loose dog that disrupts a course in progress.

Practice will be offered (weather, equipment and time permitting) after completion of the trial on Saturday only. \$3.00 per dog. No practice on Sunday.

COURSE PLANS

These course plans comply with ASFA Rule Section 8, Item 3 (s), page 14. CLCS reserves the right to alter the course due to field and/or weather conditions on the day of the trial. Course will be reversed for finals, runoff and BOB. Terrain is gently rolling, the field is not completely fenced. Each hound is entered and competes at the sole risk of its owner. It is recommended that hounds are in good physical condition.
