ELIGIBLE BREEDS & REGISTRY

Only purebred Silken Windhounds may enter. All entries shall be individually registered with the Silken Registry (ISWS), UKC, an ASFA- recognized foreign or ASFA Board approved registry. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry.

REGULAR STAKES OFFERED


