From I-20 heading East: Take Exit 37 Hwy 92 Fairburn/Douglasville; end of ramp go Right on 92 South/ Fairburn Rd. Go 5.2 miles then go Right at light staying on 92 South Fairburn Rd. Go for 4.2 miles then at light go Right on Cascade Palmetto Rd. Go 0.3 miles then Right on Cochran Mill Rd. Go 1.8 miles to Cedar Grove Rd and turn RIGHT. Go 2/10th mile, then right onto Browns Lake Road. Follow signs to Field Trial

From I-20 heading West: Take I-285 South (Exit 67A) toward Macon/Atlanta Airport. Go 15.3 miles. Take exit 62 Spur 14. Go .7 miles keep left towards South Fulton Pkwy. Stay on S. Fulton Pkwy for 7.5 miles then Right on "Hwy 92 Campbellton Fairburn Rd". Go 4.5 miles then Left on "Hwy 70 Cascade Palmetto Hwy". Go 0.3 miles then Right on "Cochran Mill Rd". Go 1.8 miles to Cedar Grove Rd and turn RIGHT. Go 2/10th mile, then right onto Browns Lake Road Follow signs to Field Trial

From I-85 heading North: Take Exit 61 Hwy 74, Fairburn; end of ramp go left heading North on 74. When the 4-lane lane turns into a 2-lane, stay straight (do not continue on 74; go straight for 2.3 miles until the road dead ends into Rivertown. There will be portable toilets available – DO NOT put poop bags in the toilet!!!

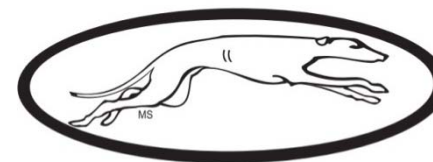

Eligibility

Only purebred Ibizan Hounds may enter the regular stakes.

All entries shall be individually registered with the AKC, FCI, UKC or an ASFA recognized foreign or an ASFA approved registry. A photo copy of acceptable registry must be submitted with each hound's first ASFA field trial entry.

Ribbons

1st - blue, 2nd - red, 3rd - yellow, 4th - white, NBQ – green, BOB - purple & gold
High scoring singles – navy blue & gold

Trophies

Special trophies will be awarded for 1st placements in each stake and for BOB.

Stakes Offered

Open: Any eligible Ibizan Hound that has met certification requirements, excluding ASFA Field Champions of record.

Field Champion: Any Ibizan Hound ASFA Field Champion

Veteran: Any eligible Ibizan Hound that has met certification requirements whose age exceeds 6 years.

Singles: Any eligible Ibizan Hound including those disqualified to run in other stakes. (Hounds run alone and are not eligible for BOB). Hounds eligible to earn TCP and CPX titles from the Singles stake.

General Information

- All entries must be one year of age or older on the day of the trial.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused.
- Substitutions (same owner) are allowed if the FTS is notified 30 minutes prior to roll call.
- Spayed and neutered, monorchid and cryptorchid hounds without breed disqualifications may be entered.
- Hounds not present at roll call will be scratched.
- All hounds will run twice, in trios if possible or braces, (except in the Single Stake), unless excused, dismissed or disqualified.
- Battery powered, continuous loop equipment will be used. Lures will consist of highly visible plastic strips and/or fur. Back-up equipment will be available.
- A \$5.00 fine will be assessed for any loose hound on the field that is not competing in the course in progress.
- GANG reserves the right to alter course due to field and/or weather conditions on the day of the trial.
- Any person may, upon reasonable complaint, be asked to leave the grounds by the Field Committee.
- There will be a minimum \$25 returned check charge.

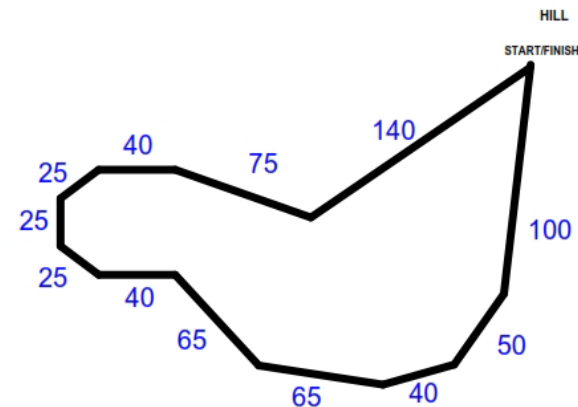
Course Plan

Field Conditions

The field is grass, which has been occasionally mowed. It is a hayfield and is not perfectly groomed, but it is level to gently sloping.

Course will be reversed for finals, runoffs and Best of Breed. Course design is subject to change depending on weather and field conditions.
