

**VETERAN:** Any eligible hound whose age is over 6 years, except Irish Wolfhounds whose age shall be at least 5 years and Whippets, Rhodesian Ridgebacks, Salukis & Afghan Hounds whose age shall exceed 7 years. Points go toward V-FCH or V-LCM titles.

LIMITED: Any eligible sighthound of a LIMITED Breed \* that has met certification requirements. Not eligible for BOB or BIF.



Hounds with breed disqualifications are not eligible to enter except the Single Stake. Hounds not present at the time of roll call will be scratched. All hounds will run twice, in trios if possible or braces (except in the Single Stake) unless excused, dismissed or disqualified. Muzzles will not be required but may be used at the handlers discretion. A \$5.00 fine will be imposed for any loose hound on the field not competing in the course in progress. 
