Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzois, Cirneco dell'etnas, Greyhounds, Ibizan Hounds, Italian Greyhounds, Irish Wolfhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Silken Windhounds and Whippets may enter. All entries shall be individually registered with the AKC (inl. ILC & PAL), the NGA, the FCI, the UKC, an ASFA-recognized foreign or ASFA board approved registry, or possess a CRN from the SPDBS. <u>LIMITED</u>: Any eligible sighthound of a LIMITED Breed \* that has met certification requirements. Not eligible for BOB or BIF.

<u>SINGLE</u>: Any eligible sighthound including those disqualified to run in other stakes. Hounds are eligible to earn TCP & CPX titles from the Singles Stake. Limited breeds are not eligible for these titles. Hounds will run alone. Not eligible for BOB or BIF.



CONDITIONS OF ENTRY: All entries must be 1 year of age or older on the day of the Trial. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more. Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered. Hounds with breed disqualifications are not eligible to enter except the Single Stake. Hounds not present at the time of roll call will be scratched. All hounds will run twice, in trios if possible or braces (except in the Single Stake) unless excused, dismissed or disqualified. Muzzles will not be required but may be used at the handlers discretion. A \$5.00 fine will be imposed for any loose hound on the field not competing in the course in progress. Club reserves the right to alter the course the day of the trial due to weather and/or field conditions. Owners must keep hounds under control and clean up after them. The course will be reversed for final courses, reversed again for Best of Breed, Best In Field, and Run-Offs. Certification runs will be offered after the trial.
