**Roll Call & Inspection for all breeds:** 8:30 AM Eastern Time. Worker's dogs may be roll called early.

Late, incomplete, conditional, unsigned, unpaid entries and entries without a registration number will NOT be accepted. Entries will NOT be acknowledged by mail. Substitutes for lame or in-season hounds will be allowed if substitute has the same owner and the trial secretary is notified before the close of day-of-trial entries.

**Breeds & Eligibility:** Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirnecho dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, Whippets, provisional breeds, if any, may be entered in the regular stakes. Limited stake breeds, if any, may be entered in Limited Stake or Singles Stake. Limited breeds currently include purebred Chart Polskis, Galgo Españols, Magyar Agars, Peruvian Inca Orchids, Portuguese Podengo (Pequeno), & Portuguese Podengo (Medio & Grande).

All entries in the regular stakes shall be individually registered with the American Kennel Club (ILP/ PAL included) the United Kennel Club, the National Greyhound Association, the Federation Cynologique Internationale, an ASFA-recognized foreign or ASFA Board approved registry, or possess a Critique Registration Number (CRN) from the Society for the Perpetuation of Desert Bred Salukis (SPDBS). Limited stake entries shall be individually registered with the appropriate registry. A photocopy of acceptable registry must be submitted with a hound's first ASFA field trial entry; this requirement is waived for hounds registered with the National Greyhound Registry.

**Regular Stakes Offered:**

**OPEN STAKE:** Any eligible sighthound who has met certification requirements, excluding ASFA Field Champions of record. A photocopy of the hound's registration must be submitted at the hound's first trial. This is waived for NGA greyhounds

**FIELD CHAMPION STAKE:** Any ASFA Field Champion of record.

**VETERAN STAKE:** Any eligible hound whose age is at least six years, except Irish Wolfhounds, whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least seven years. Points earned in this stake are towards the V-FCH or V-LCM titles.

**LIMITED STAKE** for Chart Polskis, Galgo Espanols, Magyar Agars, Peruvian Inca Orchids, & Portuguese Podengos that have met certification requirements. Not eligible for Best of Breed or Best In Field.

**SINGLES STAKE:** Any eligible sighthound including novice hounds and hounds with breed disqualifications and/or hounds that have been disqualified from competition in other stakes, are eligible to enter. Hounds are eligible to earn TCP and CPX titles from the Singles Stake. Limites Breeds are not eligible for these titles. Not eligible for Best of Breed or Best In Field. .

**BEST IN FIELD** will be offered on Saturday only.

**Conditions of Entry:** All entries must be one year or older on the day of the trial. If the entry in any regular stake is 20 or more, the stakes will be split into flights by public random draw Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake. Hounds not present at the time of roll call will be scratched. All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified. Hound certification runs will be offered after completion of the trial on Saturday.

There will be a \$5.00 fine for any loose hounds on the field which are not in the course in progress. There will also be a \$5.00 fine for any one who does not pick up after their dog.

Trailers and motor homes are allowed at the park for a fee of \$20 for the weekend. Please notify Paul Kytta if you will be bringing a motor home or trailer and include the \$20 fee with your entries. Please also provide us with your vehicle license plate number so that we can notify the local authorities that you are authorized to be in the park after dark. No tent camping allowed. There are no water or electrical hookups. Generators are allowed but must be turned off between 11 pm and 7 am. The park does have facilities with running water and flush toilets.

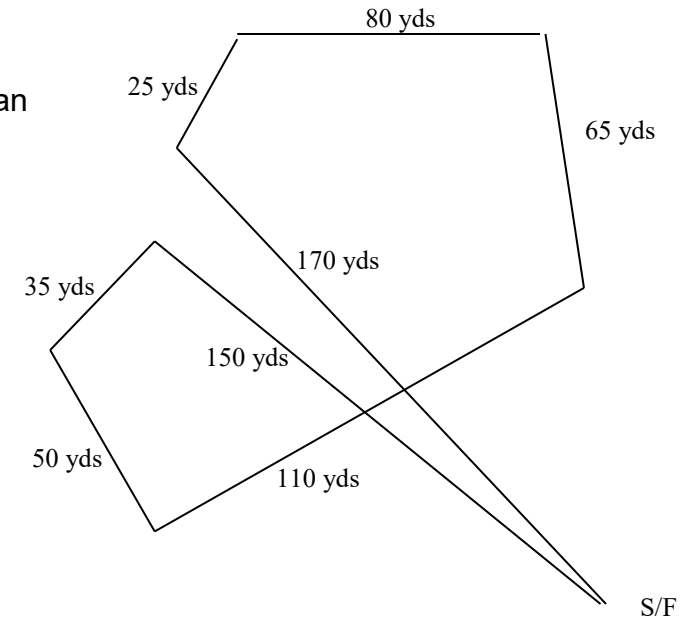
From points east via 90/2: Exit highway at Center Road (Route 83), Exit #153, and head south to Detroit Road. Make a right on to Detroit Road, heading southwest, park entrance will be approximately 2.5 miles on your left.

Follow the parkway all the way back past the ball fields into the park until the road dead ends into a parking lot near a pavilion. You may park anywhere in this parking lot. The field is on the northwest side of the parking lot.

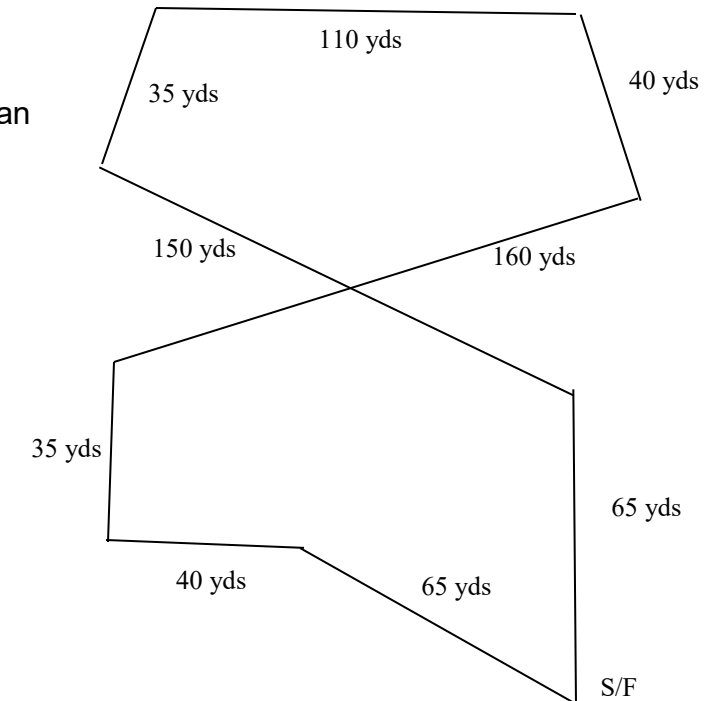

A battery powered CONTINUOUS LOOP lure machine will be used; backup equipment will be available. Lure will consist of highly visible plastic. The club reserves the right to alter the course as required by weather and/or field condition on the day of the trial. Courses will be reversed for finals, run-offs and again for BOB. The field is not fenced, but the course is well away from the main road.
