Check-in for dogs belonging to the field committee will begin 30 minutes before published trial hours.

Saturday, September 5th – "Day of" entries close at 8am.

Roll Call at 9am – Draw at 9:15 am with trial to start immediately after the draw.

Certification runs will be offered before the trial for dogs planning to enter this trial. Dogs not entering this trial may certify after the trial completes.

The handler presenting the certifying hound shall be responsible for providing the Testing Hound for the qualifying course.

Eligible Breeds:

This is a Pharaoh Hound specialty trial.

General Information:

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board

approved registry. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry.

Stakes Offered:

OPEN STAKE – Open to Pharaoh Hounds excluding ASFA Field Champions of record.

FIELD CHAMPION STAKE - Any Pharaoh Hound ASFA Field Champion of record.

VETERAN STAKE – Any Pharaoh Hound whose age is at least six years.. Points go toward V-FCh or V-LCM titles.

SINGLE STAKE – Any Pharaoh Hound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake.

KENNEL STAKE – Highest combined score for two Pharaoh Hounds with at least one common owner. Please complete attached entry form.

BREEDER STAKE – Highest combined score for two Pharaoh Hounds with at least one common breeder. Please complete attached entry form.

Conditions of Entry:

Hounds must be one year or older on the day of the trial. All hounds will run twice, in trios if possible or braces unless excused, dismissed or disqualified. Bitches in season and lame hounds will be excused. Hounds not present at the time of roll call will be scratched after a five-minute grace period. Each entry will be examined at inspection for breed disqualifications. Hounds determined to have a breed disqualification at the time of roll call shall be barred from competition and their entry fees shall be refunded. Spayed, monorchid, cryptorchid, and neutered hounds without breed disqualifications may be entered. Regular stakes will be split if 20 or more entries are present in any one stake at the time of the draw. Any hound that displays aggressive behavior during trial hours will be excused for the day. A penalty of \$5 will be assessed for any loose hound not competing in the course in progress.



Equipment & Field Information:

Terrain is natural field with uneven ground. Hounds need to be in top physical condition due to the high elevation. Battery powered continuous loop machine will be used. Backup equipment will be available. Lure will consist of white plastic strips and/or strips of fur. USRCC reserves the right to alter the course diagram as required by weather and/or field conditions on the day of the trial.

Course Plan:

The course is 800 yards, reversed for finals, BOB direction at the discretion of the judge.



General Information:

There will be a Port-a-John on site. Bring your own food, water and shade. No littering. Pick up after your dogs, and please haul your garbage off the field. There will be a fine for NOT leaving the field as you found it. Camping is available for *self-contained* motorhomes with NO hookups and NO DUMPING. Due to the proximity of homes to the RV parking area, dogs may not be off leash and barking must be kept to an absolute minimum.

USRCC relies on the generosity of all club members and visiting exhibitors to fund future trials. Please join us for home-cooked fundraiser lunch on the field and a raffle after the trial to help support our club!

USRCC welcomes spectators, but asks that all spectators and exhibitors adhere to ASFA and USRCC standards of conduct. Any spectator or exhibitor that behaves in an inappropriate manner will be asked to leave the trial site.

Directions to 14400 N 10800 W, Bothwell, UT:

From I-84 northbound, take Exit 39 for Garland/Bothwell. Turn left off the exit on to Rocky Point Rd, then right on the Frontage Road. Follow the frontage road for 3.7 miles until it bears left and becomes 13600 North, then turn right on to 10800 West. The field will be approximately one mile in on 10800 West.

Once you have reached the gate, enter and follow the fenceline to the left. Club representatives will be available starting Friday afternoon to help guide RVs and Trailers.
