

ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis, and Whippets may be entered in the regular stakes.

Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

STAKES OFFERED

OPEN STAKE: Any eligible sighthound, excluding ASFA Field Champions of record, that have met the certification process.

FIELD CHAMPION STAKE: Any ASFA Field Champion

VETERAN STAKE: Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

LIMITED STAKE: Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

SINGLE STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

GENERAL INFORMATION

Conditions of Entry:

- All entries must be one year or older on the day of the trial. •
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, lame hounds and hounds with breed disgualifications will be • excused at roll call.
- Spayed, neutered, monorchid or cryptorchid hounds without breed • disgualifications may be entered.
- Hounds with breed disqualifications are not eligible to enter except in the Single • Stake.
- Hounds not present at the time of roll call will be scratched and entry fees will not • be refunded.
- All hounds will run twice, in trios if possible or braces (except in the Single Stake), • unless excused, dismissed or disqualified.
- Hound certification runs will be offered BEFORE the trial and will begin at • 8:30 AM. Certifications will be offered after the trial as time permits. A \$5 fee is applicable per run.
- Early-entry fees submitted and accepted with early-entries will be refunded in full if the withdrawal of said entries is requested by the hound's owner or agent prior to the closing deadline for early-entries. Requests may be made by timestamped email to the FTS or by direct contact (phone or in person) with the FTS. No refunds for early-entry fees will be returned after the closing of early-entries unless the entered hound upon inspection is lame or in season.
- Day-of-trial-entry fees submitted and accepted with day-of-trial-entries will be • refunded in full if the withdrawal of said entries is requested by the hound's owner or agent prior to the closing deadline for day-of-trial-entries. Requests must be made in person to the FTS. No refunds for day-of-trial-entry fees will be returned after the closing of day-of-trial-entries unless the entered hound upon inspection is lame or in season
- Electrical-powered, continuous loop lure machine will be used with back-up • equipment available
- The lure will consist of light and/or light colored plastic and/or fur. ٠
- Muzzles are not required; it is the responsibility of the owners to determine if their • hound should be muzzled. If a muzzle is used, it must be of a color other than vellow, pink or blue
- \diamond Late, conditional, unsigned, incomplete or unpaid entries will not be accepted
- ٠ Early-Entries will not be acknowledged by mail; Entries will be acknowledged by e-mail if requested and if an e-mail address is provided
- * Substitutions may be made for hounds lame or in season at the time of roll call
- ••• Entries shall be refused for First Time Entered Hounds entering Open, Veteran or Limited Stakes that do not have a copy of registration papers (NGA Grevhounds excepted) to accompany a completed, signed and approved certification form. If a hound has earned a title that waives the certification requirement, a copy of that title certificate must accompany the appropriate ASFA form of waiver
- Hounds may enter the SINGLES stake without having ASFA certification, but \diamond must provide a copy of their official registration papers



McKinney is located approximately 33 miles north and east of downtown Dallas via U.S. Highway 75 (North Central Expressway). From U.S. Highway 75, take the Highway 380 Exit (Exit 41), and head WEST approximately 2.5 miles until you reach FM 1461. Turn right/North on FM1461 and travel approximately 3.8 miles to County Road 166. Turn right/North on County Road 166 Go about a mile. You will see the MPEC on your left. Do not turn in. Continue until you reach the stop sign at County Rd 168. Turn left/West onto County Road 168.

On the left you will see the MPEC offices and a large yellow metal barn. Continue past that area to the second gate on the left. Turn left into that gate, where there is a gravel road and a large gravel parking area.
