Large Open: for dogs over 17-1/2 inches at the withers who have not achieved the title of LCC. Large Senior: is for dogs over 17-1/2 inches at the withers who have achieved the title of LCC. Large Veteran: for dogs over 17-1/2 inches at the withers who are over the age of 7 years. Sighthound Mix Open: for dogs with a sighthound breed in its background who have achieved the title of LCC. Sighthound Mix Senior: for dogs with sighthound breed in its background who have achieved the title of LCC. Sighthound Mix Veteran: for dogs with sighthound breed in its background over the age of 7 years.

When running as a stake within a regular ASFA trial, Small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length.




