**Breeds & Eligibility:** Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneci dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, Whippets and Provisional breeds may be entered in the regular stakes. There currently are no Provisional breeds. Limited breeds may be entered in Limited Stake or Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries in the regular stakes shall be individually registered with the AKC (including ILP and PAL), the UKC, the NGA, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS.. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

Late, incomplete, unsigned or conditional entries will not be accepted. Entries will **NOT** be acknowledged by mail. Preliminary courses for all breeds will be completed before beginning final courses.

### REGULAR STAKES OFFERED:

**Open Stake:** Any eligible sighthound that has met certification requirements, excluding ASFA Field Champions of record.

**Field Champion Stake:** Any ASFA Field Champion of record

**Veteran Stake:** Any eligible sighthound that has met certification requirements whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghans, Rhodesian Ridgebacks, Salukis, and Whippets whose age shall be at least seven years. Points and Placements go toward V-FCH and V-LCM titles.

**Limited Stake:** any eligible sighthound of a Limited or Provisional stake breed that has met certification requirements. Not eligible to compete in BOB or BIF.

**Singles Stake:** Any eligible sighthound including those disqualified to run in other stakes.. Each hound runs alone. Not eligible to compete for BOB or BIF. Hounds are eligible to TCP & CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

All hounds entering Open, Veteran or Limited Stakes for the first time MUST include a completed ASFA certification form or waiver form and a copy of the hound's registration certificate (registration is not required for NGA Greyounds ONLY; certification or waiver is not required for Singles stake entries ONLY).

Best in Field will be offered on Saturday only.

### CONDITIONS OF ENTRY

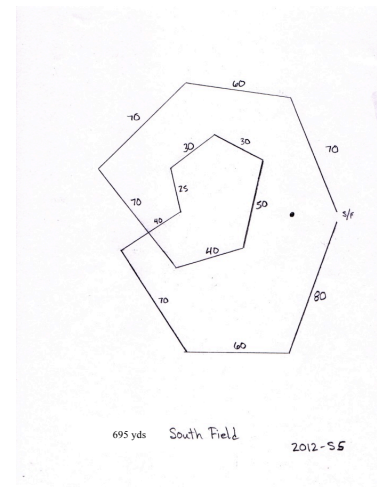
Hounds must be one year of age or older on day of trial. • Regular stakes will be split into flights by random public draw if 20 or more entries are present in any one stake at the time of the draw • Bitches in season, hounds with breed disqualifications, and lame dogs will be excused • Hounds with breed disqualifications are not eligible to enter except in the singles stake • All Hounds will be run twice in trios if possible, or braces, except in the Singles stake, unless excused, dismissed or disqualified • Hounds not present at roll call will be scratched.

- Hound certification runs will be offered after the trial on Saturday only.
- A penalty of \$5.00 will be assessed for any loose hound not competing in the course in progress.
- Battery powered continuous loop lure machine will be used; backup equipment will be available.
- Lure will consist of plastic.
- The MCA provides slip leads and blankets.

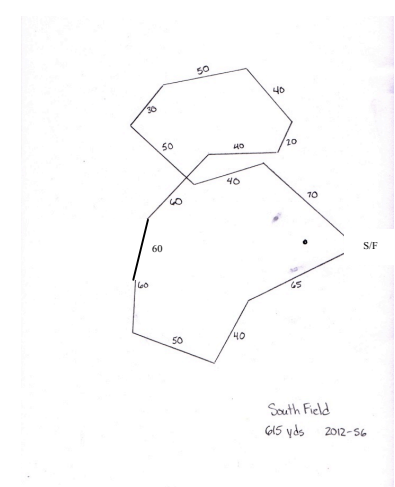

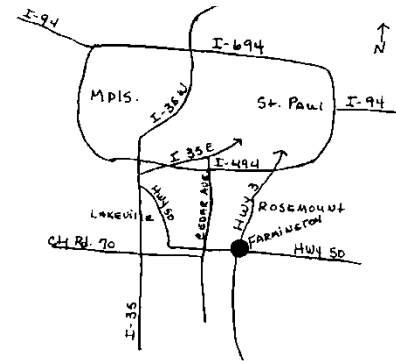

**Directions to the Field:** From either north or south on I-35, take exit 81 east (County Road 70). Follow 70 east about 3 miles to Cedar Avenue. Turn left on Cedar about 1/8 mile to Highway 50. Turn right (east) on 50 to Farmington. Follow the signs to the Dakota County Fairgrounds. Proceed to the southwest side of the fairgrounds.
