**ROLL CALL:** Promptly at 1:30 PM; hounds not present at roll call will be marked absent and are not eligible for a refund of entry fee.

We are pleased to offer each dog that earns a new ASFA title at our trial a New Title rosette. Please notify the FTS if your hound might earn a new title at our trial.

### ELIGIBLE BREEDS & REGISTRY

Only purebred Silken Windhounds may be entered in the regular stakes. All entries should be individually registered with the Silken Registry (ISWS), UKC, an ASFA recognized foreign or ASFA Board-approved registry.

All LCI entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

### REGULAR STAKES OFFERED

**OPEN STAKE:** Any eligible sighthound, excluding ASFA Field Champions of record that has met the certification requirements.

**FIELD CHAMPION STAKE:** Any ASFA Field Champion

**VETERAN STAKE:** Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Ibizan Hounds, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least seven years. That has obtained an ASFA certification, AKC QC, or other qualifying waivers prior to the closing date. A copy of the certificate MUST be submitted with the entry forms. Points go toward V-FCh or V-LCM titles.

**SINGLES STAKE:** Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Provisional breeds are not eligible for these titles.

**LURE COURSING INSTICT (LCI STAKE):** Open to non-sighthounds and sighthound mixes. All entries shall be individual registered with the AKC (including ILP, CP, and PAL) or the UKC. A photocopy of acceptable registry must be submitted with each dog's first ASFA field trial entry. Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registry fee at time of entry.

**SMALL OPEN:** for dogs 17.5" or less at the withers and/or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC.

**SMALL SENIOR:** for dogs 17.5" or less at the withers and/or brachycephalic ("flat-faced") dogs who have achieved the title of LCC.

**SMALL VETERAN:** for dogs 17.5" or less at the withers and/or brachycephalic ("flat-faced") dogs who are over the age of 7 years.

**LARGE OPEN:** for dogs over 17.5" at the withers who have not achieved the title of LCC.

**LARGE SENIOR:** for dogs over 17.5" at the withers who have achieved the title of LCC.

**LARGE VETERAN:** for dogs over 17.5" at the withers who are over the age of 7 years.

**SIGHTHOUND MIX OPEN:** for dogs with a sighthound breed in its background who have not achieved the title of LCC.

**SIGHTHOUND MIX SENIOR:** for dogs with a sighthound breed in its background who have achieved the title of LCC.

**SIGHTHOUND MIX VETERAN:** for dogs with a sighthound breed in its who are over the age of 7 years.

When running as a stake within a regular ASFA trial, Small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length.

## CONDITIONS OF ENTRY

*Applies to all stakes*

- All entries must be one year or older on the day of the trial
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.
- Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake Hounds not present at the time of roll call will be scratched
- All hounds will run twice, in trios if possible or braces (except in the Singles and LCI Stakes), unless excused, dismissed or disqualified.
- Please do not bring bitches known to be in season to the field.

**REMINDER:** first time entries: a copy of the hound's registration must be submitted with a hounds ASFA field trial entry, except if the hound is registered with the NGA.

## HOUND CERTIFICATIONS

All first time entered hounds must present either the judge-signed ASFA Hound Certification or waiver certificate or AKC Qualified Coursing certification and a copy of the hound's registration to the FTS before entries close to be considered complete. First time single entrants do not need a hound certification/waiver.

## ADDITIONAL INFORMATION

- There will be a \$5.00 fine assessed for any loose hound not participating in the course.
- Any person may, upon reasonable complaint, be asked to leave the grounds by the Field Trial Committee.
- Any hound which is entered in a trial must have a copy of the hound's registration papers to send in with the entry. This is true if the hound is entering Open, Veteran, Singles, or Provisional stakes for the first time.
- Dakota County Fairgrounds are not securely fenced; it is strongly recommended that prior to running your hound, you have good control over your dog, as the dogs will run off leash.
- Handlers should wear comfortable, sturdy shoes and be physically able to hold, catch, and release their dogs.
- Coursing is a physically demanding sport and can tax a hound's physical strength. Hounds that are old, have physical ailments, or are out of condition may be at greater risk for injury. Consult your veterinarian if you have any concerns.
- Muzzles are not required but are permitted at the handler's discretion.
- Please do not bring bitches known to be in season to the field.
- Each entry will be inspected for breed disqualifications, lameness, fitness to compete, and females in season. Any entry found to be unfit to safely compete shall not be allowed to entry and entry fees shall be refunded. Hounds with breed disqualifications will be excused and entry fees will not be refunded.
- The club will have coursing slip leads and blankets available as needed.

- FTE LCI dogs must be wicketed
- MCA issues entry fee refunds for dogs that are in season or lame. You must inform the FTS before roll call to request a refund if your dog will not be attending the trial for these reasons.

#### **FOOD**

MCA will host a potluck brunch during this trial. **Please come early and join us** by bringing a dish to share or a free will donation.

#### **HOW TO ENTER**

- Pre-entry: mail completed entry form and payment to the FTS. Do not send entries without a signature.
- Day of trial entry: provided an entry limit has not been reached (if applicable), bring entry form and payment to the event before close of entries.
- Checks should be made payable to Minnesota Coursing Association.
- Separate entry forms and entry fees are required for each dog.
- A fee of \$40.00 will be assessed for any returned checks.
- Incomplete, unsigned, conditional, or unpaid entries will not be accepted.
- The club and/or the Field Trial Secretary assume no responsibility for wrong or incomplete information given on the entry form.

#### **Lure Chase Instinct (LCI) Program**

All non-sighthounds, sighthound-mixes, and mixed-breeds entered must have a registration number with one of the accepted registries or obtain a unique entry number from ASFA (see below). A photocopy of the acceptable registry must be submitted with each dog's first ASFA field trial entry. Acceptable registries:

- American Kennel Club (AKC):
  - Registration as a recognized breed
  - Purebred Alternative Listing (PAL) program, which is for purebred dogs that cannot be fully registered with the AKC to participate in AKC events.
  - Canine Partners (CP), which is for mixed-breed dogs and dogs ineligible for other types of AKC registration.
  - Foundation Stock Service (FSS), which is for recorded breeds on the road to full AKC recognition.
- United Kennel Club (UKC) registration:
  - Registration as a recognized breed
  - A Performance Listing (PL) number

If the dog does not have one of the above registrations, ASFA will provide a unique entry number for a one-time \$10 charge.

1. The owner has to complete an ASFA request for a unique entry number.
2. The Trial Secretary will submit a copy of the form with the records.
3. The owner will retain a copy as proof of request and payment until a permanent number is provided.

**Field Setup**

- Come early in the morning to help unload and set up equipment
- Help prepare the field for the dogs by learning how to measure the course, place pullies, and fill holes.

**Field Tear Down**

- Help tear down the field, pick up the pullies and put everything away.

**Inspection**

- Check-in dogs, ensure they are ready to run, and get the trial moving

**Field Clerk**

- Sit on the field with the judges and prepare the scoresheets they fill out.
- Learn how the scores are recorded and check for math errors. Learn by listening to the judges.

**Paddock**

- Make sure everyone knows who is running and who is up next

**Lure Operator**

- Hang around and talk with the lure operator between courses.
- Try running the lure around before the trial or after the trial concludes.

**Huntmaster**

- Spend some time on the field with an experienced huntmaster and watch how they check dogs as they come to the line
- Talk with them between courses about how they watch the dogs throughout the course and the things they are checking
