
## Directions to Hanover Shoe Farms, Sell Station Road Site:

**General Site Descriptions:** The Sell Station Road soccer complex is fenced and remote from busy roads. The weather may be hot and dry. Please provide shade and water for your hounds.

*From East and North:* Rt. 194 South out of Hanover. Sell Station Road is 0.8 miles past the main entrance to Hanover Shoe Farms. Turn right on Sell Station; 1.3 miles to the site.

## STAKES OFFERED:

## The entry for each hound entering the Open or Veteran Stake for the first time MUST include a completed & signed ASFA Certification Form, or AKC QC or a Waiver Form (with proof of title) and a copy of the hound's registration certificate (certification waived for Single Stake).

**Open:** Any eligible sighthound, excluding ASFA Field Champions of Record that has met the certification requirements.

Field Champion: Any ASFA Field Champion.

**Veteran:** Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least seven years. Points & placements go toward V-FCH & V-LCM titles.

**Limited Stake:** Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

**SINGLES STAKE:** Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible to compete in Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles

#### **ELIGIBLE BREEDS & REGISTRY**


Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, Whippets may be entered in the regular stakes.

Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFArecognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

**Conditions of Entry**: All entries must be one year or older on the day of the trial. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more. Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake. Hounds not present at the time of roll call will be scratched. All hounds will run twice, in triosif possible or braces (except in the Single Stake), unless excused, dismissed or disqualified. Hound certification runs will be offered Saturday only, following the trial, before practices. Each entry will be examined at inspection for breed disqualifications. Battery powered, continuous loop lure machines will be used. The lure will consist of white plastic strips. Backup equipment will be available. The course will be reversed for the finals, runoffs and Best of Breed. The members of MDIHC reserve the right to alter the course plan as required by weather and/or field conditions on the date of the trial. Exhibitors are requested to not bring bitches known to be in season to the field. There will be a \$5.00 fine assessed for any loose hound not participating in the course. Any person may, upon reasonable complaint, be asked to leave the grounds of the field trial by the Field Trial Committee.
