

DIRECTIONS



Myers Park and Event Center (MPEC)

McKinney is located approximately 33 miles northeast of downtown Dallas via U.S. Highway 75 (North Central Expressway). From U.S. Highway 75, take the Highway 380 exit and head WEST approximately 2.5 miles until you reach FM 1461. Turn right (NORTH) on FM 1461 and travel approximately 3.8 miles to County Road 166. Turn right (NORTH) on County Road 166. Go about a mile. You will see the MPEC on your left. Do not turn in. Continue until you reach the stop sign at County Road 168.

On the left you will see the MPEC offices and a large yellow metal barn. Continue past that area to the next gate on your left. Turn left into that gate. See the drawing below.

If it is too muddy to park on the grass, everyone will have to park on the paved road, so please plan to pull over as far as you can so other cars can still get by. We will try to park the motor homes in the small circular turn around area.

Ribbons or rosettes will offered for all placements.

First=Blue, Second=Red, Third=Yellow, Fourth=White, NBQ=Green Highest Scoring Single=Navy/Gold, Best of Breed=Purple/Gold, & Best in Field=Red, White & Blue.

ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, Whippets..

Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

REGULAR STAKES OFFERED

OPEN STAKE: Any eligible sighthound, excluding ASFA Field Champions of record. **FIELD CHAMPION STAKE:** Any ASFA Field Champion

VETERAN STAKE: Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Saluki and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

LIMITED STAKE: Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

SINGLE STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

BEST IN FIELD WILL BE OFFERED Saturday ONLY

Conditions of Entry: All entries must be one year or older on the day of the trial • Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more • Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. • Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake • Hounds not present at the time of roll call will be scratched • All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

GENERAL INFORMATION

Everyone must clean up after their dog(s). \$5.00 fine for not picking up after their dog or leaving trash on the field.

Certification runs will be offered on Saturday. You must pre-arrange runs with the Field Trial Secretary (e –mail OK) and must provide a your own test dogs

Hounds with breed disqualifications are not eligible to enter except in the Singles Stake.

Bring your own shade and water and protection from the elements. Texas weather at this time of year is wildly variable and can vary from hot and dry to windy, rainy and cold – sometimes all in the same day! Be prepared for anything.

Port-a-potty is available.

There will be a \$5.00 fine for any hound loose on the field, other than those running the course in progress.

There will be a \$35.00 fee for returned checks

Persons or hound exhibiting conduct detrimental to ASFA/NTXSC/AKC will be asked to leave the trial site.

Late, conditional, unsigned, incomplete or unpaid entries will not be accepted. Entries will not be acknowledged by mail, email or phone.

IMPORTANT - A photo copy of acceptable registry must be submitted with each hound's ASFA's first Field Trial entry. Requirement is waived for hounds registered with NGA.

Muzzles are not required, but will be permitted. (Bring your own.)

Equipment: Type of lure machine: battery-powered continuous-loop system. • Type of lures: highly-visible white plastic or dark strips • Back-up equipment will be available.


The field consists of gently rolling terrain. The field is NOT entirely fenced.

The NTXSC reserves the right to alter the course plan as required by weather and/or field conditions on the day of the trial. In this event a new course plan will be posted.


The total course length for Saturday is 715 yards - Sunday is 730 yards
