ELIGIBLE BREEDS & REGISTRY:

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, Whippets and Provisional breeds may be entered in the regular stakes. Provisional breeds are listed on the ASFA website.

“All entries in the regular stakes shall be individually registered with the American Kennel Club, the National Greyhound Association (NGA), including the United Kennel Club (UKC), the Federation Cynologique Internationale, an ASFA-recognized foreign or ASFA Board approved registry or possess a critique registration number (CRN) from the Society for the Perpetuation of Desert Bred Salukis (SPDBS). Provisional stake entries shall be individually registered with the appropriate registry. (Dogs with an Indefinite Listing Privilege (ILP) or Purebred Alternate Listing (PAL) from the American Kennel Club shall be considered registered with that body.)”

REGULAR STAKES OFFERED

OPEN STAKE: Any eligible sighthound, excluding ASFA Field Champions of record that has met the certification requirements.

FIELD CHAMPION STAKE: Any ASFA Field Champion

VETERAN STAKE: Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years. Afghan Hounds, Ibizan Hound, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least seven years. That has obtained an ASFA certification, AKC QC, or other qualifying waivers prior to the closing date. A copy of the certificate MUST be submitted with the entry forms. Points go toward V-FCh or V-LCM titles.

PROVISIONAL STAKE: Any eligible sighthound of a Provisional breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

SINGLES STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Provisional breeds are not eligible for these titles.

LCI STAKES: All eligible non-purebred sighthound dogs and mixed breeds. Must have a registration number via AKC, AKC Canine Partner, AKC PAL, UKC or ASFA registration.

Small Open: for dogs 17-1/2 inches or less at the withers and / or brachycephalic (“flat-faced”) dogs who have not achieved the title of LCC.

Small Excellent: for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs who have achieved the title of LCC.

Small Veteran: for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs over the age of 7 years.

Large Open: for dogs over 17-1/2 inches at the withers who have not achieved the title of LCC.

Large Excellent: for dogs over 17-1/2 inches at the withers who have achieved the title of LCC.

Large Veteran: for dogs over 17-1/2 inches at the withers who are over the age of 7 years.

Sighthound Mix Open: for dogs with a sighthound breed in its background who have not achieved the title of LCC.

Sighthound Mix Excellent: for dogs with sighthound breed in its background who have achieved the title of LCC.

Sighthound Mix Veteran: for dogs with sighthound breed in its background over 7 years of age.

AWARDS FOR TRIAL

Awards will be offered for Best of Breed

Ribbons or rosettes will be offered for all placements. Rosettes will be offered by ASFA for all placements at the Sunday Regional Invitational.

First=Blue, Second=Red, Third=Yellow, Fourth=White, NBQ=Green

Highest Scoring Single=Navy/Gold, Best of Breed=Purple/Gold,

& Best in Field=Red, White & Blue.

NON-REGULAR STAKES OFFERED (Sunday Invitational only) Rosettes will be awarded for Bench, Kennel and Breeder Stake Winners.

KENNEL STAKE: For any two hounds – designated upon entry – of the same breed which are owned by and living with the same individual. Hounds must be entered in Open, FCh, or Veterans.

BREEDER STAKE: For any two hounds – designated upon entry – of the same breed which are bred or co-bred by the same individual. Hounds must be entered in Open, FCh, or Veterans.

BENCH STAKE: For any hound eligible to enter a regular stake (Open, FCh, or Veterans) that has a conformation champion title from the AKC, CKC, or both, or a conformation grand champion title from the UKC. A copy of the hound's championship certificate must accompany entry in this stake.

RULES & INFORMATION:

All entries must be one year or older on the day of the trial. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more. Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered. Hounds with breed disqualifications are not eligible to enter except in the Single Stake. Hounds not present at the time of roll call will be scratched. All hounds will run twice, in trios if possible or braces, (except in the Single Stake and LCI), unless excused, dismissed or disqualified. There will be a \$5 fine assessed for any loose hound not taking part in a course in progress.

Persons exhibiting conduct detrimental to ASFA/ORCA/any hound(s)/other person(s) will be asked to leave the trial site.

This applies to hounds entering Open, Veterans, Singles, or Provisional for the first time.

Muzzles are not required; it is the owner's responsibility to determine if their hound should be muzzled. But muzzles are allowed.

Note: Hounds who have received a disqualification at an ASFA trial are ineligible to compete until reinstated.

Information for entering your dog in the LCI Stakes

Section 1. All non-purebred sighthound dogs entered must have a registration number via one of the following:

- A. AKC Registration as one of the recognized breeds.
- B. AKC Canine Partners, which is for mixed-breed dogs and dogs ineligible for AKC registration.
- C. Purebred Alternative Listing (PAL) program, which is for purebred dogs that cannot be fully registered with the AKC to participate in AKC events.
- D. Foundation Stock Service® (FSS), which is for recorded breeds on the road to full AKC recognition.
- E. United Kennel Club (UKC) registration as one of the recognized breeds.
- F. If the dog has none of the above registrations, ASFA will provide a unique entry number for a one-time \$10 charge.

- 1. The owner must complete an ASFA Lure Chasing Instinct Registration form (LCI Registration) for a unique entry number.
- 2. The Trial Secretary will submit a copy of the form with the records.
- 3. The owner will retain a copy as proof of request and payment until permanent number is provided by the ASFA Records Coordinator.

Section 2. The owner or agent entering a dog in a lure field trial does so at his own risk. The owner or agent and licensed club agree to abide by the rules of the ASFA.

Section 3. Entry fees shall be fixed by the host club and shall be forfeited in such cases where dogs are scratched from the field except for one of the following causes.

- A. Dogs determined to be lame at the time of roll call shall be barred from competition and their entry fees shall be refunded.
- B. Bitches in season, or bitches showing a discharge characteristic of being in season, or which come in season after the close of entries, shall be excepted from

this rule and their entry fees shall be refunded. Notification to the Field Trial Secretary of bitches in season must be made before or during the roll call. Bitches known to be in season should not be brought onto the trial grounds and shall be removed if discovered to have come into season.

C. Dogs that have been disqualified for aggression by another organization. Fees will be refunded only if the owner or agent notifies the Field Trial Secretary of such ineligibility prior to or during roll call.

Section 4. To compete, dogs must:

- A. Be a minimum of 12 months old on the day of the trial.
- B. Be physically fit for competition. Blindness, lameness and amputation are considered as being unfit.
- C. May be spayed, neutered or intact.
- D. Females must not be in heat/season.

PET VACCINATIONS

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Rabies vaccination should be current, as required for the state you live in.

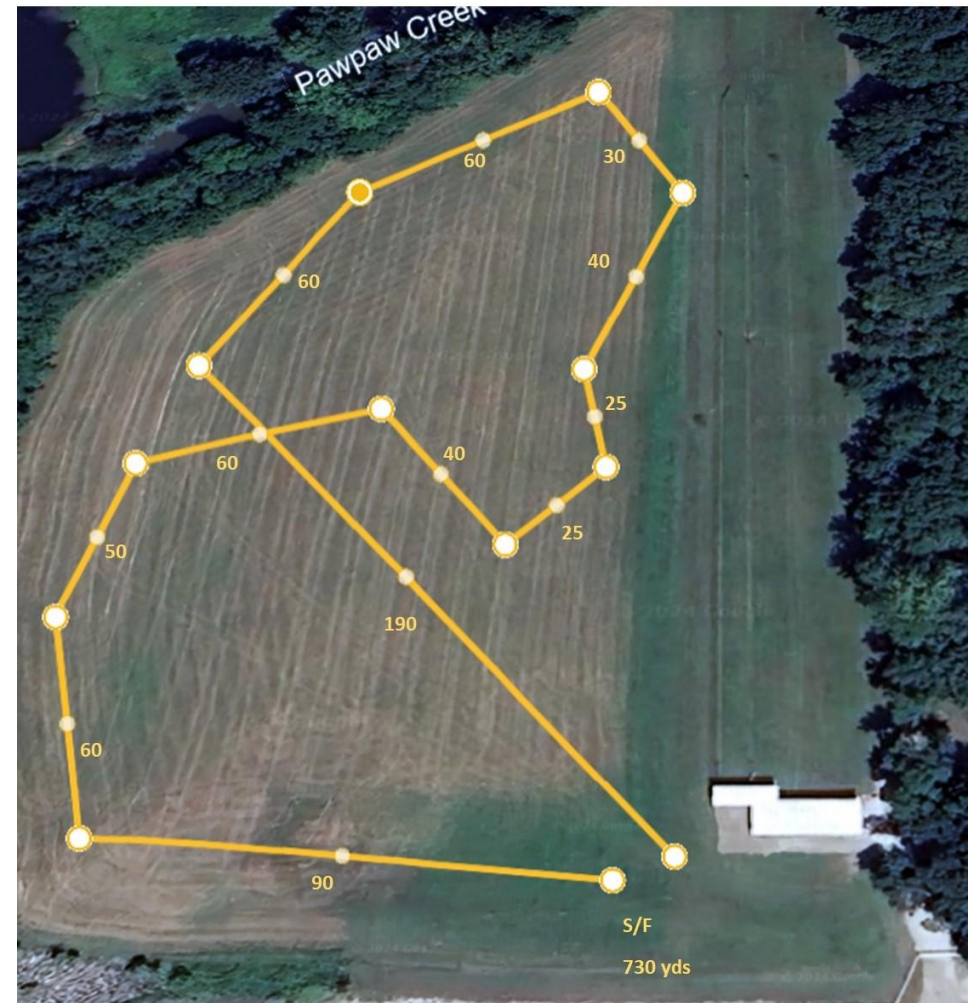
