

FROM THE SOUTH

- 1. From I-25 North, take exit 135 Academy Blvd
- 2. North on Academy 5.8 miles to East Platte Ave
- 3. Right on E. Platte 3.7 miles to Hwy 94 (direction Shriever AFB)
- 4. Right on Hwy 94 7.5 miles to Curtis Road (2nd light on Hwy 94)
- 5. Left on Curtis Road 1.9 miles to mailbox 2115 and Zoiboyz Ranch on right—it is the house surrounded by white fence on the hill. (Ignore the small house in front near Curtis Road. You've gone too far north on Curtis if you come to Falcon Hwy and a blinking red traffic signal.)

FROM THE NORTH

- 1. From 1-25 South, take exit 153 Interquest Parkway/Hwy 83
- 2. Go on Hwy 83 to South Powers Blvd
- 3. Turn right on South Powers Blvd
- 4. Stay on Powers to Woodmen Road Exit
- 5. Go left (east) ~12 miles on Woodmen to its end at Hwy 24
- 6. Go right on Hwy 24 0.5 miles to Meridian
- 7. Go left on Meridian to STOP sign at Falcon Hwy
- 8. Turn left onto Falcon Hwy ~3 miles to flashing yellow (Curtis Rd)
- 9. Turn right (south) onto Curtis Road for 4.4 miles to mailbox 2115.
- 10. Turn left to Zoiboyz Ranch (NOTE: This will be the 2nd driveway on left after Davis Road. Ignore small house near Curtis Road; go on up the hill to the house surrounded by white fence. You've gone too far down Curtis if you come to Hwy 94 and a traffic signal)

ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis, and Whippets. Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry. All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

ENTRIES WILL NOT BE ACKNOWLEDGED BY MAIL OR TELEPHONE. LATE, INCOMPLETE, UNSIGNED OR CONDITIONAL ENTRIES WILL NOT BE ACCEPTED.

REGULAR STAKES OFFERED:

OPEN - Any eligible sighthound, excluding ASFA Field Champions of record that has met ASFA Certification requirements.

FIELD CHAMPION - Any ASFA Field Champion

<u>VETERAN</u> - Any eligible sighthound which is 6 years or older on the day of the trial, except Irish
Wolfhounds whose age shall be at least 5 years; and Afghans, Rhodesian Ridgebacks, Salukis
and Whippets whose age shalle at least 7 years of age and has met ASFA certification requirements.
Points go toward V-FCh and V-LCM titles.

SINGLE STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone.
Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

<u>LIMITED</u> - Any eligible sighthound of an eligible Limited stake that has met certification requirements. Not eligible for Best of Breed or Best in field.

BEST IN FIELD WILL NOT BE OFFERED

GENERAL INFORMATION PLEASE READ CAREFULLY ALL HANDLERS MUST BE PRESENT FOR ROLL CALL INSPECTION AND ANNOUNCEMENTS

Any dog not present 5 minutes after roll call will be considered absent.

All dogs will be inspected prior to roll call

- The Zoiboyz property is being provided for the purposes of this trial. Please pickup after your dogs, respect property, and do not litter.
- There will be 1 port-o-pot on the field.
- Weather in Colorado is unpredictable from very hot temperatures to snow bring rain gear, layers of
 clothing, hat, gloves, sunglasses, and sunscreen. It is often windy bring stakes for your shade cloths
 and canopies. There is NO shade on the field. Bring shade and lots of water for your dogs there is
 NO hose or hookup for water available at the field site. Some first aid supplies will be available at the
 field; however, you should be advised to bring your own first aid kit for your dog.
- No fires allowed! If you must smoke, please do so inside of your vehicle; conditions are quite dry and even an errant cigarette ash could spark a fire.

FIELD AND EQUIPMENT INFORMATION

Terrain is mowed field grass with uneven ground. There is possibility of goatheads and cactus. Elevation of the course site is about 6800 feet and course layouts include up and downhill slopes. The perimeter of the property is fully fenced. RMCC recommends that your hounds be in good physical condition before attempting the course.">RMCC will use a battery-powered, continuous loop machine. The lure will consist of white plastic bags.

A \$20.00 fee will be assessed for any returned checks.

Persons exhibiting conduct detrimental to ASFA/RMCC/any dog(s)/other person(s) will be asked to leave the trial site AND appropriate disciplinary action will be filed- please conduct yourselves accordingly.



Practices will be held <u>AFTER</u> the RMCC trial <u>WEATHER AND</u> <u>MACHINERY PERMITTING</u>

All hounds will be inspected before running. Lame hounds and bitches in season may NOT run.

Certification: Any entry marked "First ASFA Point Trial" Must have an ASFA Hound Certification form and a copy of the hound's registration papers, not required for NGA greyhounds, and must present them to the Field Trial Secretary along with your entry before entering a regular ASFA trial. This applies to "First ASFA point trial" hounds entered in the OPEN, VETERAN or LIMITED stake. Certification forms will be available, but MUST be completed prior to judging. Also have your hound's registration number available for the Certification Form.

Certification: \$7.00, Owners wishing to certify a hound for competition are responsible for arranging a hound of the same breed, or similar running style, to run with his/her dog for the certification.

Practices: \$5.00 each dog

Plan on arriving to the field around 12:00pm; arrive earlier if you wish to see the competition. Practices and Certs will not be run earlier than 12:00pm, but may be held much later depending upon the entry in the trial.
