

### Directions to the grounds:

By kind permission of Hal and Linda Barry, this trial will be held at Bear Creek Farm in Moreland, Georgia, approximately 50 miles south of Atlanta. The address of the Farm is 1539 Bear Creek Road, Moreland, GA 30259.

**From I-85 South or North:** Take Exit 41, then go north on Hwy 29 toward Newnan (a right turn off the ramp if coming from I-85 South; a left turn off the ramp if coming from I-85 North). Go .3 mile on Hwy 29, and just past the Howard Johnson motel, turn right onto Hwy 16. Go .6 mile on Hwy 16 and turn right onto Gordon Road. Go 5.4 miles on Gordon Road and come to a stop sign at Hwy 54. Turn right onto Hwy 54 and go .8 mile on Hwy 54 until you see Bear Creek Road on the left. Turn left onto Bear Creek Road, go 3.4 miles, and the field will be on the left.

Please enter the field only at the designated gate. Parking is to be along the fence line only, in one or two rows.

**From I-75 North:** Take Exit 205 and turn left onto Hwy 16, heading west toward Griffin. Go 35.3 miles on Hwy 16, then turn left onto Hwy 54. Go 6 miles on Hwy 54 and turn left onto Bear Creek Road. Go 3.4 miles on Bear Creek Road, and the field will be on the left.

Please enter the field only at the designated gate. Parking is to be along the fence line only, in one or two rows.

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, and Whippets may be entered in the regular stakes.

Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande). These breeds must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the NCC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for Greyhounds registered with the NGA.

**Stakes Offered**

**OPEN:** Any eligible Sighthound that has met certification requirements excluding ASFA Field Champions of record.

**FIELD CHAMPION:** Any ASFA Field Champion.

**VETERAN:** Any eligible Sighthound that has met certification requirements and whose age exceeds six years, except Irish Wolfhounds whose age exceeds five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis and Whippets whose age exceeds seven years.

**SINGLES:** Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

*Note: Owners of hounds that have not previously run in practice courses are encouraged to enter their hound in the Singles stake.*

**LIMITED:** Any eligible Limited stake Sighthound that has met hound certification requirements. The winner of this stake is not eligible to compete in Best of Breed or Best in Field courses.

**Best in Field will not be offered. Best in Event will be offered.**

**NOTICE: All breeds will be run in braces if possible, or trios as necessary.**

All hounds must be one year of age or older on the day of the trial.

Stakes will be split into flights if the entry in any one stake is 20 or more at the time of the draw.

Bitches in season, hounds with breed disqualifications, and lame hounds will be excused.

Hounds not present at the time of roll call will be scratched.

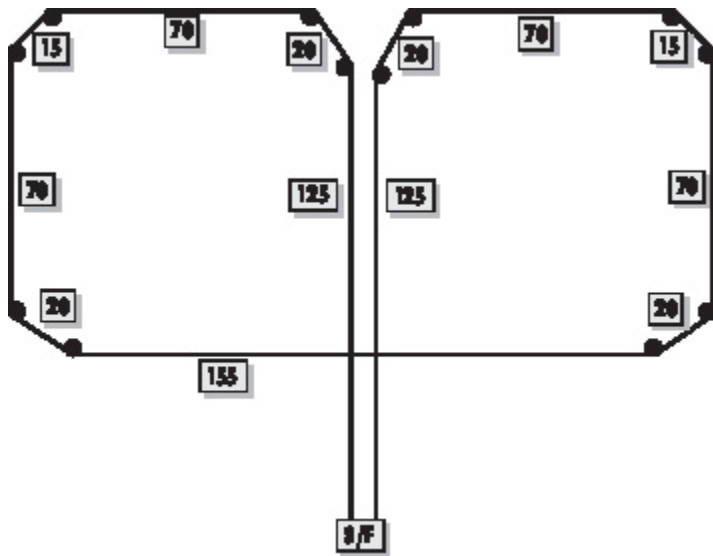
Certifications and practice will be offered at the lunch break on Sunday, time, weather, equipment, and personnel permitting.

Battery-powered drag lure machines with back-up equipment will be used. The lure will consist of highly visible plastic strips and may contain fur.

The course will be reversed for final courses, reversed again for any run-offs, and reversed again for Best of Breed.

The Club reserves the right to alter the course and/or the lure delivery system as required by weather, field conditions, or equipment on the day of the trial.

All owners must keep their hounds under control at all times, and must clean up after them. There will be a \$5 fine assessed for any loose hound on the field not taking part in a course in progress. There will be a \$15 fine assessed for any owner who does not clean up after his/her hound.
