The Field:

The field is on private property with restroom, water and shade available. Please make sure to clean up after your hounds.

Directions from South and West:

Take I-255 north to IL-143 turn right onto IL-143. Go @ 5 miles to second stoplight. Turn left onto IL-159. Go @ 5 miles to first stoplight at IL-140. Continue straight on IL-159 for 4.1 miles to Renken Rd on right. There is an intersection warning sign just before Renken Rd along with a sign that indicates "Prairietown." Turn right onto Renken Road for 2.7 miles through the small town of Pairietown until you see Prairie Inn tavern on right. Turn left here onto Prairietown Rd. Go 2.3 miles to Rosewood Farms on your left.

Directions from North:

From I-55, turn right at Exit 41 (Staunton) which is Main St. Travel thru town to Stop Sign at Duda Ace Hardware (IL Rt 4, unmarked) and turn left. Follow to south side of town to Renken Road at Tri Ford. Turn right onto Renken Rd and go 7 miles to Prairietown. Turn right onto Prairietown Rd (there is Prairie Inn tavern on your left).

Directions from East:

Take I-70 West to I-55 North. Take I-55 north to Il Rt 4 and turn left to Staunton. Then follow above "Directions from North."

All entries in the regular stakes shall be individually registered with AKC (including PAL and ILP), FCI, an ASFA-recognized foreign or ASFA Board approved registry.

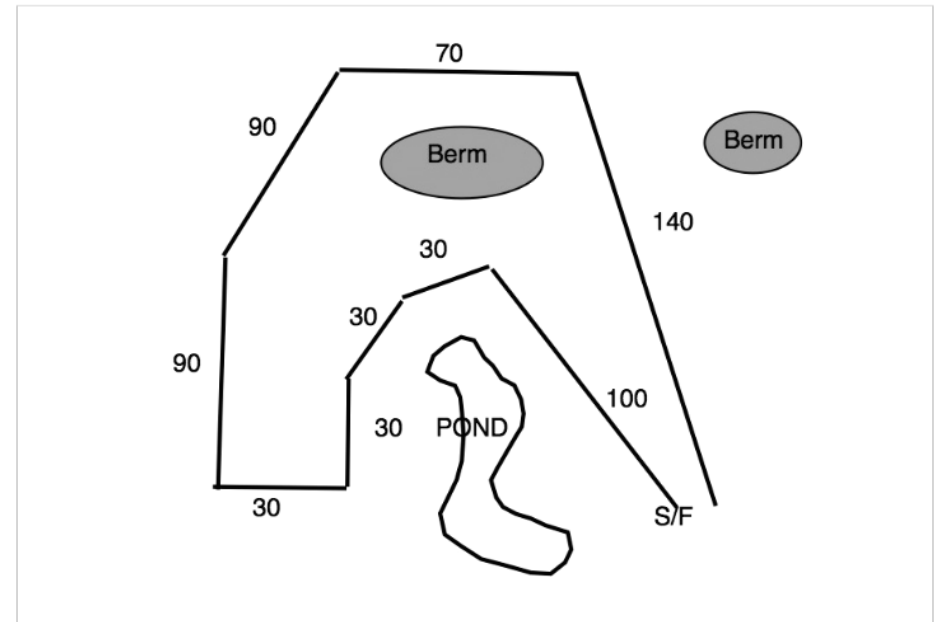
Stakes Offered

OPEN: Any eligible Irish Wolfhound that has met certification requirements, excluding ASFA Field Champions of Record.

FIELD CHAMPION: Any Irish Wolfhound ASFA Field Champion

VETERAN: Any eligible Irish Wolfhound that has met certification requirements that is at least 6 years of age.

SINGLE: Any eligible Irish Wolfhound including those disqualified to run in other stakes. Not eligible to run for Best of Breed.



Course Plan - 610 Yards - Drag Lure

SLASH reserves the right to alter course plan due to weather or field conditions. A battery-operated drag lure will be used with highly-visible plastic strips. Diagram approximate to scale. Course will be reversed for finals and again for run-offs and Best of Breed.



- 🐰 Stakes will be split into flights by public random draw if entry in any regular stake is 20 or more.

The End of an Era

The lure coursing trial, held in conjunction with Locust Grove, began with an idea and with the approval of Bob and Gretchen Bernardi in 1998. St Louis Area Sighthounds had been a local ASFA Club that traditionally drew large numbers of Irish Wolfhounds to their all-breed coursing trials. The very first Locust Grove ASFA trial was held in the front field of the Berwyck estate and was judged by Marie Adams. It was a dreary day but the conformation judge from the day before, Rosemary Wortman, braved the rain to stand in the field with Marie to observe the coursing. We were able to continue to use that field for a couple years until it became necessary to move to Tri-Township Park, Troy, Illinois. At that point, LGRA racing was added to the Locust Grove performance events. More recently, these events have been held at the beautiful Rosewood Farms in Dorsey.

This ASFA Lure Coursing trial will be the eighteenth and last Irish Wolfhound Locust Grove trial. In 2016 the Locust Grove Match will be a two-day event, counting as the Forty-Ninth and Fiftieth and the final Locust Grove Matches.

I am sure we all have fond memories of the joy we have had throughout these years watching our beautiful hounds have fun in the field. Thanks to everyone who entered hounds and to all those who helped with these events. And a special thanks to our noble hounds for adding so much to enrich our lives!
