Only purebred Afghans Hounds, Azawakhs, Basenjis, Borzois, Cimechi dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, Whippets and Provisional Breeds, if any, may be entered in the regular stakes. Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Espanol, Magyar Agars, Peruvian Inca Orchids, Portuguese Podengos (Pequeno), Protuguese Podengo (medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-

recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds

registered with the NGA.

#### STAKES OFFERED

Open Stake: Any eligible sighthound, excluding ASFA Field Champions of record.

Field Champion Stake: Any ASFA Field Champion of record.

Veteran Stake: Any eligible hound whose age is at least six years, except Irish Wolfhounds, whose age shall be at least five years, and Afghan Hounds, Ridgebacks, Salukis and Whippets, whose age shall be at least seven years. Points go toward V-FCH or V-LCM titles.

Limited Stake: Any eliqible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

Single Stake: Any eligible sighthound including those disgualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

#### **CONDITIONS OF ENTRY**

All entries must be one year or older on the day of the trial.

Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or

Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll

Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.

Hounds with breed disqualifications are not eligible to enter except in the Single Stake.

Hounds not present at the time of roll call will be scratched.

All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

Hound certification runs will be offered on Saturday only, following the trial, before practice and weather and equipment permitting.

There will be a five dollar fine assessed for any loose hound on the field not taking part in the course in progress.

There will be a \$25 charge added for any returned checks.

Owners must keep their hounds under control and clean up after them.

# BEST IN FIELD (BIF) will be offered both days. **PRACTICE**

Will be held after the Trial is finished, Saturday only, if weather, equipment and daylight permit. Practice is \$5 per dog. Priority will be given to sighthound breeds.




