

This is the 2<sup>nd</sup> oldest ASFA Perpetual Trophy.

In order to qualify a dog must run in both ASFA Events (Saturday and Sunday) The dog must be breed winner at least one of the 2 days. The dog will then be eligible to run for "Best of Event". The winner of the "Best of Event" will be awarded the Florida Classic Cup ("Lil Man" Perpetual Trophy)

Also eligible to run in the "Best of Event" is the previous years winner,

### **ELIGIBLE BREEDS & REGISTRY**

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Whippets, and Provisional breeds may be entered in the regular stakes. Current Provisional breed: Silken Windhound.

Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.






