NOTICE: EMAIL SPOOFING ALERT

Over the summer, there has been a noticeable increase in email spoofing attempts involving what appear to be messages from ASFA Board members. In reality, these emails are fraudulent, and the sender addresses are forged.

To clarify, email spoofing is the act of sending emails with a fake sender address. According to Wikipedia: "Email spoofing is the creation of email messages with a forged sender address. The term applies to emails purporting to be from an address which is not actually the sender's; mail sent in reply may bounce or be delivered to an unrelated party whose identity has been faked."

These spoofed messages often aim to create a sense of urgency or concern—suggesting, for example, that the sender is in danger, needs money, or requires immediate contact. If you receive such a message, here are some key steps to follow:

- **Verify the sender's email address carefully.** Look for subtle signs like unusual domains (e.g., "President.ASFA@email.com" note that "email.com" is not a valid ASFA domain) or small misspellings.
- **Do not reply to suspicious emails.** Instead, contact the alleged sender through a known, separate communication method.
- Do not send money or share personal information.
- Remain vigilant. These scams are becoming more sophisticated and often rely on impersonation tactics.

Please note: ASFA will **never** request payments through Venmo, and will only use PayPal through our official account for authorized transactions.

Stay alert, stay informed, and report any suspicious messages to the appropriate channels.

The FCI 2025 World Championship Lure Coursing

in Odry, the Czech Republic

The World Championship was held from the 21st to 25th of May 2025, on the huge grounds of the recreational area "Heipark", Tošovice in Odry, the Czech Republic.

Let's start with some statistics: 832 dogs were entered, spread over the 13 breeds of the FCI group 10 (Sighthounds), and 4 breeds from the FCI Group 5 (Spitz and primitive types: Pharaoh Hound, Ibizan Hound, Canary Hound, and Cirneco dell'Etna), and a further number of 125 reserve dogs from all breeds.

The dogs came from 23 countries, including one for the first time from Japan. The countries with the largest number of entrants were Germany (134), the Czech Republic (114), Switzerland (65), and Poland (61).

The breeds with the largest number of entrants were, Whippets: 177, Salukis: 118, Borzois: 80, and Italian Sighthounds: 80.

Individual dogs require a lure coursing license from their country of origin, with proof of competition free from any disqualification in a minimum of two events prior to the Championship. Each country is free to decide on any further qualifications they require for their own dogs to be entered in international events. The aim is to ensure that only the best dogs from each country take part.

There are two licenses: The FCI CACIL class license for dogs that have earned a minimum of two show results, and the Open Class, which does not require show results. There were a total of 647 CACIL licenses and 185 Open Class licenses entered.

All dogs receive a preliminary veterinary examination to prove they are fit enough to compete. After their first course, those dogs under two years of age and those over six get another veterinary exam before they are allowed to run their second course. During the entire event, random dogs are selected for doping control. https://www.fci.be/en/Doping-84.html

After a couple of weeks of fine weather, just days before the event started, the grounds were flooded with rain. The grand opening ceremony itself was literally drowned by a heavy storm. Luckily all the planned festivities were still able to be held spread over the following evenings, and from Friday the 23rd of May, it was dry with a cool breeze, ideal for the dogs.

The courses were run on three separate fields over four days. The wide, sloping grounds offered great space for challenging championship-worthy courses to be designed. The length of each course was the regulated maximum: for large breeds between 960 and 1000 meters [1,049.87–1,093.61 yards], and for the small breeds (Whippet, Italian Sighthound and Cirneco) 780-800 meters [853.018-874.891 yards]. On each course the natural sloping ground was included in the design - seen from outside the field not really appearing spectacular, but walking the ground itself that proved to be heavy going, which gave an excellent chance to judge the condition of the dogs. It was a pleasure and a privilege to be able to judge the dogs



here! Each course design contained one or more "technical" aspects in which the lure made several turns that required close attention and agility from the dogs.

The day before the trial each of the three course was inspected by four judges, the coursing director, and the FCI executive delegate for the event. After which, in principle, nothing in the course may be changed unless something appears to affect the safety of the dogs.

A drag lure is used (closed loop is not allowed by FCI regulations), which is restrung by an ATV. This takes time with a long and "technical" course, but on average, 10-14 courses can be run per hour.

Dogs run muzzled, in couples only; with sufficient numbers (4 or more dogs and 4 or more bitches) the sexes run separately, otherwise they run together.

Each dog is judged by 6 different judges from 6 different countries. This year, the judges used electronic tablets for the first time to transmit scores to the field secretary. This was quick and very easy. As a judge you have good oversight of the scores you have already given, the system automatically calculates results, and they are already with the secretary by the end of each class. Although heavy rain on the afternoon of Thursday the 22nd caused problems with the touchscreens, and that needs to be solved.

At the end of the day, a maximum of the 6 best dogs are placed in each class, dogs and bitches separated if they have been run separately. In principle, the best dog and bitch of each breed each earn the title World Champion 2025 in their class (CACIL or Open), the national flag is raised, and the national anthem is played. At the end of the prize ceremony, the dog with the highest score of the day is rewarded with the additional title of Best in Field.

The 3 fields were staffed by 3 different technical teams from the Czech Republic: NordCoursing Club, Field 1; Moravský Coursing, Field 2; and the Saluki Club, Field 3; using three very different drag lure machines.

In total around 200(!) volunteers were active over the whole period: from pulling campers, caravans and recreational vehicles out of the mud, to actually running the trials. The coursing director, Eva Jeník Dufková had assembled an excellent team!

The team leaders, and the judges (44), were on duty from 6 in the morning until 11 in the evening, and were constantly kept up to date by app notifications.

Prior to the first day of competition and at the end of each day, the FCI Executive delegate for the Championship, Willem Vermaut held meetings with all team leaders, as well as all judges, to keep them informed, to listen to their advice, and eventually make any improvements.

It is always a very special event to take part in!

You see many old familiar faces, both human and canine. There are always dogs from breeds you normally don't see much of, something which I very much enjoy.

Note on the FCI CACIL Certificate by Richard Hawkins

The FCI CACIL (a working title) stands for Certificat d'Aptitude au Championnat International de Lévriers, which translates to Certificate of Aptitude for the International Championship for Sighthounds. It is an award given in FCI (Fédération Cynologique Internationale) international lure coursing and racing events for sighthounds.

To achieve that, the dog is required to have earned a CACIB at an international show, CACIB (Certificat d'Aptitude au Championnat International de Beauté). The CACIB award is an international certificate for dogs from all breeds. Winners of the Intermediate, Open and Champion classes who have received an Excellent grade can compete for this award.

The Open Class in the FCI World Championship Lure Coursing is for dogs that have not earned a CACIB. In other words, allowing 'working' dogs as opposed to 'show' dogs to compete and win a title.






A MUSEUM THAT IS ALWAYS OPEN

At ACoDs held in "days of old," attending delegates would occasionally articulate pipe dreams about ASFA's maintaining a physical museum which would have exhibits chronicling the history of the sport of lure coursing and the ASFA Hall of Fame featuring those sighthounds and people who were inducted over the years. The conversations never really got beyond the dreaming stages, due to the expense of both creating and maintaining such a physical facility.

Well, the National Coursing Club of Great Britain (NCC) has solved those challenges for those who want to preserve the history of lure coursing and the collective memories of the great sighthounds and people who have brought the sport down through the decades to the present. On June 24 of this year, the NCC held a public launch of its new, two-years-in-themaking virtual Coursing Museum.

This groundbreaking museum is entirely online at www.thecoursingmuseum.com and offers literally hundreds of hours of viewing of all the art, photographs, trophies, statuary and video that comprise the centuries of history of the sport of coursing. And, unlike the physical facilities which house the traditional museums, the Coursing Museum never closes, there is no need to incur the expense of travel to visit the Museum, and admission is always free!

You need only "pop in" to the museum on your computer, tablet, or phone, and while away a rainy or snowy afternoon looking at coursing art or watching narrated videos of all the Waterloo Cup meetings held from 1984 to 1999. For those who have never had the opportunity to see hare coursing live and in person, the Waterloo Cup videos will give you a great appreciation for what the founders of lure coursing were trying to accomplish in creating what they called "a simulation of coursing."



The superb documentary film "The Last Waterloo Cup" is among the coursing films offered in the virtual Coursing Museum.



Full length narrated videos of multiple Waterloo Cup meetings are available for viewing.

The Coursing Museum was the brainchild of David Midwood, the Chairman of the NCC who also served as the Chairman of the Waterloo Cup Committee in its final years. As he articulated it, the goal of the Coursing Museum is to establish a complete history and chronicle of the sport, the Greyhounds who ran in it, and the people who preserved it in the face of numerous challenges. The NCC hired a young web designer, who spent hundreds of hours compiling content from a wide variety of sources and interviewed longtime coursing luminaries such as Sir Mark Prescott, Charles Blanning, David Midwood and Peter Sant, among many others. The oral histories they provided will provide a wonderful we-were-there chronicle of coursing and its traditions as a country sport, long after the last coursing enthusiast who actually stood on the great coursing fields of Great Britain are no longer living.

No field sport is more celebrated in art than is coursing, and all the paintings and statuary of the sport are in the Coursing Museum.

Readers can learn more from David Midwood and from coursing historian Charles Blanning about how the Coursing Museum was created and developed, by watching an interview of them on episode 50 of the Greyhound Nation podcast, available on YouTube at https://youtu.be/bP63CFGafDE?si=G6swXg5TaG9FUUNi or on any of the popular podcast apps.

The Coursing Museum is a wonderful resource, both for those who love sighthound sports and for those who seek a greater understanding and appreciation of the origins of lure coursing. – John Parker


The 2026 ACoD will be <u>virtual</u>

A (Predictably) Failed Experiment by John Parker

In 2022, three clubs – the Southeastern Greyhound Club (SEGC) of Region 7; the Silken Windhounds of California (SWC); and Racing and Coursing Enthusiasts (RACE) of Region 2 – joined in submitting a proposal to the ASFA Board of Directors. They requested the creation of an experimental program, as contemplated by the ASFA Constitution, by which host clubs would have the option to offer the brace elimination running format and the point tally scoring format at their regular ASFA trials. The proposal included letters of support from three longtime ASFA licensed judges who had judged at numerous lure trials featuring the brace elimination/point tally format. Also included in the proposal were letters of support from two longtime lure coursers who were not members of any of the three clubs but who had run their sighthounds frequently in the brace elimination/point tally format.

For those who are not familiar with the brace elimination running format, it is the oldest of all the (hare) coursing running formats. It has been employed in England and Ireland for centuries. When the sport of coursing first came to America in the 1800s, brace elimination is the format which was run. There can be no better testament to the legitimacy of the brace elimination format than its ability to identify the best running dogs of the day, which has been proven over centuries of sighthound coursing sport.

Over those centuries of coursing on both continents, literally millions of British pounds and millions of U.S. dollars have been wagered in coursing meetings run under the brace elimination format. Followers of sports on which there is wagering (which there is/was on coursing in England, Ireland and the U.S.) don't consistently wager lots of money on

competitions which they believe are flawed in determining the best dog (or horse) of the day. Those very pounds and dollars wagered on brace elimination are the most objective demonstration by a wide demographic of followers of the sport of coursing that brace elimination is a legitimate format for determining the best dogs of the day.

The brace elimination is unique in its simplicity – if you are familiar with tennis tournaments or basketball tournaments, then you are familiar with brace elimination in lure coursing. The "point tally" scoring format is objectivity itself: The two dogs in a course accumulate "first-to-each-turn" points as the course progresses. There are no subjective categories, no cross-course judging, and no "voodoo math" concepts like "average scores."

In making the joint proposal to the ASFA Board of Directors, the three clubs represented to the ASFA Board that if the experimental program proposal was approved, they would run all their lure trials as ASFA trials – this would have added 8 ASFA trials annually in Region 7 and 8 ASFA trials annually in Region 2. These numbers represented significant increases in trial numbers in two ASFA Regions which have experienced a particularly substantial decrease in the number of ASFA trials held there in the last ten years.

After the proposal for the brace elimination experimental program was made, the ASFA Board of Directors did not engage any of the three clubs in a discussion of the proposal. Instead, the Board formed an "Experimental Program Committee." That committee did not engage the proposing clubs, the ASFA licensed judges who endorsed the brace elimination experimental program proposal, or the exhibitors who had written letters of support about their experiences judging or running hounds in the brace elimination format, in any discussion about those experiences or the reasons that they had endorsed the brace elimination proposal.

Instead, the Experimental Program Committee, none of whose members had any experience in even watching brace elimination run in lure coursing, much less judging it or running their dogs in it, developed what it called the "Bracket Coursing Challenge" experimental program. This was a format and a program which no club proposed, no ASFA judge endorsed, and no exhibitor supported. No club had indicated that it was interested in running a "Bracket Coursing Challenge" lure trial. Neither

coursing meetings nor lure coursing trials had ever been run using the untested "bracket challenge."

Upon being informed of the "Bracket Coursing Challenge" experimental program and being given an opportunity to review the running/scoring rules of the program, all three proposing clubs quickly advised the ASFA Board that none of them would be running trials under the "Bracket Coursing Challenge" program, for the simple reason that it was decidedly not the tried-and-proven brace elimination running format and point tally scoring format. It was, instead, an impenetrably complicated running format with none of the elegant simplicity of the brace elimination running format or the judging objectivity of the point tally scoring format.

The proposing clubs also predicted to the ASFA Board that no club would run trials under the "Bracket Coursing Challenge" experimental program, for any number of the following reasons:

- (1) As noted, rather than being a brace elimination format, the "Bracket Coursing Challenge" as written was a nearly unfathomable and untested or unproven running format.
- (2) The "Bracket Coursing Challenge" was required to be run separately rather than alongside a regular ASFA trial either after the regular ASFA trial or on a different day. Few if any clubs have the worker capacity or field availability to do such a thing.
- (3) Breeds were not run separately, but run together, eliminating the head-to-head competition between dogs of the same breed, which is one of the attributes which makes brace elimination so exciting.
- (4) Regular ASFA points, titles and rankings could not be earned by dogs running in the "Bracket Coursing Challenge".

The Experimental Program Committee ignored the feedback and predictions from the three proposing clubs and pressed forward with presenting the "Bracket Coursing Challenge" to the ASFA Board of Directors in March 2023. The ASFA Board likewise sought no engagement with the three proposing clubs, the ASFA-licensed judges or the exhibitors who have endorsed and supported the brace elimination proposal, and approved the "Bracket Coursing Challenge" experimental

program. It was then presented to the 2023 ACoD that same weekend as a Board-approved program.

Fast forward to the 2024 ACoD, and it was reported by the Experimental Programs Committee that, as predicted, no clubs had expressed any interest in the "Bracket Coursing Challenge," and it was therefore being abandoned.

So, instead of having had 16 additional ASFA trials annually and the associated entries in two Regions in which ASFA trials are scarce that would have resulted from accepting the brace elimination experimental program proposal, ASFA saw 0 ASFA trials, 0 ASFA entries and 0 clubs running an ill-conceived experimental program which no club, no ASFA judges and no ASFA exhibitors had expressed an interest in. It will go down in ASFA history as one of the most colossal blunders ever made by the organization, and it ignored experienced clubs, judges, and exhibitors in doing so.

It is now beyond dispute that ASFA is continuing to lose "market share" of the lure coursing dollar to the AKC. AKC has the title-on-the-pedigree advantage to distinguish its lure coursing program from ASFA's lure coursing program, and thus the AKC attracts more exhibitors. ASFA has no "product" to distinguish its program from the AKC program. An optional brace elimination/point tally experimental program could have been a start at offering a lure coursing product that the AKC does not have. It was truly a shame that the ASFA Board of Directors served its constituency so poorly by missing an opportunity to demonstrate vision and forward-thinking while at the same time listening to its clubs, its judges and its exhibitors.

Records Search Committee

Report by Phil Fullam, Committee Chair

The response from our search activity has been underwhelming. However, we have identified an individual who has the skills, experience with ASFA, and time to work on the project. We are actively working with the individual to ensure they understand what needs to happen and identify likely problem areas.

A lot of work was done by Eddie Kominek, who laid a foundation for developing the program. He examined the current database and identified corrupt data that would prevent the new program from functioning. A basic architecture was developed for the programs.

A critical decision-point is coming up based on how much of the work already done can be used as we move forward. We are taking a methodical approach, trying to be sure that once ASFA executes a contract for the new program, it will move forward efficiently and with appropriate speed.

A key area of discussion for the committee continues to be how to monitor progress as the program is being developed. Oversight must be appropriate to the tasks. Too little oversight could result in lack of progress or worse, progress going in the wrong direction. Too much oversight can result in excessive reporting devoted to minutiae, rather than reporting on task completion.

We are optimistic that we will be able to submit a formal recommendation to the Board fairly soon.



Remembering Camille C Mendicino

Camille was born October 18th, 1943, and passed very peacefully on July 3rd, 2025, at the age of 81. She was married to Peter Mendicino for 53.5 years until his passing on November 2nd, 2018. Camille is survived by a son Peter Mendicino Jr and his wife Robyn; three grandsons, Ryan, Eric and Jason; and two great grandsons, Francis and Jaxon.



Camille and Pete started coursing with an Afghan Hound named "Shariff" that was the first of many field champions for "Campe Sighthounds". Over the many years from the '70s until about 2012, they had a couple of Pharaoh hounds (Mera & Seker), a Greyhound (Rooof), and a load of Whippets (Ashley, Poncho, Bullet, Knockers, Psyche, Dynk, Rage, Samantha, and Ripple).

Camille and Pete were very active in ASFA. Pete was an awesome lure operator, and Camille was an ASFA judge. She judged all over the country. They started a club in New Jersey by the name of Coastal Coursers, and brought that club with them when they relocated to the Maryland area.

The field they frequently used was nicknamed "The Wall" because the field literally went up on a very steep slope. It was hard work to walk up that slope for the people setting up the courses, but the dogs didn't mind it. Camille and Pete became active in the Upper Chesapeake Bay Saluki Club (UCBSC). They were instrumental in starting Tortoise & Hare Lure Coursing Club (T&HLC) and the Mason Dixon Ibizan Hound Club (MDIHC). Over the years, Camille held many positions in the clubs, including Field Trial Secretary.

Camille and Pete rarely missed an ACoD, and boy did we have fun at those! A group of us from Region 8 would attend together. We would go early and stay late. We would also get together for holiday meals, dinner after trials, and New Year's Eve celebrations, which required shopping for gag gifts to give out - and did we have a blast doing it. Camille was an awesome friend, judge, coach to newbies, and ASFA supporter. She will be missed by many of us.

Camille loved to shop, whether in a store or online. She lived by the motto that if you find something you really like - buy multiples, especially if it is available in different colors. She told me that the UPS delivery person knew her by name.

Camille was the ASFA Scheduling Chair from 1982 to 1983. She became the ASFA Records Coordinator in 1990, and worked with the first ASFA computer program. The program was built in dbase and there were no bells or whistles. But it got the job done at that time.

When it became too much for Camille to be at the computer for long periods, she wanted to step down, and ASFA posted that job. I was hired, and then the training with Camille began. One of the most important things she taught me was to treat everyone the same. I strive to do that with every trial that I process and every email I send.

Camille generally spoke with a calm reassuring voice. She was great with those who were thinking about becoming a judge, as well those who were experiencing coursing for the first time.

She was great at giving guidance. And she was well known on the field for getting a loose hound to return to its owner by belting out in a loud dominant voice: "You'd better get to your mother (father) right now". It was amazing how many times that scared the hound to actually returning to the owner, but also it could scare the people standing there.
