## Proposals and Motions

Debating and voting on the issues is a spirited part of the ACoD. The proposals and motions that come before the ACoD will either pass and become part of ASFA's future, or go down in defeat. The official results of these voting on the proposals and motions will be included in the ACoD Minutes, which will be posted on the ASFA website. Below is an unofficial summary. The ACoD voted to

- clarify the Huntmaster's role in the event of an entanglement in the string,
- post the new Code of Conduct both in the Running Rules and in a highly visible place at ASFA trials,
- define when a title is earned versus when a title becomes official,
- create additional Singles stakes,
- create a process to replace ACoD Committee members who are unable to serve,
- create an LCI Best in Variety run off,
- combine the ACoD Site Selection Committee and Planning Committees,
- remove the minimum participation number requirements for new breeds,
- rescind the 2022 ACoD's directive to adopt gender neutral language throughout ASFA's writings, and
- change the designation "Senior" as used in LCI to a word that is not-age related.



# A Brief Update on The ASFA Website

ASFA's new Records Program and Website Project are underway. Phase 1 is currently in progress. It will eventually replace the records database in which our dogs' results are tracked. Next, the record program that analyzes, summarizes, and reports the results will be located online, replacing the use of Microsoft Access database management system.


Because many people are using their phones, rather than their computers, to view information on websites, we have selected a best practices method called Mobile-First Design. In Mobile-First Design, web developers start the design process for the mobile screen, which has restrictions because of size and its touch screen, ensuring that proper function of the website is preserved in the mobile app. Once the functionality is worked out on a small screen it is easy to expand the design for the large screen of a desktop computer or laptop.

The website design is part of Phase 2 of ASFA's Records Program and Website Project.

This is a simple wireframe design to work out the site navigation and make sure that users will be able to find what they are looking for quickly and easily.

It is not meant to be attractive – just functional. This design is all about structure and flow. Colours and shapes will probably change.

A working prototype was presented to the board and delegates at the ACoD for discussion and comments. The images on this report are screenshots from that presentation.



*Above: Screenshot of the homepage (left) and homepage with the menu open (right).*


The prototype has two types of pages, referred to as “static” pages and “dynamic” pages. Static pages tend not to change very often. They include information or descriptions. The “Eligible Breeds” page and the “Running Rules” on the ASFA Website are examples of static pages. These pages are usually updated once a year.

Dynamic pages draw their content from records databases based on inquiries made by the user. Currently, there are no dynamic pages on the ASFA website.


Dynamic pages will be particularly useful to ASFA participants. For example, the new website will include dynamic account pages where owners can input dog information and request results for their dog. The program will do the work and return up-to-date results instantly. Presently an owner would submit a request to the records co-coordinator who would then create a report about the dog and email the report to the owner.

Using dynamic pages, an owner would need to input the dog's information into the system once only, for that information to become part of the ASFA database. The trial schedule will be paired with the dog's information to allow owners to make online entries. ASFA clubs will be able to link their PayPal accounts will be linked to the premium lists if they choose to use that feature.








Owner's account with a list of dogs

Other organizations use Owner accounts to keep track of dogs and their results. If you have ever done Barn hunt, this will look familiar.

Remember these are very early drafts and the look of the pages will change, but the basic functionality will be close to what you see here. This is a stage on the journey to modernize the ASFA website and make it easier for everyone to use.

These pages will become the locations that will display the information that users are looking for and be readable on your phone as long as you have cell service and a data plan.

## Bracket Challenge Lure Coursing *update*

The Bracket Challenge Lure Coursing experimental program was approved by the ASFA Board of Directors at the annual in-person meeting. A change was made to the name to specify that it is lure coursing by adding the word “Lure” into the title.

On Sunday of the ACoD, there was a detailed discussion of the program. Several changes were suggested. There was discussion that some owners of large hounds will not run with small hounds and vice versa. To address this problem, the committee started meeting immediately after the discussion, and agreed to the following new wording.

**Section 4.** There will be no separation according to breed. *When there are a minimum of 4 hounds of the following breeds: Basenji, Cirneco dell’Etna, Italian Greyhound, Peruvian Inca Orchid, Podengo Poqueno, Portuguese Podengo, Silken Windhound, they will be placed in their own bracket. If there are fewer than 4, the owner/agent of these hounds may either run in the standard bracket or may withdraw their hounds and receive a full refund of their entry fees.*

This question also came up: “Does a dismissal in the experimental program go against the hounds record?” It is believed that O-RCD16 should cover this. “A dismissal at a Fun Trial does not count against a hound as an official dismissal.” A motion will be made to the board to explicitly state it.

### JUDGES LICENSING REPORT – March 2023



## Understanding Lure Operating from the Sidelines

What does the lure operator do? Basically, they push a button which turns on a motor which pulls a string with trash bags attached (the lure) along the ground in front of the dogs fast enough to see it and chase it. But what are they really trying to accomplish?

The lure operator is there to give the dogs their best chance to have a good time with a great run. One lure operator describes it as dancing with dogs.

How can you learn to recognize what lure operator is doing? First, observe lure operation when your own dogs are *not* running. Watch the lure operation both for your own breed and for other breeds because running style varies from breed to breed.

There are three primary aspects to lure operating. The most important of these is safety. The lure operator is responsible for the safety of the dogs on the field. That overshadows anything else. The other two are of equal importance. The lure operator wants to give the judges something to judge and to allow the dogs to perform well - you might say – to allow the dogs look good.

Safety includes showing dogs the corners so that the dogs can make those athletic moves without risk of injury. The lure needs to be ahead of all dogs so that they don't risk running into each other.


Giving the judge something to judge and giving the dogs their best chance to have a good run are two sides of the same coin. The lure has to be within sight of the dogs and far enough away to be a challenge. Generally, that is 10 to 30 yards

ahead of the dogs as directed in the Running Rules. However, this distance can vary with the conditions on the field, the breed on the field, and the individual dog(s) on the field. Sometimes when dogs are center surfing, slowing the lure a little may draw them back out to the line, but at other times, it is successful to speed it up. Some dogs run better when the lure is far out in front of them. Some dogs run better when the lure is close enough, so they think they have a chance to catch it.

# When Rabbits Designed Lure Courses

**“ . . . how does one design a course plan to simulate a rabbit run? It is easy: 1. Use the longest possible initial straight; 2. Follow it by a series of turns (5 to 8); and 3. Follow those with another long straight to test endurance.”**

In the (good?) old days, back in 1972 or so, when lure coursing was started, most of the people involved had graduated from open field coursing and were running their dogs in both sports. Their actual hunting experience influenced both the early course plans and the judging. These people knew what was required of a dog in a successful rabbit course. They relied on that knowledge when it came to lure coursing; and they set out to design lure courses that would simulate live coursing, and test the same qualities in a dog that it would need for real hunting.

Then lure coursing spread to areas where coursing live game is illegal, or impractical; and people who have never seen a rabbit run by hounds took to designing course plans and judging. The similarity between lure and classic coursing diminished. In live coursing, the rabbit and the dogs design each course plan and, while each one will be slightly different, there are basic similarities that underlie all the courses. These are the things that early lure folks tried to design into their course plans which have been lost lately. This is a pity, because a properly designed course plan can simplify the judging, speed up the trial, decrease the number of reruns needed, and improve the dogs safety.

For folks who have never seen actual coursing, an explanation is in order. Anything can happen once the dogs are slipped; but more courses follow a fairly fixed pattern: the rabbit is given a head start and the dogs are slipped. With the exception of Salukis, the dogs sprinting off the start are going to show the most speed available to them. Their first goal in the course is to overcome the rabbit's lead. If they are not fast enough to do that, the rabbit will simply run away from them, and it wins. However, usually the dogs will manage to overtake the rabbit after a very long straight run (called the run up) in which they and the rabbit all get tired. The fastest dog will get close to the rabbit. At that point the rabbit will start a series of turns. Rabbits weigh less than dogs, so they can turn quicker than the dogs.

Each time the rabbit turns, it will gain ground on the dog closest to it. This gives the second and third dogs a chance to gain ground in the turn by cutting the corner. Passing in a turn like this is not going to help their score since it displays neither superior speed nor agility. In this part of the course, the rabbit will use a series of turns to test the dogs' agility (this is called working the rabbit).

There are rarely more than six or eight turns, during which the dogs and rabbits get even more tired. Then, one of two things will happen: either the rabbit will tire or make a mistake and be caught, or it will wear the dogs down enough so that it can safely try to run straight away from them once more. This is the final part of a course (generally called a tail chase). The dogs are determined not to give up, but may be too tired to force another turn; so you will see a tired rabbit leading some very tired dogs off into the distance. (Here is where Salukis are the exception, because at this point in a course they may start running their strongest, shift into high gear and look like they have decided to get serious. This is the part of the course where a talented Saluki will demonstrate its special skills. There are Salukis who just cruise through the early part of a course and then begin to sprint at this point.) It is in the last part of the course where endurance is tested, while exhausted dogs try to force one more turn on a tired rabbit.

For most breeds, speed is demonstrated and mostly judged during the run-up; agility is best demonstrated in the middle of the course while the dogs are working the rabbit; and endurance is displayed in the final tail chase. Why does this matter when it comes to designing plans for lure coursing? If there are a bunch of sharp turns right at the start of a course, the fastest dog may never have a chance to display its speed as it overruns the corners and loses the lead at each pulley. By the time it reaches a straightaway, where it could use its speed, it may have learned to hold back, waiting for the next turn. It may also be injured in the early turns, where stress fractures are likely. If the dogs have a straight run-up, and have a chance to blow off their early speed and intensity, they will be using less stress in the turns when they come to them and reduce their risk of injury. Dogs that have just been slipped are running very hot and their judgment is not the best. They will run straight through barbed wire fences at this point, while later in a course they would notice the hazard and handle it safely. The same applies to sharp turns, where some breeds of dogs can turn so strongly that they can fracture their own legs. It is not necessary. Given an initial run-up to let them demonstrate their maximum speed, the dogs are then running slower and more reasonably, and staying closer to the rabbit when the turns take place.

So, how does one design a course plan to simulate a rabbit run? It is easy:

- 1 Use the longest possible initial straight,
- 2 Follow by a series of turns (5-8), and
- 3 Follow those with another long straight to test endurance.

When the course is reversed, the finishing straight becomes the run up for the reversed direction and the preliminary run-up becomes the endurance straight.

Is there anything you need to know about the turns? For one thing, rabbits generally turn from 15 to 90 degrees from their old direction. In normal running they NEVER turn more than 90 degrees for a very good reason: it would take them toward the second or third place dogs who are, at the moment, cutting the corner to reach them. Rabbits are not stupid enough to run toward dogs. They never turn the 135 degree turns that are so dear to the heard of some lure operators. Why are lure operators so fond of them? It beats me. What such a turn does is break the stride of the lead dog and let the slower dogs cut to take over the lead. That makes the judge's life more complicated.

There are two foolproof ways to handicap and break the stride of a good, fast dog. One is to use turns in excess of 90 degrees, especially at the end of a long straight so the fastest dog is leading by a good distance. The second is to set a 90 degree turn close to the start so the fastest dog is flying off the corner while its slower or wise course mates are cutting to take the lead.

What happens when a hard running dog has its stride broken? When a dog has been running for a while, it is using the action of its stride to help it breathe. The expansion and contraction of the

stride assists the diaphragm muscles in forcing air in and out of the lungs. In order to do that, its breathing has to be in rhythm with its stride. When a dog is crunched in a corner and has to slow way down, turn, then accelerate again, its stride is slowed; and during that period, it is not going to be able to breathe as often or as deeply as when it was running straight. What happens is that its oxygen debt increases, and the dog feels like a marathoner who has, in their terms, “run into the wall”. The dog feels terrible and will not feel right again until it has gotten back into an extended stride and run for some distance. A dog coming out of such a corner looks like it is hurting, and it is. The real problem, though, is that the dogs who followed it into the corner had room to cut, ran a smooth turn, did not break stride, and will not only be in the lead but they will be feeling just fine. A really keen dog who gets hurt often enough by this kind of turn may learn to avoid the pain by holding back and not running full out, or it will watch for turns and practice cutting. Why should we punish the very dogs that we should be rewarding?

Difficult corners can make the judge’s job tough. If the judge knows what has happened to the lead dog and scores it high because it lost the lead to lure operation and course design, not to greater speed or agility, the judge may well award the course to a dog who as only led occasionally. Knowing when to do that is the judge’s job; but it is easier to judge a course that does not handicap the fastest dogs. A good course plan simplifies judging by making the best dogs apparent to all the watchers, not just the sophisticated ones.

One last word about turns: lure machines can zip the lure around a pulley without slowing it down at all so the lead dog has no warning of the turn. Rabbits, on the other hand, have something called inertia and momentum. They cannot change direction instantaneously. They have to slow up first. They have to change their ear and tail positions, which warns the dog of the coming turn and gives the dog a chance to start to slow down. The first warning a dog has of a lure turn is the moment the lure rounds the pulley. That is no warning at all. What can we do about that? Setting an extra pulley in a sharp corner helps. If we set two pulleys at a 90 degree turn, the dog can start to turn when the lure hits the first pulley.


Actually, a lot of corner problems could be solved by adding pulleys. You say that your club does not have enough pulleys to use two at a corner? The solution is easy. Decrease the total number of turns in the course. You don’t really need many to measure agility and follow.

The shape of a course plan can determine who wins when the dogs are running it, so there is a more serious reason to design course plans that resemble rabbit courses. The coursing breeds were created by being selected to successfully run their native game. If they start competing under other criteria and are selected for success under different conditions, then the breeds are going to change. I rather approve of what hundreds of years of coursing rabbits and other game have created in my own breed. I would hate to see it changed by people who did not understand the interrelationship between coursing hounds and their prey. These dogs were not designed by artists to romp with Icart models\*. They were created by selecting for coursing qualities which we can simulate in lure coursing if we take the time to obtain a good sized field and the care to design the course plan properly.

# Interview with Ernest Abresch



**Hi Ernie. Thank you for giving the Communique' this interview. You are a storied breeder of tremendously athletic Afghan Hounds. Let's begin at the beginning. How long have you had sighthounds:**

I got my first Afghan around 48 years ago. Mostly I've had Afghan Hounds, but also some Borzoi and Greyhounds.

**What are the main activities that you've done with your dogs?**

Hunting, open-field coursing, lure coursing, and oval track racing.

**How did you get started in hunting, and what drew you to Afghan hounds in particular?**

It was unlike anything that would happen today. One Saturday morning in 1971 on Ancon Hill in the Panama Canal Zone Michael O'Neill and I went out to slay the mighty capybara. With us we brought warriors untested, but eager to do battle: Saber, the German Shepherd, born in Dusseldorf to dubious parents; Cindy, the young Great Dane puppy, whose feet where as big as penny loafers; and Michael's Mishma Khan, the swift-footed, black Afghan Hound. No ribbons were awarded, no pictures were taken, no records were kept, but on that day on that hillside in Panama, a journey began. "Someday", I said to myself, "I will have an Afghan Hound".

**How did you get your first Afghan hound?**

Little did I know that a few years later, in 1975, I would be bringing an Afghan Hound of my own back to Panama. I was recuperating in Walter Reed Hospital from an Army injury that led to my medical discharge. As it happens, Michael O'Neill lived nearby, and he would pick me up on the weekends. He also happened to know Wally Pede.\*

Nothing happens by accident. One night Wally invited Mike and me to dinner. Before sitting down to eat he introduced his hound. Out came a big black-and-tan Afghan "Native Dancer". I suppose to this day that's why black-and-tan are my favorite markings. First impressions are difficult to forget.

Dinner was served. Talks were held. And Wally agreed to send me a puppy once I got back to Panama. Wally was sharp, to the point, and not easily fooled. He must have seen something in me. He was not wrong from my first Afghan "Fleetwood" to now. Fleetwood became a family member, my mom even cooked for him.

### How did you get into dog activities in the United States?

I moved to California and got an Afghan named "Jazz" *Jazz Dancer of Sheherezade LCM* from Wally Pede. Jazz was a good boy and good runner. Mike O'Neill had a Sheherezade Afghan named "Amber" *Amberfax of Synergon*. We would hunt with Jazz and Amber around Chino, California. We hunted in the desert and ran rabbits whenever we could. Other animals can pop up. Mike had to rescue the dogs once they went after a herd of wild boar – very dangerous. And once, when a bobcat popped up, Jazz gave chase, turned the bobcat and they got into a fight.

### How did you get involved in open field coursing?

We discovered open field coursing in Merced, California. Merced was the Mecca for NOFCA open field coursing. We went to every hunt around Merced, and we also traveled to open field hunts to the Mohave Dessert, New Mexico, and Wyoming for white tails.

### How were your Afghans as hunters?



Our Sheherezade Afghans were enthusiastic hunters, but they were slow. They had the heads for it and the hearts. They were very determined. Sometimes in open field coursing when our Afghans would run with a Greyhound, they would go to the left or the right – as hunters do, and you could tell that the Greyhound expected a little help from them. But they could not help. They were too slow. In all those years of open field coursing, they were eliminated after the preliminary course. They never made it to the final. I decided I wanted an Afghan fast enough to run up on a rabbit and hang in with the Greyhounds, good Whippets and Salukis. Afghans may not be fast enough to beat those breeds, but they should be able to hang in with them.

They were fast enough to catch up to a deer. Once when they caught up to a deer, the deer jumped a fence to get away, then it ran to a lake and swam away. Someone in a boat on the lake later reported he saw a deer swim past his boat with two dogs swimming in pursuit. The deer got away. I would love to have seen that. I was always looking for faster Afghans. I wanted the best.

### Did you do any lure coursing back then?

Jazz was a good lure courser. I did a lot of lure coursing with Jazz and his sons, "Nemi" and "Flaco". One year I drove from Santa Barbara to Pennsylvania in my tiny Vega to run Jazz and his boys. Then after the Pennsylvania trials I went to Hershey and ate and ate chocolate. That year I crisscrossed the USA in my Vega looking for trials, running my three Afghan boys, and visiting interesting places. Jazz earned his LCM. We camped, stayed with friends, or stayed in motels. That was probably one of the most exciting times of my life. No cell phone and few planned destinations. Mike's Amber was also a very good lure courser. In addition to the open field coursing NOFCA Afghan Cup that she won in 1981 and 1982, Amber won the California Coursing Trophy in 1984 and 1985, and in 1983, the Afghan Hound Club of America National Specialty Best of Breed, where she defeated more than 40 Afghans.

My first star lure courser was "Koyanni" *Koyaanisquatsi of Synergon LCM*. Although she was not super-fast, Koyanni was a beautiful runner. With her, I flew around the country to trials. Koyanni won Best in Event at the Grand National, BOB at the II in Texas, and she could have won BOB at the Afghan Hound National Specialty if only I had pulled our Open dog, "Takhta" *Takhta Pul Dune von Synergon LCM*.

Takhta was an excellent lure courser. In 1989, he was the #4 ASFA Afghan Hound with 129 dogs defeated, 7 BOBs, and 1 BIF. He was the product of our breeding to a strong, sound dog named "Topper" *Oranje Topper Of Bhagendd*. Topper had European oval track racers behind him, which is probably why Takhta, his siblings, and his offspring were faster than our other dogs. Takhta's litter sister Gesserit *Bene Gesserit of Synergion LCM* was one of our best lure courses. In 1989, Gesserit was the #2 Afghan Hound with 178 dogs defeated and 8 BOBs.

I met some really nice folks in those years. It was an impressive group of people who really knew their craft. Les Pekarski was a standout. He was great fun, a tremendous asset for the sport, and a very good judge. Everyone who knew him has a Les Pakarski story. This is mine: Les and I agreed to meet in Texas and run our Afghans together at a trial near Houston. At that time, Les had a half-brother of Takhta named "Pal" and another Afghan named "Mindbender". I flew into Houston from California with Koyanni. Les was supposed to pick us up at the airport and drive to the trial. But Les didn't show up. Koyanni and I hitched a ride to the field for the trials and had a great weekend. Les called me a few days after I got home and asked if I was ready to fly to Houston for the trials. He had mixed up the dates.

### **You've bred Afghan Hounds over the years under the Synergion. Why the name Synergion?**

Michael came up with the name Synergion, which contains the idea of "working together". He envisioned hunting with birds of prey.

### **Were there many other Afghans participating in open field and lure coursing in California in the early years?**


A lot of Afghans were lure coursing, but none except ours were open field coursing. I was head of an Afghan Hound club, and to increase interest in open field coursing, I would go to dog shows and do everything I could to encourage the Afghan Hound show people to come and watch or try open field coursing.

At one of those shows Bruce and Rosemary Sutton introduced me to a visiting European weightlifter, who it turned out, also was very involved in the oval track racing with Afghans in the Netherlands. He came out and watched our Afghans run open field. He was impressed by how well our dogs ran, but he said they were slow compared to the racers in Europe. After he returned to Europe we continued communicating.

Then, in 1988 Michael imported a puppy from European oval track racing lines. She was called "Wrist Rocket" *D Wrist Rocket Synergion El Buzkashi (Mohahazy Haradin Hamadshan x Chota El Buzkashi)*. Wrist Rocket was fast. Her offspring were fast enough to turn jacks. It was a major leap in our breeding program.

Two of Wrist Rocket's offspring were extraordinary hunters: "Lippy" *Najonas Lipskein of Synergion*; and "Tully" *Turbo Flippers Of Synergion (Takhta x Wrist Rocket)*. They earned open field coursing CC (Coursing Champion) and CM (Courser of Merit) titles, which is difficult for an Afghan Hound. We also tried to lure course Lippy and Tully. But neither of them showed any interest in the lure coursing.

My last dog from those years was “Zoom Zoom” *Zoom Zoom of Synergon*. When she died in my arms, I thought that I was done with Afghans forever.

### **How were you able to revive your dream of finding faster Afghan Hounds?**

I did a lot of reading and developed contacts with European racing Afghan breeders. I became very interested in European racing dogs. I had seen professional Greyhound races, but there wasn't LGRA or NOTRA racing around me.

I decided. “Someday”, I said to myself, “I will go to Europe and watch the Afghan Hound races”. I eventually got to Europe. I watched the World Racing Championships. There were a lot of Afghans competing. I gained new information about speed from watching them race.

I was hooked.

### **How did you get European racing Afghans?**

Through an unusual set of circumstances in 2008-2009, I received a world class pair of retired racers. They were bred in the Netherlands by the van de Bremmen kennel. They came to me from Bea Sakers. The female, “Vuri” *Vuri-Durran van de Bremmen*, was the 2006 European Racing Championship winner, who set multiple track records. The male, “Xoran” *Xandramani van de Bremmen*, was the 2008 European Racing Champion.



I need to emphasize that these incredible dogs fell into my lap. These great dogs were the product of generations of careful breeding. I stand on the shoulders of great breeders that have gone before. Great runners are not born in a vacuum. I was fortunate enough that Bea Sakers believed in me and allowed me to carry forward the legacy of these two great hounds.

**Were the European Racing Afghans What you had hoped for?** In a word: Yes. I kept the male “Xoran” and I offered the female “Vuri” to Michael. Eventually we bred them, and they produced what turned out to be one of the greatest Afghan running litters. Michael and I kept three of the offspring; the two females “Kepi” and “Habbi”; and one male “Junior”.

Two of the boys, “Hakim” and “Hurricane”, went back to Europe. Hakim went on to win the World Oval Track Racing Championship twice, and the European Racing Championship once. Hurricane came in second at the World Oval Championship, behind his brother Hakim. I took Kepi to Europe to race at the 2014 World Oval Track Championship in Tampere, Finland, which she went on to win. In the United States, Kepi won Best In Event at the Afghan Hound Club of America National Specialty in 2013. She was also the Highest Scoring Open Field Coursing Afghan. Habbi also won Best in Event at the Afghan Hound Club of America National Specialty. Junior went on to sire of some of the top lure coursing and racing Afghans in the USA.

It is fascinating that the Europeans who breed for racing produced great athletes in lure coursing and open field coursing. I believe that the qualities that the European racing breeders select for are among the qualities that would have been desirable in the country of origin (COO). So, they have been actually preserving qualities that Afghans had in their COO. The European racing Afghans also morphologically resemble the COO hounds.

### **Why did you decide to get a COO Afghan Hound?**

I never envisioned breeding Afghan Hounds to totally to preserve the past. That is theirs - their world, their needs. The Afghan Hounds of the past represented years and years of successful selection that adapted to their needs and conditions. They were as perfect as perfect can be when they began arriving on Western shores.

Time eventually changes all. I have always admired the COO Afghan hounds and knew someday I would get one, not necessarily to preserve them, but to draw on their unique qualities. I have had no regrets about some of the past Afghans we bred, such as the Sheherezade hounds and currently the Van de Bremmens. They are part of the journey.


As good as the European racers are, I've held on to the thought that Afghans in the COO would have other fine qualities that even the best racing dogs have lost. That is because to run game successfully, you must run game successfully for generation after generation. No hounds outside of the COO have done this. It doesn't take many generations to lose desirable qualities. Lure coursing and racing preserve some but not all of those desirable qualities.

### **Tell us about your COO Afghan Hound**

For countless years it had been my dream to see an Afghan Hound from its native lands hunt on the soil of the American Southwest. With the help of my friend Ali Hasnain from Islamabad, Pakistan, this dream became a reality in 2021. Ali was able to locate a beautiful male with hunting experience among some tribal people. They graciously gifted Ali the male, who is now named "Kabul Kahn". Ali, in turn, graciously gifted Kabul Kahn to me. Kabul Khan had an extraordinary journey starting from Kunduz province in Afghanistan which borders Turkmenistan, to Islamabad via Kabul, Kandahar, Chaman (Pakistan), Quetta, Dera Ismail Khan, & Pindi Bhattian. From Quetta onwards he traveled in the trunk of a beat-up red Toyota Corolla! Kabul Kahn arrived in Islamabad, Pakistan on 9th January 2021. Kabul Kahn then rehabbed with Ali and his wife for 6 months before undertaking the 54 hour journey from Islamabad to Dallas-Fort Worth Airport where he was met by Michael and came to his new home with me in New Mexico.

Kabul Kahn was bred to Michael's girl "Luka" *Lazul Of Synergon*, which resulted in a litter of 7 puppies that were whelped on January 1, 2023. We are excited about their future.

### **How do you see the future of hunting and running sports?**

As much as I love open field coursing, I believe that lure coursing is the future. Open field coursing has been shrinking for decades. There are fewer fields, fewer jacks, an aging fancy, and many of the enthusiasts did not return after the pandemic. I don't see how it could grow, or even cease to shrink.

Lure coursing can be exciting. The three-day Grand National, for example, is a good challenge that is exciting and demanding. It is a class operation and Deann Britton and Connie Sullivan deserve credit for the continued success.

Over the years I have seen lure coursing trying less and less to mimic open field coursing. The two have always been different. It is only natural that lure coursing has grown into its own discipline. Yes, there are hints of an open field course. I think - not 100 percent sure - that when folks release their hounds they are thinking that they are chasing a hare or replicating it. I mean the lure has its own characteristic that elicits a different feeling. Ha - that in itself is rewarding enough.

Lure coursing is not just the dog. It is a relationship between the owner and dog, and the dog feels it. That's why I like to slip my own hounds if I can. I believe that unseen energy between the dog and owner can translate into the dog's performance on the course. Dogs thrive on knowing us, often better than we do them. Great trainers tend to be calm and have routines that make the hound comfortable. I think they function in tandem with the hound.

### **This is a long and continuing journey. Can you say something about your next steps?**

I want to thank everyone who has helped me along on this journey. I could not have done this alone.

I used to do all of this as much for myself as for the hounds. Now, I think I have what I want in them. So, I do it for them - because they like it. I don't know where this journey will go next or where it will end. Lately, I think that I got Kabul from Afghanistan, and perhaps that's it. But then, I remember that I was never really in control of it all. So, I enjoy the moment and let tomorrow take care of itself.

## Afghan **YOUSHA**

In 2008 Yousha won BOB at the AHCA (Afghan Hound Club of America) National Specialty ASFA Trial. She then went on to defeat the National Specialty AKC Trial BOB winner, taking 2008 AHCA National Specialty Best In Event. In 2009, Yousha went Best in the II. She was only the second Afghan Hound ever to win BII. That same year she earned her ASFA Field Championship. In 2010 Yousha again won the AHCA National Specialty Best in Event. This time she first won BOB in the AKC National Specialty field trial. She then went on to defeat the ASFA National Specialty BOB winner to take the 2010 AHCA National Specialty BIE. In 2010 Yousha also won BOB at the ASFA II, and she earned an AKC lure coursing field championship.

In 2013, after giving birth to her first litter, Yousha returned to the lure coursing field, going BOB and then Afghan Hound Breed Representative in the AKC NLCC (National Lure Coursing Championship). Over her career, Yousha went Best of Breed in every ASFA trial that she entered.

Yousha was whelped on January 4, 2007, in Germany. She was bred by Daniela and Wilfried Bormacher, whose "Paschdou" Afghan Hounds are prized throughout Europe. Yousha was imported to the US and owned by Sally Papin. Later Deborah and Maurice Bahm became co-owners. Yousha was not destined to become a show dog. She was well-balanced and beautifully structured, but her coat was highly "patterned", rather than long and dramatic, like the coats that are favored in the show ring.

Yousha won national racing events as well as lure coursing events. In 2008 she won both the LGRA and NOTRA National Race Meets. In addition to her lure coursing titles, Yousha earned LGRA GRC (Gazehound Racing Champion) and NOTRA ORC (Oval Racing Champion) titles.

Yousha was the Dam of 2 litters, whelped in December 2012 and March 2014. She produced good performance dogs, including multi Best in Field winning, Best in Region 5 winning, multiple II BOB winning "Tango" FC Debmar's Surrender to the Dance FCh, JOR, ORC, GRC, LCX, MC.

Yousha was sweet tempered. She got along with everyone. She had a huge prey drive, and a will to win. Those who were privileged to see Yousha lure course will remember the explosive speed combined with tremendous agility that set her apart. I believe that Yousha is worthy of a place in the ASFA Hall of Fame alongside the other great lure coursing Afghan Hounds. Yousha was NSBIE FC Paschdou's Yousha FCh, SC, GRC, ORC, BII, NSBIE.

Sailor LOVED to run . . . and run . . . AND run. He was a line runner! You may recognize his name for just that or perhaps you were one of the many who helped to capture him. I faked injuries, pretended to drive away, used an ATV, tasty foods, a muzzle, a flirt pole and more. Sometimes I could trap him in a crossover but when HE decided, he usually stopped in front of the lure operator or the huntmaster. At least he didn't run off the field. Sailor was from the first litter I bred. Two boys stood out. "You want a male that people don't have to look under to figure what they are", Laurie Soutar (Lakilanni Grehyounds) told me. So, I kept the more masculine boy. I never regretted that decision!!

Unlike many Ibizan males, Sailor was competitive at a year of age. He was a joy to watch on the field, exhibiting speed, agility and even follow. Sailor was #7 ASFA Lifetime Top 20 (87 BOBs, 8 BIFs). There were a few BIEs too, including the Grand Prix, twice the Winter challenge, and of course 2 Gillette Cup wins.

Sailor was a CKC, AKC and UKC show Champion with group wins/placements in CKC and UKC. He also coursed in AKC, CKC and UKC. He did straight and oval racing in Canada. He held his own in NOFCA including the mixed breed hunts. He was #17 on

the Top 20 in 2016 (age 11). He came out of retirement to run at the inaugural Canadian ASFA trial on May 27, 2017. He passed away at age 14.5.

Sailor extended his legacy through 2 litters with multi-titled offspring in several venues, who excel in coursing (2018 Gillette Cup winner, 2018 ASFA #1 Hound All Breeds, #11 Lifetime Top 20, several on the Ibizan Top 20 for multiple years).

## **VICKIE JACOBS**

Vickie began lure coursing in 1984. She was a founding member of Heartland Coursing Association (HCA) in Region 5. She worked at all of their trials every year until the pandemic, serving variously as Field Clerk, Field Trial Chair, Huntmaster and Judge. She was also the long-time ASFA delegate, the HCA Secretary, and she served several terms as President.

Vickie served as Field Trial Secretary for multiple Basenji Club of America National Specialty Field Trials. She was instrumental in getting the Show-Me Basenji Club to host ASFA field trials, and she served as Field Trial Secretary for most of their trials.

Vickie had a very successful breeding program under the kennel name “Cynosure”. She bred and owned at least 10 generations of ASFA titled dogs, beginning with her first Basenji LCM titles in the mid-1980s. She finished her last ASFA title in 2017 – after titling ASFA hounds for over 30 years.

Vicki had BIF dogs and many dogs in the Top Ten. Her dogs often won, first the Cynosure Cup, and then the Anubis Cup, which is awarded to BOB Basenji at the Region 5 Invitational. Vickie was the breeder and co-owner of the #1 ASFA lure coursing Basenji in 1997. She finished many dual champions and dogs with multiple working titles (AKC obedience and tracking, barn hunt, scent work). She always insisted that a well-rounded Basenji had a title on both ends! She trained, showed, and worked all of her dogs herself, with the occasional assistance of her husband, Russ, or friends.

In 1999 Vickie won the job of ASFA Membership Chair and held that position until about 2015 - ushering it into the electronic era. She chaired the ACoD Site Selection Committee and the ACoD Planning Committee. She became the ACoD Planner in 2007 and held that job until her death. In fact, she had planned the 2023 ACoD in Kansas City. ACoD Planner was a year-round job, with hotel selection and negotiation beginning at least two years before the ACoD. Vickie’s conventions seldom if ever lost money, and often they showed a profit. Vicki also served on other ASFA committees. She chaired the Advisory Committee on Animal Issues for over 20 years.

Vickie became an ASFA judge in about 2010. She judged many local and regional trials, national and regional breed specialties, and the International Invitational. Vicki also supported her local kennel club, the Lawrence Jayhawk Kennel Club, as President, Secretary, Chief Ring Steward, and Show Chair.

In 1975, Ping went to her first trial at Vale Vue in West Chester, Pennsylvania with her Borzoi. And as luck would have it, her Borzoi didn't run. Then in 1976, she got her first Whippet, and it was made clear that her Whippet wasn't a lure courser either. It wasn't until 1977 that Ping had Borzoi puppies that wanted to run. And so, it began.

In 1978 Ping became a Founding Member of the Tri-State Sighthound Club (TSSC) where she held positions as Treasurer and President, along with Chief Cook & Bottle Washer. In around 1981/1982 Ping got her first Whippets that wanted to run.

In the early 80's Ping's farm was the venue for one of the first International Invitationals. This was the first II to run 2 fields, which was a huge success and overall improvement for what is now ASFA's premiere event. Ping has since been a part of many International Invitationals, serving as Field Trial Secretary, Field Clerk, and anything else that was asked of her. Ping is always willing to help out in whatever way she can, and she does so with a smile. This love of lure coursing also called Ping to become a licensed ASFA Judge in 1985. Judging brought Ping all around the United States, and through judging her love and appreciation deepened, not only for the sport, but also for the ASFA organization.

In 2008, Ping's desire to "do more" brought her to the ASFA Board, where she was elected as Corresponding Secretary. Later she served as Recording Secretary, and then she was elected to the top honor of ASFA President. Ping has been very active on ASFA committees, not only as a committee member, but also as chair. Ping likes

to talk about the Constitutional Review (CRC) and Rules Evaluation (REC) Committees, which are two of her favorites.

Lastly, Ping is that wonderful kind of person that you can call on when help is needed. And she is always the life of the party. She gives her time freely and without judgment. And most important, Ping is always there to help a newcomer.

# Records 101

So, we now have been following the new protocol for trial submissions for a couple of years, the biggest problem continues to be missing FTE entries. For the most part it is because the owner did not mark the entry as such nor were the required copy of registration and certification (if required) attached. The USPS continues to be a problem. I will continue to rely on each FTS to question the owner of each unfamiliar entry. Also, please make sure you list an email that you check frequently in case I need to reach you. The longer it takes me to get needed info the longer it takes for results to be posted.

**I would like to say a big Thank You to all the FTS who have responded quickly to my email for information.**

Some suggestions:

- When making your roll call sheet if you have any unfamiliar entries, mark their name and have the person(s) doing roll call direct owner to see FTS to confirm that is not a FTE.
- If you have an FTE that did not bring all required information have them, email or fax directly to me. This will expedite your ability to submit the results instead of waiting for them.
- **I am requesting that you list the breed initials by the call name on the Single Record sheet. If one of entries is missing information, I now have a breed to search by.**
- If you plan to submit the results via email, please minimize the number of files you send and try to keep in the same order that you would always use to submit. Scan each day with required paperwork into a single PDF file.

- Please submit results as soon as you can. The quicker I have them the sooner I process and post results. Recently the USPS has been very slow.
- As always, please contact me should you have any question(s). Email is always the best way to reach me, but you can call me if you need an answer quickly. But if you do call, I typically do not pick up if I do not recognize the number so leave a message. I may be listening and will pick up immediately.

## **Exciting News**

- **Starting August 1 2023 as a trial, any club that submits their results electronically in the following format within 7 days from the last day of trial can reduce their per capita from \$4.00 to \$3.50 per entry for regular trials and Regionals from \$5.00 to \$4.50. The II is not included in this cost reduction.**

**Submitting electronic results - submit each day as one PDF file which should include:**

- **FTS report & per capita sheet**
- **Record sheets in the breed alphabetical order**
- **Any FTE with required paper or entries that are required to be submitted behind breed record sheet**
- **Any judge's sheets reflecting excusal, dismissal or disqualification behind record sheet**
- **A copy of premium is not required but is appreciated.**

**I learned about a free app (for Apple phone only sorry I am sure there has to be one for androids) for your phone that you can scan your paperwork into a PDF file to send to me if you don't have access to a scanner. It is called "Genius Scan". I LOVE electronic submission!**

## Records 101 (update 03/23)

### Daily Requirement

- A completed copy of the FTS Report (example included) completed in entirety.
- Per capita sheet for each day.

### Premiums

- An updated copy of the premium list is required only if there were any changes to the course plan or change to judge's panel. For changes to the judge's panel the Chair of Judge's must be notified of change and reason.
- Although it is not required a copy of premium is appreciated.

### Entries that must be submitted with your trial results

- Entries for all hound(s) that are marked as FTE (First Time Entry). This must be accompanied by proof of registration (examples AKC, UKC or CKC) (Waived for NGA registered hounds & proof of certification if entered in a regular stake. This includes the Single Stake and the LCI stakes in respect to requiring the certification. If proof of certification has been waived, a copy of the signed waiver and proof of the title must be included.
- Entry forms that indicate a change in the information (titles, address, etc). If the change is in ownership an updated copy of registration reflecting said change must be attached.
- Entry forms that reflect that said hound is working off a dismissal.

### Record Sheets

- All record sheets completed in entirety that includes the BIF sheet. All information needs to be legible and as accurate as possible.
- O-TRIALS15 When two judges are used, they shall be designated on the record sheet as Judge 1 and Judge 2, alphabetically by last name. This is for all judges whether Provisional or full judge.
- O-TRIALS04 The Field Clerk's name shall be indicated on each record sheet, but the Field Clerk's signature is not required.

- Per Ch V Sec 6 (g) hounds can no longer be left tied. There must be a runoff or a forfeit. The only tie that can stand is if it is the result of an error found during post trial review by the FTS which then a note must be attached explaining the problem.
- Any hound listed but did not run will need to have an acceptable reason (per the ASFA Running Rules) listed on the record sheet. If nothing is noted or it just says pulled, the hound will count for per capita. If an owner is unable to separate their hounds and decides to pull an entry there is no refund for this!
- On the Single sheet I would like the breed initials placed in the section with the call name. It is helpful to me if I have questions and am trying to search the database.

#### Per Capita Sheet

- There must be a sheet completed for each day.
- If you are paying the fee by Paypal send it to [treasurer@asfa.org](mailto:treasurer@asfa.org). Put Paypal transaction ID on allotted space. Otherwise the check should be submitted with the trial records or sent to me.

#### Additional Info

- Trial results can be submitted by email if you are able scan all record sheets, required FTS paperwork, all entries that are required to be submitted along with any required registration, certifications, etc that you need to send to Records into a file (suggestion is to put it all in a PDF file) and submit the payment via paypal.

- Per Policy O-RCD12

**3. Errors Discovered After the Trial Records are Published. a. Results of field trials published will not be changed except by action of the Board. Such action may be taken by electronic ballot distributed by the Corresponding Secretary. Such corrections will be limited to errors brought to the Records Coordinator's attention within 60 days of the publication of the trial records.**

I highly suggest that you check your results when they are posted.

## Special Note for Invitationals

The Regional Director is responsible to order the Rosettes and Medallions from the Awards Chairperson a minimum of 2 weeks prior to the trial. An estimate of the number of items required as close as possible is required. After the trial all remaining Rosettes and Medallions are to be returned to the Awards Chairperson within 2 weeks after the trial.

### *Most Frequent Records Errors*

1. FTE entries not submitted, typically because owner has not marked as such.
2. Incomplete Records sheets. Must have call name & registration number.
3. Not marking forfeits, just marking the placement(s).
4. The name (not signature) of the field clerk is missing (required to be listed on the Record sheet).
5. Giving hounds placements that have not total 50% of possible combined score.
6. Per capita difference between check submitted and my count. Without some sort of per capita break down I have nothing to try to figure out where the error might be.

• **Organization of Trial Records for Submission** \*previously listed in the rulebook

The following required items must be promptly sent to the Records Coordinator following each trial, indicated in Ch. VI:

1. Proper per capita fees made payable to the ASFA in USD. Current fee for each hound entered on the Record sheet which has not been excused as lame or in season at or prior to roll all. Only lame, in-season, hounds pulled due to change of judge/lure operator or hounds determined to have a breed disqualification are eligible for refund of the entry fee. **Ch. I Section 3** The record sheet should reflect the refund was given. All other hounds listed will count toward per-capita. Just writing PULLED is not acceptable and will be counted. All per capita fees shall be paid with a club check, certified check, money order or through an electronic funds transfer (EFT). Do not send cash or personal checks. If you use Paypal send to [treasurer@asfa.org](mailto:treasurer@asfa.org) and mark on the per capita sheet.

2. A copy of the approved premium list only if there are any course plan changes or changes to the judging panel. A letter of explanation of these changes.
3. All record sheets for every course, including re-runs and runoffs if required. Notations of reasons why hounds who were entered did not run, e.g., absent, bitches in season, lame, dismissed, disqualified under the ASFA breed disqualifications, excused by the Field Trial Chairman, etc. filled out and written legibly.

The following must also be included:

1. Proof of registration, completed certification and entry forms for hounds entered for the first time.
2. Entry forms that include notations for hounds working off a dismissal.
3. Entry forms that include any indicated change of information (e.g., new titles, address change or change of ownership [changes to ownership require an updated copy of registration showing the change]).
4. Per Capita Report Sheet

The preferred order to use in organizing this material for submission is:

1. Per capita payment and worksheet showing entries for per capita. If submitted by EFT please mark the amount and date submitted on the worksheet. There is a space for the transaction number.
2. Premium list if needed.
3. Record Sheets in the alphabetical breed order: Best in Field/Event record sheet (filled out completely).
4. Any entries should be in the same alphabetical breed order.

Chapter VI Section 3: The host club shall maintain a completed set of all the records submitted for a period of one year following the lure field trial(s).

• **Filling in the Trial Record Sheets**

The record sheets must be completely and legibly filled out. This includes the complete names of the judges, the call names and registration numbers of the hounds, etc. If an entered hound is not competing, the reason should be entered on the record sheet, as should the reason for any excusal, dismissal, or disqualification. For tie runoffs, the blanket color and total score only should be entered in the "Runoff" column; similarly, for Best of Breed runs, enter only these items in the "BOB Runoff" column. This becomes even more important since not all entries will be submitted with the results.

## Submission of Records

With the changes in regard to submission of trial info it will become even more important to have contact information for the FTS as with the limited information being submitted, I have to rely on the FTS to make sure that I get the needed information. So, if you have an entry and you are not familiar with the hound or owner please confirm with said owner that the hound indeed was previously entered in ASFA. Since the only info that I will be getting is the registration number and the call name I foresee problems! If I have trouble getting in touch with the FTS this will delay results being entered and subsequently getting posted on the Web.

NBQ --receives no points.

The winner of Best of Breed receives the higher number of points available from the Open, Field Champion or Veteran stake, but must defeat the winner of the other stake(s) in a run-off.

\* Example: a hound places second in a stake/flight of 3 = 9 points.

**Note:** A hound must defeat a qualifying hound to count as a qualifying placement towards title requirements.

**The hound winning BIF now gets 4 points for each hound that has competed in BIF in addition to the points earned in the regular stake up to a maximum of points.**

A single entry in a stake, who defeats another hound to win Best of Breed, will earn a qualifying (competitive) first placement for defeating a qualifying hound. A single entry in a breed, awarded Best of Breed, will earn a first placement for winning Best in Field against a qualifying hound.

- one (1) First and two (2) Second placements (all placements must be over a qualifying hound)

**Veteran Field Champion** title requirements: 75 points and

- two (2) First placements or
- one (1) First and two (2) Second placements (all placements must be over a qualifying hound)

**Lure Courser of Merit** requirements: Field Champion title,

- an additional 300 points and
- four (4) additional First placements from the Field Champion stake over qualifying hounds

**LCM II, LCM III, etc.:** same as Lure Courser of Merit.

**Veteran Lure Courser of Merit** requirements: Veteran Field Champion title,

- an additional 200 points and
- four (4) additional First placements from the Veteran Field Champion stake over qualifying hounds.

**Veteran LCM II, LCM III, etc.:** same as Veteran Lure Courser of Merit.

**Title of Coursing Proficiency (TCP)** 100 proficiency points and

- two (2) First placements or
- one (1) First and two (2) Second placements (all placements must be over a qualifying hound)

**Title of Coursing Proficiency Excellent (CPX)** Title of Coursing Proficiency title and,

- an additional 300 proficiency points and
- four (4) additional First placements from the Single stake over qualifying hounds

100 proficiency points and

- two (2) First placements or
- one (1) First and two (2) Second placements (all placements must be over a qualifying hound)

Lure Chasing Senior (LCS)

300 Proficiency points and

- four (4) additional First placements from the Single stake over qualifying hounds

**Lure Chasing Instinct (LCI)** Attained 8 qualifying scores

**Lure Chasing Advanced (LCA)** Attained 20 qualifying scores

**Veteran Lure Chasing Champion (VLCC)** Hound must be over the age of 7 get 100 proficiency points and

- two (2) First placements or
- one (1) First and two (2) Second placements (all placements must be over a qualifying hound)

**Veteran Lure Chasing Senior (VLCS)** Hound must be over the age of 7 with the VLCC title and,

- an additional 300 proficiency points and
- four (4) additional First placements from the Single stake over qualifying hounds
