

## Report of Records Coordinator

*important update for Records 101*

### Cover Letter for Records 101

There were MAJOR changes to trial submission beginning this year and we have now been following the new procedures for about 6 months. The experience has been good and bad for me but it's a learning experience for all of us. I will be continuing to rely on every FTS to make sure the information they submit is as complete and correct as possible.

Some suggestions:

When making out your roll call sheet and you have an entry for an unfamiliar hound, make note to persons doing roll call to check with owner as to previous coursing history. I have had too many First Time Entries where the entry wasn't marked thus the FTS did not submit it. Now I am left with a call name, breed, and registration number. Next step is to contact the FTS to have them scan and email me the entry for owner information.

If you come to find that a first-time entry did not come with all the information required, have the owner email or fax the information directly to me to expedite the process.

It is helpful when you list breed initials on the Single Record sheet in the event of missing information, I have a breed to aid in the search.

If you plan to submit the results via email, please minimize the number of files you send and try to keep things in the same order that you would always do to submit them.

As always please contact me should you have any question(s). Email is always best way to reach me but you can call if you need an answer quickly. If I do not pick up please leave a message and I will return the call ASAP.

# Records 101 (update 07/21)

## Daily Requirement

- A completed copy of the FTS Report (example included) completed in entirety.
- Per capita sheet for each day.

## Premium

- An updated copy of the premium list is required only if there were any changes to the course plan or change to judge's panel. For changes to the Judge's panel the Chair of Judge's must be notified of change and reason. Although it is not required a copy of premium is appreciated.

## Entries that must be submitted with your trial results

- Entries for all hound(s) that are marked as FTE (First Time Entry). This must be accompanied by proof of registration (examples AKC, UKC or CKC) (Waived for NGA registered hounds) & proof of certification if entered in a regular stake. This includes the Single stake and the LCI stakes in respect to requiring the registration. If proof of certification has been waived, a copy of the signed waiver and proof of the title must be included.
- Entry forms that indicate a change in the information (titles, address, etc). If the change is in ownership an updated copy of registration reflecting said change must be attached.
- Entry forms that reflect that said hound is working off a dismissal.
- 

## Record Sheets

- All record sheets completed in entirety that includes the BIF sheet. All information needs to be legible and as accurate as possible.
- O-TRIALS15 When two Judges are used, they shall be designated on the record sheet as Judge 1 and Judge 2, alphabetically by last name. This is for all judges whether Provisional or full judge.
- O-TRIALS04 The Field Clerk's name shall be indicated on each record sheet, but the Field Clerk's signature is not required.
- Per Ch V Sec 6 (g) hounds can no longer be left tied. There must be a runoff or a forfeit. The only tie that can stand is if it is the result of an error found during post trial review by the FTS which then a note must be attached explaining the problem.
- Any hound listed but did not run will need to have an acceptable reason (per the ASFA Running Rules) listed on record sheet. If nothing is noted or it just says pulled, the hound will count for per capita. **If an owner is unable to separate their hounds and decides to pull an entry there is no refund for this!**

## Per Capita Sheet

- There must be a sheet completed for each day.
- If you are paying the fee by Paypal send it to [treasurer@asfa.org](mailto:treasurer@asfa.org) . Put Paypal transaction ID on allotted space.

## Additional Info

- Trial results can be submitted by email if you are able to scan all record sheets, required FTS paperwork, all entries that are required to be submitted along with any required registrations, certifications, etc that you need to send to Records into a file (suggestion is to put it all in a PDF file) and submit the payment via Paypal.

# JUDGES LICENSING

## NOTES FROM JUDGES LICENSING

### **How to Comment on Judges License Applications** *(from the 5-21 report)*

Applications for a license to judge ASFA field trials are published for two consecutive months. This is to provide anyone who has a comment on the application to be heard, either pro or con. Any comments must be in writing and submitted to the Chair of Judges Licensing for consideration. After the second publication, with no negative comments or rules violations, applicants will be approved and published for the license that they are applying for.

Third party comments and verbal discussion with the Chair cannot be considered. This is because each applicant needs to know their shortcomings and any issues that exhibitors have. If requested, the name of individuals providing comments will be withheld. The applicant has the right to know and respond to any comments, whether good or bad.

### **When to Communicate with the Lure Operator** *(from the 6-21 report)*

It should be noted that comments to the Lure Operator should be made between runs, rather than during runs. If a Lure Operator is not keeping the lure in front of the dogs or is burying them in corners, discreetly talk with them about their operation between runs.

The lure operator's job is hard enough without comments coming from judges, the huntmaster, or handlers during a course. The only exception is to call "stop the course" if a dog is caught in the line, injured or otherwise hampered from running (such as interference or something on the course).

### Judges Look for the Judges Handbook in Your Mailboxes *(from the 7-21 report)*

The board has approved providing a hard copy of the Judges Handbook to all currently licensed judges. All judges should be on the lookout in your mail for your copy within the next month. If you do not receive a copy, check that your address is correct on the judges list. The latest list of current judges is posted on <https://www.asfa.org/judges/index.htm>.

## Rule Evaluation Committee Report

### ASFA Rule Change on August 1st & How the Rule Change Process Works

*from Marilyn Standerford*

#### Rule Change

Only one rule change was adopted by the ACoD in 2021. It prohibits lure operators from reversing the direction of the lure during a course. It states:

#### **3. When using a continuous-loop system, mid-course reversals are not permissible.**

## CONSTITUTIONAL AMENDMENTS Effective AUGUST 1, 2021

from Ping Pirrung,

Three Amendments to the ASFA Constitution were approved by the 2021 Annual Convention of Delegates (ACoD). They are set out below and go into effect on 1 August 2021:

### AMENDMENT #1:

#### Article IX DISCIPLINE

**Section 2:** ~~Should~~ The charges may be sustained by a simple majority vote of those present, after hearing all the evidence and testimony presented by the complainant and defendant, ~~The~~ Board may then, by a two-thirds majority vote of those present, suspend the defendant from all privileges of the ASFA for a finite period of time following the date of the hearing or, by a majority vote of those present, issue a reprimand, which shall detail the misconduct prejudicial to the best interests of the ASFA. ~~In such case~~ The suspension shall not restrict the defendant's right to appear before the ensuing Annual Convention of Delegates. Immediately after the Board has reached a decision, its findings shall be put in written form and filed with the Recording Secretary. The Corresponding Secretary in turn shall notify each of the parties of the Board's decision and penalty, if any. Any sustained charges or penalties will be published in the official ASFA publications.

### AMENDMENT #2:

#### Article IV CONVENTIONS, MEETINGS, DELEGATES and VOTING

**New Section 3:** Whenever possible, the ACoD should be held in a physical location, with all ACoD Delegates attending in person. However, should the ASFA Board determine that it is substantially impractical to host a physical ACoD, they may choose to host a virtual or electronic ACoD, using such technology as seems best at the time. When such a decision is made, all clubs will be notified as soon as possible, but in no event less than 60 days prior to the scheduled date of the ACoD, along with an explanation of the reason for the shift to a virtual meeting. Clubs may override such a Board decision to meet virtually by an affirmative vote of 1/3 of the member clubs. To do so, the clubs shall submit a petition to the Corresponding Secretary within 30 days of publication of the Boards decision to move the ACoD to a virtual meeting. Upon receipt of a petition to override signed by the club delegates of one-third of the member clubs in good standing the Corresponding Secretary shall proceed with publication of the time and place of a physical ACoD. The petition shall state the objection to the ASFA Board's vote to

host the ACoD virtually. The Board must have in place clear policies that determine when such a shift may take place, and how such a virtual ACoD shall be run, including details about how voting will be conducted.

Renumbering of subsequent Sections.

(current) **Section 5. Board of Directors Meetings.**

(a) The Board of Directors shall meet in person, at least once each fiscal year at such time and place as may be designated by the Board of Directors. Should the ASFA Board determine that it is substantially impractical to host a physical Board Meeting, they may choose to host a virtual or electronic meeting, using such technology as seems best at the time. Notice of each such meeting shall be given by the Corresponding Secretary at least thirty (30) days prior to the date of the meeting. The quorum for such a meeting shall be a majority of the Board of Directors. The Board must have in place clear policies that determine when such a shift may take place, and how such a virtual Board Meeting shall be run, including details about how voting will be conducted.

....

**AMENDMENT #3:**

**Article VIII  
EXPERIMENTAL PROGRAMS**

The Board of Directors may, after notification to the clubs, implement experimental programs on a trial basis, without revising the running rules. Such programs shall, whenever possible, be parallel and supplementary to established programs, and shall be reversible in any circumstances where hound records may be affected. Under no circumstances shall experimental programs be implemented in conflict with the Constitution. After one year, the results of the program must be posted on the ASFA website, published in the ASFA Communiqué and sent to each club delegate. After the Board of Directors presents a complete report on the results of the Experimental Program to the ASFA clubs, the experimental program may continue until the ACoD when the vote is conducted. After reporting, the subsequent ACoD must vote to approve or disapprove the establishment of a permanent program based on the experimental program. Upon ACoD approval, the experimental program shall continue until the running rules change(s) is/are approved go into effect.

If the experimental period requires substantive changes in the program, the Board of Directors may approve an additional implementation period as a trial for those changes, not to exceed a total of two years from initial implementation to an ACoD vote.

## Best of Breed Trophies – Saturday

### Afghan Hound

Gary Forrester Trophy

Gary was active as part of ASFA administration and on the field. One of the first all-breed judges in 1977, he continued judging until 1991; Chairman of judges licensing from 1978 to 1984; was a member of or chaired the following committees: AKC negotiation' computerization' reinstatements' budget' FAN' Constitution revision' rules' nominating' and several investigative committees of the board' He was 2<sup>nd</sup> VP 1978 to 1989, 1<sup>st</sup> VP 1980 to 1984, President 1984 to 1988 and the first Field Representative 1990 to 1991. He owned and lure coursed Afghan Hounds since 1974 – “Bandit” and “Piper”.

### Basenji

Merv & Wilma Bauer (1920 – 1987) Trophy

Their untiring promotion of Basenjis contributed to ASFA's acceptance of the breed. They were active members of the Central Illinois Sighthound Club, and together they worked to advance Basenjis on the field and in the show ring. The motorhome, packed with a mini-bike for restringing a drag line, lure equipment, electricity, warmth and Basenjis, was a familiar and welcome sight at trials in the Midwest (including Carbondale, Illinois – at the first International Invitational).

### Borzoi

“Locket” (canine) Trophy

Zaraya of the Wild Hunt, LCMXVII, bred by Ariel Duncan, owned by Leigh Littleton and Ariel Duncan, and chauffeured primarily by Leigh Littleton. #1 lure coursing sighthound in 1983 and 1984, #1 Borzoi in 1985 and again in 1988 as a Veteran, and continuously in the Top Ten from 1983 through 1989, Locket was winner of Best in Field at the 1983 Grand National Lure Course. Locket's goals in life were smiling at as many people as possible, playing the coursing game with intensity and follow, and killing as many lures as possible, and she did a great deal of each. Her last field trial was the 1992 International Invitational at Lexington KY, where at 10 years of age she took first place in the Veteran stake against competition; by this time, she was the only sighthound to have earned an LCM XVII, and had defeated over 2200 Borzoi.

### Greyhound

Mike Lorenzo (1948 – 2008) Trophy

This trophy, featuring a brace of coursing Greyhounds, is dedicated to the memory of Mike Lorenzo. Mike and his wife Karen bred and trained many top lure coursing Greyhounds under the banner of the Winds Greyhounds, and over the years traveled many miles to compete against the best runners on the field. Mike was one of the most talented lure operators in the sport, and there was no equipment problem that could best him. He served as Regional Director from Region 9 from 2004 until 2007, and often served as Field Trial Chairman for several clubs. He conceived and co-founded the ASFA National Greyhound Specialty. Above all, he was richly deserving of that rarest of accolades: “sportsman”.

### Ibizan Hound

Dean Wright

Dean was the president of the Ibizan Hound Club of the United States when the breed was accepted by ASFA in 1976 and recognized by the AKC for conformation in 1979. Dean has owned and bred Ibizan Hounds since 1967. He owned the first Ibizan ASFA Field Champion as well as the First Ibizan AKC Champion, both by the same hound, CH Sunking Eterna of Treybeau, FCh. Dean served on the ASFA board as a Regional Director for more than five terms and as First Vice President for two terms. He was the chairman of the Hall of Fame Committee. Dean remains very active in ASFA lure coursing.

## Irish Wolfhound

Kevin Bryson (1947 – 1999)

A familiar, friendly face behind the lens, Kevin Bryson was a devoted fan, an ingenious artist, and trusted friend within the sport of lure coursing. Creating some of our finest memories on the field, Kevin spent tireless hours working his photographic magic to give us the timeless moments we treasure. Kevin shared his life with his wife Jill, Irish Wolfhounds, a Whippet or two, and Leaping Lizards Professional Photography.

## Italian Greyhound

Jack Downing /Teri Dickinson “ Whirlwind’s Italian Greyhound Trophy”

Breeding, showing, racing and coursing Italian Greyhounds under the Whirlwind prefix, Teri Dickinson and Jack Downing were instrumental in getting Italian Greyhounds approved as an ASFA breed, having performed breed presentations at several ACoDs and working tirelessly behind the scenes to promote their diminutive sighthounds from 1993 until 2001 when IGs were fully recognized. As part of their service to ASFA, Jack has served numerous times as Regin 4 Director and as an all-breed ASFA judge and an accomplished lure operator, having been named Lure Operator of the Year in 2010.

## Pharaoh Hound

George & Joyce Martin

George and Joyce were instrumental in the late 70s and 80s. George was the RD for Region 2 from 1985 – 1986. George attended Several ACoDs even when he was not the RD. They competed with their Pharaohs on the West Coast, and “Bandit” was their most notable Pharaoh Hound.

## Rhodesian Ridgeback

Meg Willis-Redfern Perpetual Trophy

Meg is a long time Rhodesian Ridgeback breeder with the kennel name of Rare Earth Ridgebacks. Meg was instrumental in helping achieve recognition of RRs in the ASFA through her advocacy for the breed. From her breeding program, focused on form and function, to mentoring people in the RR breed about coursing, she led the change in making RR coursing a reality. Today, RRs are a huge part of coursing, both in large entries and the fact that RR owners are out working the trials in every capacity, including some of our top huntmasters, lure operators, and judges. She is a mentor and friend to many and has one of the best senses of sportsmanship in the lure coursing arena. Meg has been a strong advocate for the ASFA and believes deeply in the premise upon which the ASFA was founded.

## Saluki

Bill Henry (1929 - 1983)

Bill was the 2<sup>nd</sup> VP – 1980 until his untimely death in Texas on January 9, 1983. An active judge and competitor on the field and a colorful “protest digester” on the board; may have been one of the only 2<sup>nd</sup> VPs to call an ACoD to order. President of Galveston Bay Saluki Club for many years and an officer (and active club member) of the American Saluki Association. Bill owned many top winning Salukis (bench and field) under the Henrad Kennel name.

## Scottish Deerhound

Robert Sellers (1934 - 2002)

The Bob Sellers Memorial Trophy is offered in memory of Bob by his many friends in the lure coursing community. Bob, with his wife Norma, was the breeder of many top lure coursing Scottish Deerhounds under the Vale Vue kennel name. He was also a long-time ASFA judge and lure operator, and he served as President of the Scottish Deerhound Club of America. Vale Vue was the home of the first ASFA coursing trials on the East Coast, and Bob’s enthusiasm and love for lure coursing helped bring many new people into the sport over the years.

## Whippet

Tom Leone (1917 – 1980)

Together with his wife Betz, and Lyle Gillette, was a solid part of ASFA’s formation and early years. He served as ASFA Treasurer from March 1976 to 1980. Sheridan Seabiscuit, UD was his 5<sup>th</sup> Whippet FCh. Tom was an active judge, lure operator, and always ready with a smile and calm demeanor.

## Gillette Stake Qualifier & Best in Gillette Stake Trophies

### Borzoi Darkling Perpetual Trophy

Will be presented to the Borzoi earning the right to represent the breed in the Gillette Stake in memory of SilkenSwift Blaze's Darkfire. "Darkling", the #2 Borzoi on ASFA's Top Lifetime Achievement record, passed away on December 26, 2008. Darkling began lure coursing September 27, 1998 and retired almost eight years later on January 1, 2006. During that time, Darkling successfully participated in seven International Invitationals. He competed in ASFA trials in 16 states from Florida to Wisconsin, Colorado to Texas, Iowa to Pennsylvania, and from Delaware down the East Coast to his home state of Georgia. His record as #1 ASFA Borzoi in 2000 and 2001, as #2 Lifetime Borzoi, as well as his 69 Best of Breed wins, speaks volumes about his performance. But more significantly, we will never forget his noble presence and confident and peaceful demeanor when off the field.

### Ibizan Hound Eterna Perpetual Trophy

The Eterna Perpetual Trophy will be presented to the Ibizan Hound earning the right to represent the breed in the Gillette Stake, in memory of Ch Sunking Eterna of Treybeau, FCh, LCM, who was owned by Dean Wright and Kathy O'Brien. Eterna was not even old enough to compete on the day that Ibizan Hounds were eligible to enter their first ASFA Field Trial on April the 16<sup>th</sup>, 1976. Eterna turned one year of age two months later in June and became the first Ibizan Field Champion. In January of 1979, when the breed was eligible to compete for an AKC Breed Championship, Eterna went to Florida in January along with 20 other Ibizan Hounds. Eterna did not place on the first day but earned 3 5-point majors on the next three days, making her the first AKC breed champion. Finally finishing her LCM at the age of 10, Eterna did truly combine form and function the way that it should be.

### Irish Wolfhound Woople Perpetual Trophy

The perpetual trophy for the Gillette Stake was inspired by the memory of the past Irish Wolfhounds who demonstrated the beauty in the show ring and the drive in the field. Jill Bryson commissioned this trophy and dedicated it to her IW Woople, CH Franjo Pearla Dhu at Aeroglen, LCM, RA, RATi, TKN, VC.

### Rhodesian Ridgeback Nitro Perpetual Trophy

This trophy is donated by Gayle A and Paul Kytta II in memory of BIF DC Rare Earth Top Fuel Eliminator, LCM7, VLCM4, GRC. JOR, MC, DC, CGC, TDI, TT, HIC, VC. Nitro was ranked nine times in the ASFA Top Ten Ridgebacks, achieving the #1 spot in 2010. He retired in 2016 as the #2 ASFA Lifetime Ridgeback and as the highest ranked male Ridgeback in ASFA history.





## Best of Breed Trophies – Sunday

### Afghan Hound

“Bandit” Tamora’s Image of Ali CD LCM7 CAN FCHX TT

Bandit shared a home with Gary & Marietta Forrester in Pennsylvania. #1 Sighthound (all breeds) in '76, '77 and '78 and #2 lure coursing Afghan (Top Ten) as of 2011. Bandit has 1167 hounds defeated, 31 Best of Breeds, and 4 Best in Fields. That black & tan, always impeccably groomed, very calm – until slipped and then a burst of power with the black and tan coat flowing in the wind! “Bandit” actively competed for 6 years and was known to be flown to some trial site by his own personal pilot, Gary.

### Azawakh

“Cinnamon” Multi CH Kel Simoon Cinnamon, FCC

Cinnamon was the first Azawakh to fulfill the requirements of ASFA Field Champion. She was also a great show dog, a loving mother and a wonderful pet. Cin was tragically killed when she escaped from our yard in April of 2000. Her legacy lives on in her daughter, SBIS, Multi CH Kel Simoon Essari, FCC and her litter sister, SBIS, CH Kel Simoon Celie, FCC. These three dogs were the only Azawakhs awarded the FCC, before the breed was fully recognized.

### Basenji

“Sheena” PATRICIAN SHEENA CRIMSON ART, LCM3

Sheena was owned by Dave and Carol Phelps of Maryland. #1 Basenji in 1988 and was #1 lure coursing Basenji all time, as of 1989. Sheena proved that Basenjis were truly competitive! Sheena was a pet that everyone hopes they will have one day. Unless something was moving, she was perfectly content to lie in front of the wood stove on a cold day. On the field she ignored the other dogs, and all attention was focused on catching the “bunny”. She squeaked and fought to be released when she heard the lure machine. All she wanted was to kill that bag at the end. Sheena would leap in the air to try to see where the bunny went if she lost sight of it. Sheena never did learn to “cheat”. Sheena helped change the attitude toward Basenjis as lure coursers.

### Borzoi

“Pyerun” CASPIAN PRINCE PYERUN DUNCAN, LCM2 CANFCH

Owned by G Ariel Duncan. The first LCM Borzoi on Sept 17, 1977, and first LCM II Borzoi in April, 1979. Dubbed “the alligator” by many lure operators in the later years of competition, this red dog’s zeal for plastic set the standard for the others to follow.

### Greyhound

“Fantasy” Treybeau’s Fantasy, LCM 7 (March '84 – Sept '91)

Fantasy lived to run, and with Dean and Sandy Wright’s help, she loved living. She began accruing lure coursing titles with a FCh in 1985 and finished her LCM 7 in '91. She was #1 lifetime Top Ten coursing Greyhound (1995); 847 hounds defeated, 133 BOBs, 30 BIFs, 151 Firsts, 2394 ASFA points, and ASFA Top Ten every year from 1985 to 1991, seven years and #1 for six of those years from '85 to '90. “THE PAST IS ONLY A MEMORY AWAY”.

### Ibizan

“Flyer” Treybeau’s Spanish Flyer, LCM3

Flyer was one of the first three Ibizan Hounds to compete in an ASFA trial at Vale Vue Kennels in 1976. Flyer was the first Ibizan Hound to earn the LCM title and was an original inductee into the ASFA Hall of Fame. Flyer was in the ASFA Top Ten ASFA 1976 to 1982; #6 Lifetime Ibizan in 1995 with 461 dogs defeated and 24 Best of Breeds. Flyer proved to all that you run on your heart and the desire in your head. It makes no difference as to your conformation.

### Irish Wolfhound

“Joshua” CH JUST PLAIN JOSHUA MURPHY, FCH

Josh was owned by Deborah Keplinger Sanders and bred by Dr Paul Palmer. Josh was the first Irish Wolfhound Field Champion (1974) and the first Irish Wolfhound Dual Champion. He received his AKC conformation championship two weeks after finishing his ASFA Field Championship. Josh is the only Irish Wolfhound to achieve his FCh under the original ASFA format, having to earn his points competing against Greyhounds, Salukis and Whippets. In the beginning, before ASFA instituted breed stakes, the dogs competed in mixed stakes determined by a random draw which included all breeds entered in the trial.

## Italian Greyhound

“D” FCC DC Whirlwind Blew By You LCM VFCh OA NAJ JOR VCM

“D” was an IG lure coursing pioneer. Born in February 1995, he ran in his first trial in March 1996, the year IGs were admitted to the Miscellaneous Stake. Famous for both suicide bunny kills and sideline histrionics, his durability and enthusiasm opened the mind of many a skeptic. He coursed in an era when the Miscellaneous Stake was optional and not offered at all trials. Competitors were few and far between. Despite that, he earned enough points to meet ASFA Field Champion requirements three different times. He was first awarded a Foundation Coursing Champion title, then after a rule change, earned the Miscellaneous Field Champion title. After IGs reached full recognition in mid-2001, he went on to earn Field Champion, LCM and Veteran Field Champion titles. His first entry in a standard ASFA stake was in the veteran’s stake at the 2001 II. Among D’s groundbreaking accomplishments were first IG to earn an ASFA title, and the first IG dual titlist. He was the #1 Lifetime Miscellaneous Under 18” from 1996-200”m the entire duration of IGs residence in that stake, the #1 Miscellaneous Under in 1997, and a member of the IG Top Twenty every year from 1996 – 2004. “D” ran his last trial in 2006. Breeder/Owners Teri Dickinson & Jack Downing.

## Pharaoh Hound

“Bozo” CH KAMARAJ RA-HARAKHTE, LCM 6, CAN FCH

Bozo was owned by Frank Belinowiz of Massachusetts. Bozo is the only LCM 6 Pharaoh to date (2-94). #1 lure coursing Pharaoh ending 1989. A lure operator’s worst nightmare. The BOZO Trophy is to honor all Kamaraj Pharaoh Hounds in the past, such as: BOZO, #2 Lifetime Ranking Pharaoh Hound; Tiye Tu, 1999 BIF at the II; Luxor the Brod, 2001 Gillette Stake Winner; Seeker “Shut Up”, Hall of Fame.

## Rhodesian Ridgeback

“Ida” BII FC Redwing’s Private Idaho LCM13 VFCH SC CGC

Ida was owned by Chuck Harper and Jeff Nearhoof. Bred by Sue and Dick Kaehler. In a crowded field of great coursing Rhodesian Ridgebacks, “Ida” has left a lasting impact on the sport. Blazing a coursing path since 1999 through 20 different states, she has set many records and often been a pioneer, most notably as the first Ridgeback to go beyond LCM 5. Ida won Best in International Invitational in 1999, was the #1 Ridgeback for 1999, 2000, 2001 and 2002, and remained in the Top Ten for 2003 and 2004. She also went BOB at four non-consecutive IIs, and seven Regional Invitationals in four different regions. Ida has been #1 Lifetime Ridgeback since 1999.

## Saluki

“Haseeb” SUR-RA HASEEB AMON KAHTAHDIN, LCM 8

Haseeb was owned by Dean Wright & Janis Copenhaver. Haseeb was the Number 1 Lifetime Saluki ending in 2000, with 976 hounds defeated, 56 Best of Breeds, and 13 Best in Fields. He made it look so effortless and easy over his many years on the field. Haseeb competed in 365 ASFA trials, plus some trials in Canada. Haseeb was a loner at home, preferring to do things alone. He would play for hours with an old football, throwing it in the air and chasing it.

## Scottish Deerhound

“Pyns” AM/CAN CH PIBROCH’S PYNS OF VALE VUE LCM

AmCanCH Pibroch’s Pyns of Vale Vue, LCM, owned by Norma & Robert Sellers of PA #4 lure coursing SD of ’89.

## Whippet

Betz Leone (1918 – 1993)

The “first lady” of ASFA, helped put together the first ASFA lure course on school grounds a stone’s throw from her home in California and continued to be an active judge and handler throughout her lifetime. She was the FAN co-editor and printer (crank-style) beginning in 1974 and continuing for several years, served as Regional Director from 1981 to 1984 and 2<sup>nd</sup> VP in 1986 & ’87. Always willing to help, always with a smile, always the lady.

## Best in International Invitational Trophies

### The President's Cup

The President's Cup is offered in memory of ARNOLD ROSS who served on the ASFA Board as President in 1978 and 1979. Arnold competed on the West Coast with his Whippets. Ross was ASFA President when the first ASFA International Invitational was held in Carbondale Illinois. This was a one day II on Saturday, with the top hounds of each breed competing for top honors on Sunday. Today, Best of Breed hounds, from both days of the II, compete in the Best of International Invitational.

### "Links to the Past"

The remarkable "Links to the Past" II Chain was awarded for the first time at the 2007 International Invitational' a truly fitting tribute to the 35<sup>th</sup> Anniversary Year of the ASFA. It is absolutely spectacular.

This truly unique trophy was the brainchild of Kathy Nelson and Jack Helder and was purchased (and is maintained) by individual donations from ASFA clubs and their memberships.

The "Links to the Past" Best in II Trophy is hand-crafted in sterling silver and is comprised of a chain bearing engraved links that recognize every Best in II hound in ASFA's history, stretching back to the first II in 1976. The hound's name is on one side, and the year on the other. The trophy links every former Best in II hound within one exceptional trophy. It remains in the possession of the ASFA President for presentation at IIs and is displayed in a case to protect the chain. Best in II hounds, and those who owned a former Best in II winner, can purchase an engraved sterling silver "take home link" – for a donation toward the future costs of maintaining this one-of-a-kind historical record – to us in display or as a piece of jewelry.





Suzanne thinks that Andy would approve of the Turtle Award in his honor that can help to soften the blow of a tough loss with a touch of humor.



# Animal Advisory Report

## The CDC Suspends Importation of Dogs from Countries Classified as High Risk for Rabies

The United States Centers for Disease Control and Prevention (CDC) has temporarily suspended the importation of dogs from countries classified as high risk for canine rabies. This suspension will also apply to dogs arriving from countries not considered a high risk if the dogs have been in a high-risk country during the previous six months. The new suspension applies to all dogs, including puppies, emotional support dogs, and dogs that traveled out of the United States and are returning from a high-risk country. CDC has coordinated with other federal agencies and entities as necessary to begin implementing this action and will review the suspension periodically. The suspension is due to commence July 14, 2021.

CDC reports that this suspension is necessary to ensure the health and safety of dogs imported in the United States and to protect the public's health against the reintroduction of canine rabies virus. Rabies is considered one of the deadliest zoonotic diseases. After decades of work, the U.S. was declared to be free of dog rabies in 2007. However, CDC estimates 6% of all dogs imported into the U.S. arrive from countries at high risk for dog rabies. In 2020 alone, CDC identified a 52% increase in the number of inadequately vaccinated dogs that were denied entry into the U.S. from high-risk countries compared with the previous two years. The following countries are currently considered high risk for importing dog rabies into the United States.

**AFRICA:** Algeria, Angola, Benin, Botswana, Burkina Faso, Burundi, Cameroon, Central African Republic, Chad, Comoros, Côte D'Ivoire, Democratic Republic of the Congo, Djibouti, Egypt (temporary suspension of importation of dogs from Egypt until further notice), Equatorial Guinea, Eritrea, Ethiopia, Eswatini (Swaziland), Gabon, Gambia, Ghana, Guinea, Guinea-Bissau, Kenya, Lesotho, Liberia, Libya, Madagascar, Malawi, Mali, Mauritania, Morocco, Mozambique, Namibia, Niger, Nigeria, Republic of the Congo, Rwanda, Sao Tome and Principe, Senegal, Sierra Leone, Somalia, South Africa, South Sudan, Sudan, Tanzania (including Zanzibar), Togo, Tunisia, Uganda, Western Sahara, Zambia, and Zimbabwe.

**AMERICAS AND THE CARIBBEAN:** Belize, Bolivia, Brazil, Colombia, Cuba, Dominican Republic, Ecuador, El Salvador, Guatemala, Guyana, Haiti, Honduras, Nicaragua, Peru, Suriname, and Venezuela.

**ASIA, THE MIDDLE EAST, AND EASTERN EUROPE:** Afghanistan, Armenia, Azerbaijan, Bangladesh, Belarus, Bhutan, Brunei, Cambodia, China, Georgia, India, Indonesia, Iran, Iraq, Jordan, Kazakhstan, Kuwait, Kyrgyzstan, Laos, Lebanon, Malaysia, Moldova, Mongolia, Myanmar, Nepal, North Korea, Oman, Pakistan, Philippines, Qatar, Russia, Saudi Arabia, Sri Lanka, Syria, Tajikistan, Thailand, Timor-Leste (East Timor), Turkey, Turkmenistan, Ukraine, United Arab Emirates, Uzbekistan, Vietnam, and Yemen.

**Advanced Written Approval Available on Limited, Case-by-Case Basis.** CDC may, on a limited basis, grant advanced written approval permitting the importation of fully rabies-immunized dogs, six months of age or older, from a high-risk country. To apply to import a personal pet dog, a person must be: a U.S. government employee with work-related relocation orders; a lawful U.S. resident/citizen relocating back to the United States such as for employment or education; or an owner of a service dog that is individually trained to assist an individual with a disability. Importers wanting to import dogs that are not their own personal pets are only eligible to apply for a permit to import an unrestricted number of dogs for science, education, exhibition, or law enforcement purposes.

During the temporary suspension, each eligible importer of personal pet dogs may be granted approval to import a maximum of three dogs for one trip. Permits will be granted for dogs six months of age or older, that have been microchipped for identification and that have a valid rabies vaccination certificate. If the vaccine was administered outside of the U.S., a rabies serologic titer from an approved laboratory will also be required. All permitted dogs must enter the U.S. at a port of entry with a U.S. Customs and Border Protection-bonded animal holding facility, which currently is only available at John F. Kennedy Airport in New York City.

**AKC's Long Concern with Importation of Unhealthy Dogs.** The American Kennel Club (AKC) has long been concerned with the importation of unhealthy dogs into the United States. In April 2018, the AKC Board of Directors adopted the following position statement on Pet Imports:


*The American Kennel Club® recognizes the value of importing breeding stock from overseas, and ensuring that people may travel with their pets with a minimum of disruption. The AKC® is also greatly concerned about increasing documented incidences of the importation of unhealthy, random-source pets into the United States, particularly for transfer, where public and pet health may be inadequately protected.*

*AKC supports efforts to better understand the impact of large quantities of dogs being imported into the United States. AKC further supports strengthening efforts to ensure that all dogs imported into the United States are fully immunized; free of infection, parasites and contagious diseases; and are individually certified as such by a qualified veterinarian.*

*No pet should be imported without an individual examination, valid veterinary certificate, and documentation regarding the source of the dog and the party responsible for it upon arrival into the United States.*



## How to Proactively Protect Yourself & Your Community from Harmful Local Dog Ordinances



**First - a cautionary tale:** An AKC club member from a small rural city was served with a “Cease and Desist” order because her small breeding program with puppies advertised on her Facebook page was newly classified to a “Puppy Mill” under a new local ordinance. She was floored, because until then she knew nothing about the ordinance. She immediately notified AKC Government Relations and her kennel club – and hired an attorney.

Unfortunately, this breeder’s options were limited after the ordinance was already enacted. She could try to get the ordinance amended or repealed. But that process is difficult, may take a long time, and success is far from assured.

There is a much greater chance of success when local clubs and breeders take action before an ordinance is enacted. Unlike state legislatures or Congress, many local governments can pass laws very quickly with just a handful of votes – and these laws can have an immediate and detrimental impact on dog owners and hobbyists. In addition, surrounding localities also looking to regulate animals will often model their laws after those of their neighbors.

For this reason, it is best for clubs, local breeders, and hobbyists to get involved and be proactive in their community. Here are a few simple actions you can take.

### Help Watch for Local Dog Proposal Introductions:

**Watch your local media** – Keep your eye out for reports on animal incidents in your community. Often proposals are introduced as a response to a tragic incident (For example, in 2019, a child attacked by a dog led the City of Detroit to propose a measure regulating large dogs. Onondaga County, NY, proposed tethering regulations after a dog died when tethered outside during a winter storm).

Also, it’s not unusual for proposals that initially start out as a limited response to a specific animal incident to expand into something much more expansive, extending well beyond the stated purpose of the proposal. In Detroit, for example, the final proposal included not just dangerous dog regulations, but also breeder permits and limits on litters.

When you learn of incidents, reach out to your local lawmakers. Let them know you share the community’s concerns about what happened and offer your expertise in developing effective solutions.

**Regularly check city and county websites** – Most cities and counties have websites where they post meeting agendas. Learn when the council or commission meetings are held and find out when

agendas are posted. Also check to see if your city or county has an animal advisory committee and check those agendas as well. When you learn of an issue, contact AKC Government Relations and we can help you with analysis, talking points, and spreading the word to other local clubs and breeders.

### **Actions to Take Today Before Something is Introduced:**

The most essential thing you and your club can do is make sure that your lawmakers are aware of local constituent dog breeders (and experts!) right in their community. Often lawmakers will reach out to those that they know can assist them on issues of interest. They need to know you are willing and able to help.

In addition, it helps them when considering proposals. There have been times when AKC has contacted a city about a proposal that would impact hobbyists or shows, and the councilmember was surprised to learn there were local clubs that would be impacted – and in some cases that there are dog shows and events held in their community. Here are some ideas to help develop these essential relationships:

**Introduce yourself and your club** – In the AKC Legislative Action Center, we have sample letters to help you and your club with lawmaker introductions.

**Invite them to shows and events** – This is a great way to introduce lawmakers to our sport and the importance of supporting responsible breeders and hobbyists. Consider giving them a tour – or better yet, allow them to present a best in show or another award. AKC GR can help you with inviting the lawmakers and providing appropriate resources and materials they can take with them to learn more about how dog events and responsible dog owners and breeders benefit the community.

**Let them know of your club's good works in community** – When communicating with lawmakers, AKC GR always lets them know if there are AKC clubs in their district/city/county. You can help strengthen this talking point by letting them know what you do in the community. If you are offering a training class or CGC certification, write your local lawmaker and let them know. Did you donate money for K9 vests or participate in the Adopt a K9 Cop Program? Let your lawmakers know! This demonstrates your value to the community and also again shows your expertise on local dog issues.

**Volunteer at your local shelter** – Not only is this a great community service, but it shows your local animal control officers that you care about these dogs and want to be a part of the solution. Often, too, local proposals are brought forward by local animal control directors and officers. By having a relationship and working with them, you may be able to better learn about these concerns and offer your expertise before a negative proposal is introduced.

**Sign up for local boards and advisory commissions** – Many counties and communities have an animal advisory board or commission. Consider applying for open seats on these boards to ensure the voice of local clubs and hobbyists are heard. If there aren't any open seats or animal boards in your area, perhaps consider other boards or commissions that deal with issues of interest to you. Being involved in your community helps develop those essential relationships with leaders who can impact your ability to breed, own, and show dogs.

## Self-Interview with Dean Wright



### 1. What Breed of dogs did I go through to get to the Breeds I have now?

My first dog was a mutt that wandered into our backyard when I was 5 years old. I named him "Pete" and my parents let me keep him. They also told me that Pete was a girl – what does a five-year-old know about sexing dogs. From then on, "Pete" was short for "Patricia".

Pete was still around when I got married at 21. My wife and I heard about a Standard Poodle in the dog pound and we went and rescued her. We named her "FiFi" a fitting name for a really loveable, ugly black poodle. We then got a Miniature Black Poodle "Cinder" from a Breeder.

In 1967 we saw an ad in the Washington DC newspaper from a gentleman that had bred a litter of Ibizan Hounds. We had just read about the rare breed in Dog World Magazine. We went to look at them and, as usual, my wife and I could not agree on which we liked best, so we bought two - one for her and one for me. I was hooked on the Ibizan from then on.

### 2. Describe the first time I saw one of my dogs course.

I went to my first field trial at Val Vue Kennels. My Ibizans did not get to practice after the trial on that first day, but the excitement they showed hooked me on the sport. I went home, built a machine, and made pullies out of skateboard wheels. My dogs practiced in my backyard, and I began holding practices for everyone on Thursdays.

### **3. When did I attend my first field Trial?**

My first field trial was at Val Vue Kennels in 1976.

### **4. When did I start working at trials?**

I started working at the trials at the first trial we put on. It was at the six-acre fenced field “backyard” of my home. The trial was called the “TREYBEAU Follies”. It was held on December 31st, 1976, and the purpose of that particular timing was to help my friends’ dog stay in the ASFA top 10. (That is a story for another time).

### **5. What positions have I held in putting on trials?**

I have worked every job at Field Trials. I will rank them as I enjoy doing them.

Lure Operator- The best and most rewarding job. Especially if the hounds work with you to make them Look good.

Judging- The second-best job. They invite me for my opinion, and then disagree with it and argue with me. It is my opinion. How can it be wrong?
