From Dallas:
Take the Dallas North Tollway NORTH until it officially ends at US Hwy 380 at the north end of Frisco. When the official Tollway ends, CONTINUE STRAIGHT across US 380 on the Tollway Extension (2 lane road.) When the Tollway Extension dead ends at FM 428 in Celina, TURN RIGHT (East) on FM 428. Follow 428 around the curves until it dead ends into FM455. TURN LEFT (west) on FM 455 and continue around the curve about 1 mile and turn LEFT on County RD 9. Go approximately 1/2 mile on RD 9 and turn LEFT onto Rawhide Rd. (Look for the Lure Coursing signs.) Go to the top of the second hill on the right hand side and 7655 on the mailbox. Any hound that is ASFA pointed, or is pointed in its country of residence, or is AKC pointed, is eligible to enter a Regional Invitational in an appropriate stake, including Single Stake, if offered. Proof of non-ASFA points for hounds should be in the form of a photocopy of the certificate, or a page of formal printing, included with the entry. For a Limited breed to be eligible, the entry must have one first placement, or two second placements, with competition in the Limited Stake. For a Provisional breed to be eligible, the hound must have received a placement with competition. All points or placements must be earned by the closing date of the event. An eligible hound may be entered in any number of Regional Invitationals. Hounds entered in the Single Stake are not eligible to be entered in Breeder, Kennel, or Bench stakes.

ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis and Whippets may be entered in the regular stakes. **Limited breeds** may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

STAKES OFFERED

OPEN STAKE: Any eligible sighthound, excluding ASFA Field Champions of record, that have met the certification process. **FOR REGIONALS, all dogs must have at least 1 ASFA point.**

FIELD CHAMPION STAKE: Any ASFA Field Champion

VETERAN STAKE: Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least seven years.

LIMITED STAKE: Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field. **For a Limited breed to be eligible at the Regional,** the entry must have one first placement, or two second placements, with competition in the Limited Stake

SINGLE STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

Lure Coursing Instinct STAKE: Open to all Non-Sighthound breeds. All entries shall be individually registered with the AKC (including ILP & PAL), the UKC, the FCI, an ASFA recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each dog's first ASFA field trial entry. Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registration fee at time of entry. **For Regional, Dogs must have run before (no FTE entries.)**

Small is for dogs shorter than 17.5 inches at the withers and / or brachycephalic ("flat-faced") dogs.

Large is for dogs over 17.5 inches at the withers.

Small will run 50% of the course as laid out in this premium up to a maximum of 400 yards. All other sizes will run the full course length.

GENERAL INFORMATION

Conditions of Entry:

- All entries must be one year or older on the day of the trial.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.
- Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
- Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- Hounds not present at the time of roll call will be scratched and entry fees will not be refunded.
- All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.
- **Certifications will be offered after the trial as time permits. A \$10 fee is applicable per run.**
- Early-entry fees submitted and accepted with early-entries will be refunded in full if the withdrawal of said entries is requested by the hound's owner or agent prior to the closing deadline for early-entries. Requests may be made by time-stamped email to the FTS or by direct contact (phone or in person) with the FTS. No refunds for early-entry fees will be returned after the closing of early-entries unless the entered hound upon inspection is lame or in season.
- Day-of-trial-entry fees submitted and accepted with day-of-trial-entries will be refunded in full if the withdrawal of said entries is requested by the hound's owner or agent prior to the closing deadline for day-of-trial-entries. Requests must be made in person to the FTS. No refunds for day-of-trial-entry fees will be returned after the closing of day-of-trial-entries unless the entered hound upon inspection is lame or in season
- Electrical-powered, continuous loop lure machine will be used with back-up equipment available
- The lure will consist of light and/or light colored plastic and/or fur.
- Muzzles are not required; it is the responsibility of the owners to determine if their hound should be muzzled. If a muzzle is used, it must be of a color other than yellow, pink or blue
- Late, conditional, unsigned, incomplete or unpaid entries will not be accepted
- Early-Entries will not be acknowledged by mail; Entries will be acknowledged by e-mail if requested and if an e-mail address is provided
- Substitutions may be made for hounds lame or in season **at the time of roll call**
- For the Regional Invitational, all hounds must have earned at least 1 ASFA point in previous trials
- Hounds may enter the SINGLES stake without having ASFA certification, but must provide a copy of their official registration papers

We will follow State and local guidelines.

1. All Field Committee and Lure Operators will wear facial coverings.
2. All participants will wear facial coverings.
3. No food will be served, bring your own breakfast and lunches. Sorry!!! Please bring your own food, water and shade for yourself and your dogs. None will be available at this time.
4. We ask that you park at a safe distance away from each other.
5. Roll Call will be done at everyone's car. The roll call committee will wear gloves and facial coverings. We will ask the owners of females to wipe their dogs and show the inspection committee the tissue.
6. Wickets will be wiped down after each dog.
7. We will have hand washing stations or instant hand sanitizer and wet wipes.
8. We will prop open the portapots when not in use for more air flow to cut down on bacteria.
9. Huntmasters will stand 6 feet from the dogs after inspecting blankets and slip leads.
10. At the starting line, all dogs will stand 6 feet apart.

12. Please be aware of the running orders will be posted as usual.
13. We will also post running orders and scores on **Lone Star Borzoi Club** Facebook page.
14. No self-serve ribbons anymore due to cross contamination.

Lure Chasing Instinct Program Open to NON sighthounds and sighthound mixes

All entries shall be individually registered with the AKC (including ILP & PAL) or the UKC. A photocopy of acceptable registry must be submitted with each dog's first ASFA field trial entry.

- A. AKC Registration as one of the recognized breeds.
- B. AKC Canine Partners, which is for mixed breed dogs and dogs ineligible for AKC registration.
- C. Purebred Alternative Listing (PAL) program, which is for purebred dogs that cannot be fully registered with the AKC to participate in AKC events.
- D. Foundation Stock Service® (FSS), which is for recorded breeds on the road to full AKC recognition.
- E. United Kennel Club (UKC) registration as one of the recognized breeds.

Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registration fee at time of entry. **NO FIRST TIME ENTERED DOGS AT THE REGIONAL.** If the permanent number is not yet available from ASFA, the owner will supply a copy of the Request for Unique Entry Number as proof of request and payment until permanent number is provided to the owner by ASFA.

LCI Stakes:

Small Open: for dogs 17-1/2 inches or less at the withers and / or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC.

Small Senior: for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs who have achieved the title of LCC.

Small Veteran: for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs over the age of 7 years.

Large Open: for dogs over 17-1/2 inches at the withers who have not achieved the title of LCC.

Large Senior: is for dogs over 17-1/2 inches at the withers who have achieved the title of LCC.

Large Veteran: for dogs over 17-1/2 inches at the withers who are over the age of 7 years.

Sighthound Mix Open: for dogs with a sighthound breed in its background who have not achieved the title of LCC.

Sighthound Mix Senior: for dogs with sighthound breed in its background who have achieved the title of LCC.

Sighthound Mix Veteran: for dogs with sighthound breed in its background over the age of 7 years
