PLEASE READ VERY CAREFULLY.

This year we are again in Southern Colorado and the Pikes Peak region, with its wide open spaces and staggering views. The terrain at the trial site is grassy with very sparse overgrazed vegetation, there are no rocks and some cactus. The surface is coarse sand and drains well. As this is private property we strongly recommend that vehicles proceed very slowly entering or leaving the trial site. The altitude is over 7000 feet. We do not expect this to affect either the general health or the athletic ability of your hounds but people with respiratory or cardiac problems should seek medical advice before exerting themselves at this altitude.

FRIDAY, September 16, 2022 SATURDAY, September 17, 2022 & SUNDAY, September 18, 2022 The COLORADO LURE COURSING ASSOCIATION will hold ASFA Sanctioned All-Breed Lure Field Trial all three days at the same location.

ELIGIBILITY TO COMPETE IN CLCA'S GRAND NATIONAL BEST-IN-EVENT

The requirements needed to qualify to compete in the Grand National Best in Event run which will take place on Sunday, September 18th after the regular trial are as follows:

- Winner of Best of Breed, Friday, Saturday or Sunday.
- Compete in two of the three ASFA Trials, Sunday being mandatory
- Any hound that is DISMISSED or DISQUALIFIED at the Sunday trial will NOT be eligible to compete in the Best-in-Event.
- All hounds are required to run a BEST OF BREED run on Sunday, whether it is forfeited, the only hound qualifying, or only one in that particular breed.

The Grand National Best-in-Event is NOT an ASFA sanctioned event.

OBJECTIVE

The objective of the GRAND NATIONAL is to bring together the finest lure coursing sighthounds from the continent and to provide for them a challenging test of their relative abilities on a demanding and extended series of courses. The emphasis will again be on the individual breeds with each Best of Breed winner running approximately two miles during the two-day period to earn this title. In order to match various breeds against each other in competition, there will also be a Best-in-Event run-off approximately one mile, depending upon field conditions.

JUDGES

Because of the unusual difficulty of the courses caused by distance and terrain as well as the anticipated quality of the dogs running, all trials will use two judges except for the Best-in-Event on Sunday, when more may be used and be selected from the panel of judges from Friday, Saturday and Sunday.

TRIAL PROCEDURES The ASFA sanctioned field trial on Friday will consist of a course of 790 yards reversed for finals, Saturday's course of 830 yards reversed for finals. Sunday's course will consist of Field "A" of 875 vards and Field "B" of 800 yards, with the preliminary run on Field 1 and the finals on Field 2. Best of Breed runs may be run on either of the course plans. Field "A" and "B" will be joined together for the BEST-IN-EVENT run, which is a NON ASFA event. In order to compete in the 2022 Grand National Best-in-Event run on Sunday, the hounds have to be Best of Breed winners and have competed in two of the three ASFA trials, Sunday being mandatory. No hound will be allowed to compete who fails to receive a minimum of 200 points. All hounds must run a Best of Breed course in order to advance to the Best-in-Event, even if there is only one qualifying hound, or one stake in the breed. This applies to the Sunday trial only. The Best of Breed winners who have met these requirements will be advanced to the 2022 Grand National Best-in-Event competition, which will consist of one course of approximately one mile in length, depending upon course conditions. Any hound that is DISMISSED or DISQUALIFIED during the Sunday Trial will NOT be eligible to compete in the Best of Event Run. Any hound entered only in the Single Stake that wins high single in trial on Friday, Saturday or Sunday and competes in two of the three days with Sunday being mandatory, may compete for Best Single in Event. This will be run on the Best in Event Field and will be judged before the running of the Best in Event.

TROPHIES AND ROSETTES

Ribbons suitably inscribed will be awarded for all placements on Friday, Saturday and Sunday. Trophies will be awarded for Best of Breed on Friday, Saturday and Sunday. The Best-in-Event winner will receive a trophy, along with a Humane Purse to be donated to a recognized canine humane society or research facility, subject to approval by the COLORADO LURE COURSING ASSOCIATION Board of Directors. Donations to the Humane Purse gladly accepted, see separate insert in the premium list. The CLCA is also offering a perpetual trophy for Best-in-Event consisting of a silver plated wine cooler on a walnut base engraved with the names of the Best-in-Field winners, to be retained by the Colorado Lure Coursing Association.



ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis and Whippets may be entered in the regular stakes. Provisional breeds may be entered in the

Provisional Stake or the Singles Stake. Provisional currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

ENTRIES WILL NOT BE ACKNOWLEDGED BY MAIL OR TELEPHONE. LATE, INCOMPLETE, UNSIGNED OR CONDITIONAL ENTRIES WILL NOT BE ACCEPTED.

STAKES OFFERED:

<u>OPEN</u> - Any eligible sighthound, excluding ASFA Field Champions of record that has met ASFA Certification requirements.

FIELD CHAMPION - Any ASFA Field Champion

<u>VETERAN</u>: Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Ibizen Hounds, Rhodesian Ridgebacks, Salukis, and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles."

SINGLE STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone.
Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Provisional breeds are not eligible for these titles.

PROVISIONAL - Any eligible sighthound of an eligible Provisional stake that has met certification requirements.

BREEDER: For any breed which shall have, designated at the time of entry, two

hounds bred by the same person or individual.

KENNEL: For hounds of any individual breed, an entry shall consist of two

hounds designated at the time of entry in one of the regular stakes,

being owned and kenneled by the same person or individual.

BENCH: For any eligible sighthound with proof on file with the ASFA of a conformation champion title from the AKC, CKC or both, or a conformation grand champion title from the UKC.

NO BEST IN FIELD WILL BE OFFERED. BEST IN EVENT ON SUNDAY

GENERAL INFORMATION

Conditions of Entry: All entries must be one year or older on the day of the trial. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more. Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake. Hounds not present at the time of roll call will be scratched. All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified. Hound certification runs will be offered on Friday ONLY and after the trial.

EQUIPMENT: Type of lure machine: battery-powered continuous-loop system. Back-up equipment will be available. Type of lures: highly-visible plastic strips.

A \$20.00 fee will be assessed for any returned checks. Persons exhibiting conduct detrimental to ASFA/CLCA/ any hound(s)/other person(s) will be asked to leave the trial site.

There will be a \$5.00 fine for any owner who does not clean up after his/her hound.

A penalty of \$5.00 will be assessed for any loose hound not competing in the course in progress.





790 yards, Prelims clockwise and reversed for the finals




Saturday 9/17/2022

830 yards, Prelims clockwise reversed for finals




Sunday, 9/18/2022

CLCA Lure Coursing Procedures

We will follow the State of Colorado and all local guidelines.

As of 6/7/2022 the number of people at an outdoor gathering is **NOT limited** this may change, and we will adjust accordingly. Further, El Paso County does **NOT** require face-coverings outdoors. Therefore, face-coverings are optional – up to the individual's comfort level. Please continue to maintain social distancing measures and respect the space that others request.

- 1. All participants shall maintain the 6-foot social distancing requirement when interacting with people not in their household.
- 2. No food will be served. Please bring your own food, water and shade for yourself and your dogs. None will be available.
- 3. Park at a 4 to 6-foot distance away from other vehicles.
- 4. Roll Call will be done at a central location. We will ask the owners of females to wipe their dogs and show the inspection committee the tissue.
- 5. Huntmasters will stand 4 to 6 feet from the dogs after inspecting blankets and slip leads.

- 7. Practice social distancing the best you can and respect the space that others request.
- 8. Please be aware of the running order posted.
