

## **Certification Requirements**

All Scottish Deerhounds must be certified prior to the closing date of entries in an ASFA trial. If this is the first trial for your Scottish Deerhound, the judge-signed certification form or waiver (with proof of title) as well as a copy of the hound's registration certificate MUST accompany your entry.

## CONDITIONS OF ENTRY

- All Scottish Deerhounds must be one year or older on the day of the trial. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- All entries in the regular stakes shall be individually registered with AKC (including PAL and ILP), FCI, an ASFA recognized foreign or ASFA Board approved registry.
- A photocopy of an acceptable registry must be submitted with each hound's first ASFA field trial entry.
- Hounds with breed disqualifications are only eligible for the singles stake.
- Bitches in season and hounds lame at roll call will be barred from competing and their entry fees refunded. *No bitches in season on the field.*
- Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
- Hounds not present at the time of roll call will be scratched. No refund will be issued.
- All hounds will run twice, in trios if possible or braces, unless excused, dismissed or disqualified.
- Battery or gas powered, continuous loop lure machines will be used. The lure will consist of black or white plastic strips and/or skins. Back up equipment will be available.
- The members of the field committee reserve the right to alter the course plan as required by weather and/or field conditions on the day of the trial.
- There will be a \$5 fine assessed for any loose hound not taking part in a course in progress.
- Persons exhibiting conduct detrimental to ASFA/SDCA/any hound(s)/other person(s) will be asked to leave the trial site.

## **Stakes Offered (Regular Stakes)**

**Open:** Any eligible Scottish Deerhound that has met certification requirements excluding ASFA Field Champions of Record.

**Field Champion:** Any Scottish Deerhound ASFA Field Champion.

**Veteran:** Any eligible Scottish Deerhound that has met certification requirements that is at least 6 years of age.

**Singles:** Any eligible Scottish Deerhound including those disqualified to run in other stakes. Not eligible to run for Best of Breed.

## Non-Regular Stakes Offered

**Breeder:** Any two eligible Scottish Deerhounds designated at the time of entry in one of the regular stakes and bred by the same individual. A hound may be part of only one Breeder Stake. Single Stake entrants are not eligible for this stake.

**Kennel:** Any two eligible Scottish Deerhounds designated at the time of entry in one of the regular stakes and owned by the same individual. A hound may be part of only one Kennel Stake. Single Stake entrants are not eligible for this stake.

- ◆ Come early (one hour before roll call) and start by carrying equipment.
- ◆ Learn as you go how to place pulleys and tie downs, eventually

### **Field Clerk**

- ◆ Volunteer to help the field clerk for even one stake
- ◆ Learn how scores are tabulated and recorded - when you are comfortable with this you will be able to start helping the field trial secretary.
- ◆ The benefit is you will get a whole new perspective on the course and may learn by listening to the judges.

### **Runner**

- ◆ Volunteer to run paperwork from the field clerk to the field trial secretary after each stake has run.
- ◆ Scores can only be posted as quickly as the paperwork is delivered to the field trial secretary.
