### Eligible Breeds and Registry

Only purebred Afghan Hounds, Azawakh, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhound, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughi, and Whippets may enter the regular stakes.

Provisional breeds may be entered in the regular stakes. Current Provisional breeds include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequino) and Portuguese Podengo (Medio and Grande) and must be individually registered by the appropriate registry.

All entries shall be individually registered with the AKC (ILP and PAL included), NGA, FCI, UKC or an ASFA recognized foreign or an ASFA approved registry or possess a CRN from SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry. This requirement is waived for hounds registered with the NGA.

### Stakes Offered

Open: Any eligible sighthound that has met certification requirements, excluding ASFA FieldChampions of record.

Field Champion: Any ASFA Field Champion

Veteran: Any eligible sighthound that has met certification requirements whose age exceeds 6years (5 years for IWs, 7 years for Afghans, Ibizan Hounds, Rhodesian Ridgebacks, Salukis and Whippets.)

Single: Any eligible sighthound including those disqualified to run in other stakes. (Hounds run alone and are not eligible for BOB or BIF.) Hounds are eligible to earn TCP and CPX titles from the Singles stake. Provisional breeds are not eligible for these titles.

Provisional: Any eligible sighthound of a Provisional breed that has met certification requirements. Not eligible to compete in BOB or BIF.

Best in Field: will not be offered either day.

All entries must be one year or older on the day of the trial. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more. Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered. Hounds with breed disqualifications are not eligible to enter except in the Single Stake. Hounds not present at the time of roll call will be scratched. All hounds will run twice, in trios if possible or braces, (except in the Single Stake), unless excused, dismissed or disqualified. Battery powered, continuous loop lure machines will be used. The lure will consist of white plastic strips and/or skins. Back up equipment will be available. Hound certification runs will be offered following the trial. The members of TSSC reserve the right to alter the course plans as required by weather and/or field conditions on the day of the trial. There will be a \$5 fine assessed for any loose hound not taking part in a course in progress. Persons exhibiting conduct detrimental to ASFA/TSSC/any hound(s)/ other person(s) will be asked to leave the trial site. As of January 1, 2003, any hound which is entering a trial the first time, must include a copy of the hound's registration papers with the entry. This applies to hounds entering Open, Veterans, Singles, or Provisional for the first time.

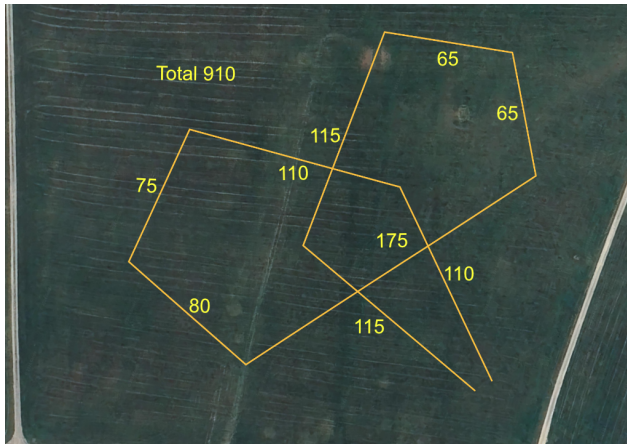

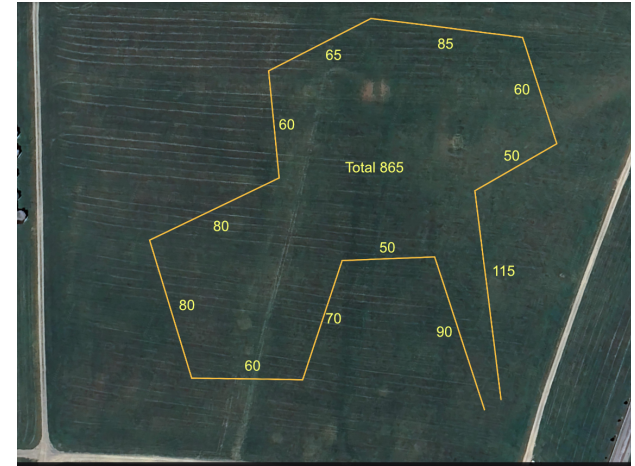

*You can make a difference, even if you can help out for an hour or so. Easy ways to volunteer at a lure coursing field trial (and you don't even have to be a TSSC member):*

### Field Setup

- ◆ Come early (one hour before roll call) and start by carrying equipment.
- ◆ Learn as you go how to place pulleys and tie downs.

### Field Clerk

- ◆ Volunteer to help the field clerk for even one or two breeds
- ◆ Learn how scores are tabulated and recorded - when you are comfortable with this you will be able to start helping the field trial secretary.
- ◆ The benefit is you will get a whole new perspective on the course and may learn by listening to the judges.

### Runner

- ◆ Volunteer to run paperwork from the field clerk to the field trial secretary after each breed has run.
- ◆ Scores can only be posted as quickly as the paperwork is delivered to the field trial secretary.

### Lure Operator

- ◆ Hang around and talk to the lure operator between courses
- ◆ If you are interested, try running the lure around before the trial, at lunch or after the trial at practice.

### Practice

- ◆ Give the volunteers who have been working all day a break!
- ◆ Take the practice list, call out the names and collect the money.

### Fundraiser

- ◆ It's great when people donate things, but even better if you can organize and execute a fundraiser whether it be a 50/50 raffle, silent auction, raffle etc. It doesn't have to be complicated or too time consuming.
- ◆ Feel free to do this at any TSSC trial!
