# EARLY ENTRIES must be received at the field secretary's address by Wednesday, March 26, 2025.

### Gate entries must be received by the Field Secretary before 8:00 am CST.

Entries will be acknowledged by email provided an email address is provided (not by mail or phone).

Incomplete, unsigned, conditional or LATE ENTRIES WILL NOT be accepted. Entry forms by minor owner/handlers (under the age of eighteen years) must be signed/cosigned by a parent or guardian. Substitutes for lame or in-season hounds are allowed if the substitute has the same owner and the Field Secretary is notified at least one hour prior to the roll call.

Any entry marked "First Time Entry" must be accompanied by a completed ASFA hound certification form or an AKC QC certificate (not required for entries in the Singles Stake). A photocopy of acceptable registry must be submitted with a hound's first ASFA field trial entry (not required for first time entered NGA hounds).

## **Eligible Sighthound Breeds & Registry**

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis, Whippets, and Provisional breeds may be entered in the regular stakes. Current Provisional breeds include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

## **Sighthound Stakes Offered**

**Open:** Any eligible sighthound that has met certification requirements, excluding ASFA Field Champions of record.

**<u>Field Champion:</u>** Any ASFA Field Champion.

<u>Veteran:</u> Any eligible sighthound that has met certification requirements whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years and Afghans, Ibizan, Rhodesian Ridgebacks, Salukis, and Whippets, whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

<u>Provisional:</u> Any eligible sighthound of a Provisional stake breed that has met certification requirements. Not eligible for Best of Breed or Best in Field.

<u>Singles:</u> Any eligible sighthound including those disqualified to run in other stakes. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake.

### Best in Field will be offered both days.

### **Lure Chasing Instinct (LCI) Stakes Offered**

LCI is offered both days. Open to NON sighthounds and sighthound mixes. All entries shall be individually registered with the AKC (including ILP & PAL) or the UKC. A photocopy of an acceptable registry must be submitted with each dog's first ASFA field trial entry. Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registration fee at time of entry.

**Small Open**: for dogs 17-1/2 inches or less at the withers and / or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC.

**Small Excellent**: for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs who have achieved the title of LCC.

**Small Veteran**: for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs over the age of 7 years.

<u>Large Open</u>: for dogs over 17-1/2 inches at the withers who have not achieved the title of LCC.

<u>Large Excellent</u>: is for dogs over 17-1/2 inches at the withers who have achieved the title of LCC.

<u>Large Veteran</u>: for dogs over 17-1/2 inches at the withers who are over the age of 7 years.

<u>Sighthound Mix Open</u>: for dogs with a sighthound breed in its background who have not achieved the title of LCC.

<u>Sighthound Mix Excellent</u>: for dogs with sighthound breed in its background who have achieved the title of LCC.

<u>Sighthound Mix Veteran:</u> for dogs with sighthound breed in its background over the age of 7 years. When running as a stake within a regular ASFA trial, Small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length.

# **Important Information**

- All entries must be one year of age or over on the day of the trial.
- Hounds not present at roll call will be scratched.
- Bitches in season, hounds with breed disqualifications, and lame hounds will be excused.
- Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- · Monorchid, cryptorchid, spayed, or neutered hounds may be entered.
- Stake will be split if the entry in any one stake is 20 or more hounds at the time of the draw.
- All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.
- Muzzles are not required; it is the responsibility of the owner to determine if their hound needs to be muzzled.
- Lure machine is battery powered, continuous loop. Back-up equipment is available.
- Lure will consist of highly visible plastic strips.
- The course will be reversed for finals and again for run-offs and Best of Breed.
- SLASH reserves the right to alter the course plans as needed due to weather or field conditions on the day of the trial.
- A fee of \$20 will be assessed for any returned checks.
- There will be a \$5 fine for any loose hounds on the field that is not part of the course in progress.
- There will be a \$15 fine for any owner/handler who does not clean up after their hound.
- Persons exhibiting conduct detrimental to ASFA/SLASH/any hound(s) /other person(s) will be asked to leave the trial site.
- Hound certification runs will be offered Saturday only following the trial pending condition of the equipment and weather.




