Stakes Offered (Regular Stakes)

Open: Any eligible Whippet that has met certification requirements, excluding ASFA Field Champions of record. The hound certification will be waived for a hound that has earned a lure coursing title from another recognized organization, if such title requires competition, and if a waiver for such title has been approved by the ASFA. If first time entered hound—proof of title and waiver form must accompany entry.

<u>Field Champion</u>: Any ASFA Field Champion Whippet

<u>Veteran</u>: Any eligible Whippet that has met certification requirements whose age is at least 7 years. (No first time entered whippets may enter the Veteran Stake.) <u>Singles</u>: Any eligible whippet, including those disqualified to run in other stakes. Singles entries are not eligible for Best of Breed or Best in Field. Whippets are eligible to earn TCP and CPX titles from the Singles stake. Entries in the Singles Stake are <u>LIMITED TO THE FIRST 15 SINGLES TO ENTER</u>. No first time entered whippets are allowed to enter the Singles Stake.


- All Whippets must be one year or older on the day of the trial. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.

If you are completing your entry form by hand, please print clearly. The information in the catalog is dependent on the legibility of what is submitted.

Please include all titles, separated by commas, for entries with multiple titles.
