- LARGE VETERAN: for dogs over 17.5" at the withers who are over the age of 7 years.

- SIGHTHOUND MIX OPEN: for dogs with a sighthound breed in its background who





ADDITIONAL INFORMATION

- There will be a \$5.00 fine assessed for any loose hound not participating in the course.
- Any person may, upon reasonable complaint, be asked to leave the grounds by the Field Trial Committee.
- Any hound which is entered in a trial must have a copy of the hound's registration papers to send in with the entry. This is true if the hound is entering Open, Veteran, Singles, or Provisional stakes for the first time.
- Dakota County Fairgrounds are not securely fenced; it is strongly recommended that prior to running your hound, you have good control over your dog, as the dogs will run off leash.
- Handlers should wear comfortable, sturdy shoes and be physically able to hold, catch, and release their dogs.
- Coursing is a physically demanding sport and can tax a hound's physical strength.
 Hounds that are old, have physical ailments, or are out of condition may be at greater risk for injury. Consult your veterinarian if you have any concerns.
- Muzzles are not required but are permitted at the handler's discretion.
- Please do not bring bitches known to be in season to the field.
- Each entry will be inspected for breed disqualifications, lameness, fitness to compete, and females in season.
