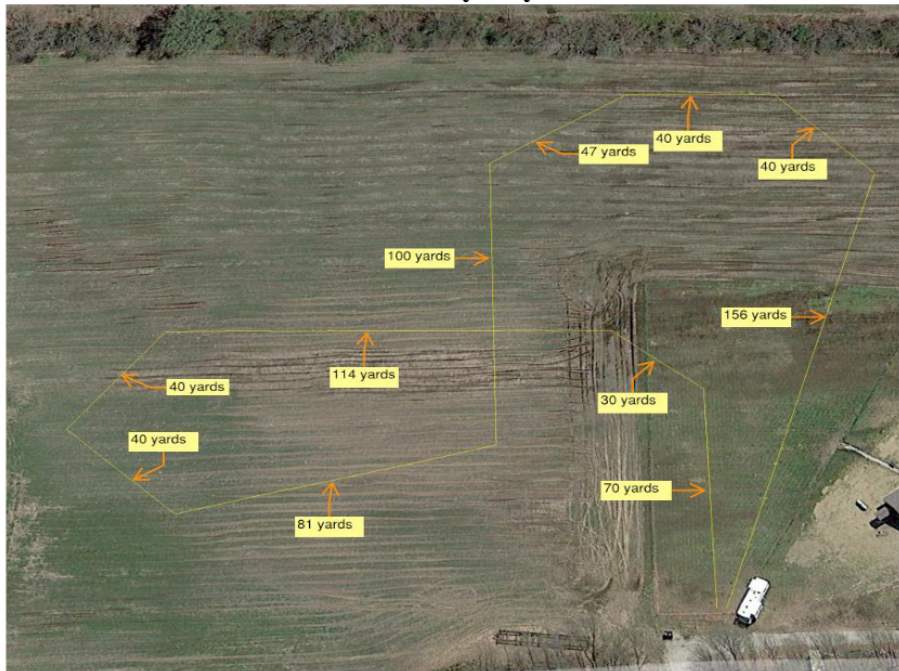
Directions to Isen Farm, 1690 Griffiths Rd, Sorento, IL 62086

From 1-55 North or South: take Exit 37 for Livingston/New Douglas, go East approximately 5 miles into the town of New Douglas, turn left (North) onto Main Street (at the stop sign), then in 1/4 mile turn right (East) onto Sorento Road. Go approximately 5 miles and turn left onto Griffiths Road. Field is 3/4 mile on the right, just past the county rock pile (which is on the left).

From 1-70 East or West: take Exit 36 for Pocahontas and go North approximately 4 miles to IL-140 (first stop sign). Turn left (West) on IL-140, go 1 mile then turn right (North) onto Old Ripley Road. Follow Old Ripley Road 6.3 miles to stop sign, turn left (West) onto New Douglas Avenue. Go 0.4 miles, turn right (North) onto Griffiths Road. Field is 3/4 mile on the right, just past the county rock pile (which is on the left).

## ALL DOGS RUN AT OWNERS SOLE RISK

- All entries must be 12 months of age or older on the day of the trial.
- Each dog requires an entry form
- Entries will not be accepted without fees, signatures, or the “Agreement” found on the Official ASFA Entry Form
- Bitches in season and lame dogs will be excused. Entries will be refunded
- Coursing is an athletic activity that can tax a dog’s physical strength.
- Dogs that are overweight and/or out of condition may be at greater risk for injury and exhaustion. The Inspection Committee has the authority to disallow a dog’s entry, and in such instances, applicable entry fees will be refunded
- **A \$5.00 fine will be assessed for any loose dog on the field that is not competing in the course in progress**
- Battery powered, continuous loop equipment will be used. Lures consist of white plastic.
- Exhibitors should follow their veterinarian’s recommendation to assure their dogs are free of parasites, any communicable diseases and have appropriate vaccinations.
- The Huntmaster is responsible for field safety and therefore he/she is in complete charge of all dogs and handlers on the field. In service to this responsibility, he/she has the authority to stop the lure in any potentially dangerous situation and signal the handler to retrieve a hound
- Persons exhibiting conduct detrimental to the ASFA/BCOA/any dog(s)/other person(s) will be asked to leave the trial site.
- Bring your own shade & water
- No entry fees will be refunded if the event cannot be started or completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or its members and representatives.
- The event-hosting club or Isen Farm, its agents, members, representatives, volunteers, etc. assume no liability or responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children or spectators before, during, or after this event.

Conditions of Entry: All entries must be one year or older on the day of the trial. If the entry in any regular stake is 20 or more, the stakes will be split into flights by public random draw. Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call and refunds provided. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake. Hounds not present at roll call will be scratched and no refund provided. All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound’s first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

### Stakes Offered

**OPEN STAKE:** Any eligible basenji, excluding ASFA Field Champions of record. Must possess certification form signed prior to the close of entries

**FIELD CHAMPION STAKE:** Any ASFA Field Champion (basenji only)

**VETERAN STAKE:** Any eligible basenji whose age is at least six years. Points & placements go toward VFCh and VLCM titles.

**SINGLES STAKE:** Any eligible basenji including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Provisional breeds are not eligible for these titles.

### NON-REGULAR STAKES OFFERED

**BREEDER STAKE:** An entry shall consist of two basenjies bred or co-bred by the same individual. Basenjies must be entered in one of the regular stakes (Open, FCh, or Veteran) Scores of the two basenjies will be added and the highest combined score will be awarded the Breeder Stake Award.

**KENNEL STAKE:** An entry shall consist of two basenjies owned by and living with the same person. basenjies must be entered in one of the regular stakes (Open, FCh, Veteran). Scores of the two basenjies will be added and the highest combined score will be awarded the Kennel Stake Award.

**FOR BREEDER AND KENNEL STAKES:** Entries may consist of the identical pairing of dogs, but each dog may only be entered once in each stake. Hounds are named at the time of entry by completing the attached form. Singles are treated as a “breed” unto themselves, therefore both dogs must be entered in singles to be in Breeder or Kennel Stake.
