FIELD CHAMPION STAKE: Open to Silken Windhound ASFA Field Champions. **VETERAN STAKE:** Open to any eligible Silken Windhound whose age is over 6 years, on the day of the trial. Points and placements go towards the V-FCh and V-LCM titles. **SINGLE STAKE:** Open to any eligible sighthound breed including those disqualified to run in other stakes. They are not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles Stake. Limited breeds are not eligible for these titles. When running as a stake within a regular ASFA trial, small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length.






