
## **LURE COURSING TRIAL**

**OPEN STAKE:** Open to any eligible Silken Windhound excluding ASFA Field Champions of record, that have met certification requirements.

FIELD CHAMPION STAKE: Open to Silken Windhound ASFA Field Champions.

**VETERAN STAKE:** Open to any eligible Silken Windhound whose age is over 6 years, on the day of the trial. Points and placements go towards the V-FCh and V-LCM titles. **SINGLE STAKE:** Open to any eligible sighthound breed including those disqualified to run in other stakes. They are not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles Stake. Provisional breeds are not eligible for these titles. Hounds will run alone.

LURE COURSING INSTINCT STAKES: Open to all Non-Sighthounds and Sighthound mixes: Small Open for dogs 17 ½ inches or less at the withers and/or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC. Small Senior: for dogs 17 ½ inches or less at the withers or brachycephalic ("flat-faced") dogs who have achieved the title of LCC. Small Veteran: for dogs 17 ½ inches or less at the withers and/or brachycephalic dogs over the age of 7 years. Large Open for dogs over 17 ½ inches at the withers who have not achieved the title of LCC. Large Senior: is for dogs over 17 ½ inches at the withers who have achieved the title of LCC. 




