### DIRECTIONS TO THE FIELD:

#### Directions from the North:

From Interstate 70 in Frederick, MD: take Route 340/15 South. Bear onto 15S at the split. Leesburg is 24 miles. Follow 15/7 Leesburg bypass to 15 South. Oatlands is 6 miles south of Leesburg on Rt. 15. Turn LEFT on to Oatlands Plantation Lane. Watch for coursing signs.

From Washington Beltway: take either Route 7 or Dulles Greenway west to Leesburg 15/7 bypass, then exit south on Route 15-South.

Follow rest of directions above.

#### Directions from the South:

Follow Route 15 North toward Leesburg. Oatlands is on the right before Leesburg. Go to the main entrance, Oatlands Plantation Lane.

Follow coursing signs to the field.

#### FIELD:

The field is fenced with typical board farm fencing. Please bring your own shade and water.

All points or placements must be earned by the closing date of the event. An eligible hound may be entered in any number of Regional Invitationals. Hounds entered in the Single Stake are not eligible to be entered in Breeder, Kennel, or Bench stakes.

### ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, and Whippets.

Provisional breeds may be entered in the Provisional Stake or the Singles Stake. Provisional breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

### REGULAR STAKES OFFERED

**OPEN STAKE:** Any eligible sighthound that has met certification requirements, excluding ASFA Field Champions of record.

**FIELD CHAMPION STAKE:** Any ASFA Field Champion

**VETERAN STAKE:** Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Ibizan Hounds, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

**PROVISIONAL STAKE:** Any eligible sighthound of a Provisional breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

**SINGLE STAKE:** Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPS titles from the Singles stake. Provisional breeds are not eligible for these titles.

**Lure Coursing Instinct STAKE:** Open to all Non-Sighthound and mixed breeds. All entries shall be individually registered with the AKC (including ILP & PAL), the UKC, the FCI, an ASFA recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of the acceptable registry must be submitted with each dog's first ASFA field trial entry. Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registration fee at time of entry. This stake will be limited to a total of 20 entries.

**Small** is for dogs shorter than 17.5 inches at the withers and / or brachycephalic ("flat-faced") dogs.  
**Large** is for dogs over 17.5 inches at the withers.

**Small** will run 50% of the course as laid out in this premium up to a maximum of 400 yards. All other sizes will run the full course length.

### **NON-REGULAR STAKES OFFERED**

**KENNEL STAKE:** For hounds of any individual breeds; an entry shall consist of two hounds, designated at time of entry, in one of the regular stakes being owned and kenneled by the same person.

**BREEDER STAKE:** For any eligible breed which shall have, designated at time of entry, two hounds bred by the same individual.

**BENCH STAKE:** For any eligible sighthound with proof on file with the ASFA of Conformation champion title from the AKC, CKC or both, or a conformation grand champion title from the UKC.

**BEST SINGLE IN EVENT:** Top Single, Saturday \* Sunday May compete in single runs on Sunday for Best Single in Event

**BEST IN FIELD WILL NOT BE OFFERED either day.**

**BEST in EVENT WILL BE OFFERED ON SUNDAY, DOGS MUST BE ENTERED BOTH DAYS TO QUALIFY FOR BEST IN EVENT**

### **CONDITIONS OF ENTRY**

- All entries must be one year or older on the day of the trial.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.
- Exhibitors are requested not to bring bitches known to be in season to the field
- Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
- Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- Hounds not present at the time of roll call will be scratched.

- ~ All hounds will run twice, in trios if possible or braces (except in the Single Stake & LCI's), unless excused, dismissed or disqualified. The members of CHAMP reserve the right to alter the course plan as required by weather and/or field condition on the day of the trial.
- Each entry will be examined at inspection for breed disqualifications.

### **Exhibitor Information**

The course will be reversed for the finals, runoffs and Best of Breed. The members of CHAMP reserve the right to alter the course plan as required by weather and/or field conditions on the date of the trial. Exhibitors are requested to not bring bitches known to be in season to the field. There will be a \$5.00 fine assessed for any loose hound not participating in the course. Any person may, upon reasonable complaint, be asked to leave the grounds of the Field Trial Committee. Bring your own shade and water.

**Equipment:** Type of lure machine: battery-powered continuous-loop system.  
Type of lures: highly visible white plastic strip. Back-up equipment will be available.

**DISCLAIMER:** Upon entering this trial, the exhibitor agrees to hold harmless CHAMP, its members, and the event location (Oatlands Plantation) for any injury, loss, or damage sustained by person or hound. 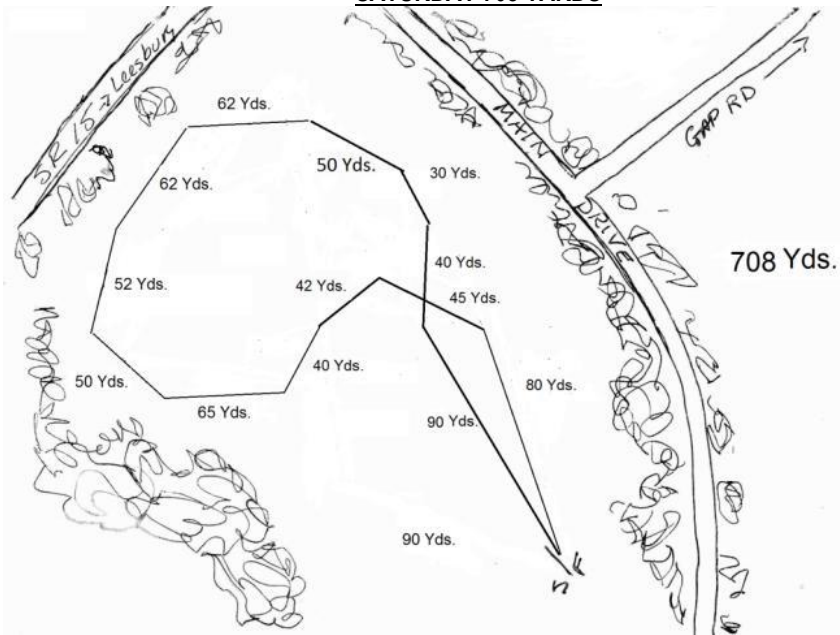

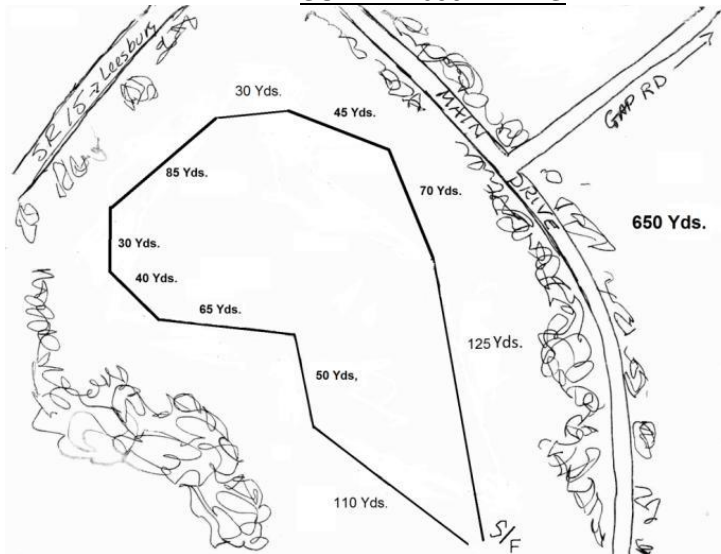

*You can make a difference, even if you can help out for an hour or so.. Easy ways to volunteer at a lure coursing field trial (and you don't even have to be a CHAMP member):*

**Field Setup**

- ◆ Come early (one hour before roll call) and start by carrying equipment.
- ◆ Learn as you go how to place pulleys and tie downs, eventually

**Field Clerk**

- ◆ Volunteer to help the field clerk for even one or two breeds
- ◆ Learn how scores are tabulated and recorded - when you are comfortable with this you will be able to start helping the field trial secretary.
- ◆ The benefit is you will get a whole new perspective on the course and may learn by listening to the judges.

**Runner**

- ◆ Volunteer to run paperwork from the field clerk to the field trial secretary after each breed has run.
- ◆ Scores can only be posted as quickly as the paperwork is delivered to the field trial secretary.

**Lure Operator**

- ◆ Hang around and talk to the lure operator between courses
- ◆ If you are interested, try running the lure around before the trial, at lunch or after the trial at practice.

**Practice**

- ◆ Give the volunteers who have been working all day a break!
- ◆ Take the practice list, call out the names and collect the money.

**Fundraiser**

- ◆ It's great when people donate things, but even better if you can organize and execute a fundraiser whether it be a 50/50 draw, silent auction, raffle etc. It doesn't have to be complicated or too time consuming.
- ◆ Feel free to do this at any CHAMP trial!
