### ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis, Whippets and Provisional breeds may be entered in the regular stakes. Current Provisional include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry. All entries in the regular stakes shall be individually registered with the American Kennel Club, the National Greyhound Association (NGA), including the United Kennel Club (UKC), the Federation Cynologique Internationale, an ASFA-recognized foreign or ASFA Board approved registry or possess a critique registration number (CRN) from the Society for the Perpetuation of Desert Bred Salukis (SPDBS). Provisional stake entries shall be individually registered with the appropriate registry. (Dogs with an Indefinite Listing Privilege (ILP) or Purebred Alternate Listing (PAL) from the American Kennel Club shall be considered registered with that body.)

### **REGULAR STAKES OFFERED:**

**OPEN** - Any eligible sighthound, excluding ASFA Field Champions of record that has met ASFA certification requirements.

**FIELD CHAMPION** - Any ASFA Field Champion

**VETERAN** - Any eligible sighthound which is 6 years or older on the day of the trial, except Irish Wolfhounds whose age shall be at least 5 years; and Afghans, Ibizans, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least 7 years of age and has met ASFA certification requirements. Points go toward V-FCh and V-LCM titles.

**SINGLES STAKE**: Any eligible sighthound including those disqualified to run in other stakes and provisional breeds. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake.

**PROVISIONAL** - Any eligible sighthound of a provisional breed that has met certification requirements.

Not eligible to compete in Best of Breed or Best in field.

**LURE CHASING INSTINCT (LCI) STAKE**: Open to NON sighthounds and sighthound mixes. All entries shall be individually registered with the AKC (including ILP & PAL) or the UKC. A photocopy of acceptable registry must be submitted with each dog's first ASFA field trial entry. Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registration fee at time of entry.

**Small Open**: for dogs 17-1/2 inches or less at the withers and / or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC.

**Small Excellent**: for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs who have achieved the title of LCC.

**Small Veteran**: for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs over the age of 7 years.

**Large Open**: for dogs over 17-1/2 inches at the withers who have not achieved the title of LCC.

**Large Excellent**: is for dogs over 17-1/2 inches at the withers who have achieved the title of LCC.

**Large Veteran**: for dogs over 17-1/2 inches at the withers who are over the age of 7 years.

**Sighthound Mix Open**: for dogs with a sighthound breed in its background who have not achieved the title of LCC.

**Sighthound Mix Excellent**: for dogs with sighthound breed in its background who have achieved the title of LCC.

**Sighthound Mix Veteran**: for dogs with sighthound breed in its background over the age of 7 years.

When running as a stake within a regular ASFA trial, Small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course.

### **Regional Invitational Requirements – for SUNDAY ONLY**

Any hound that has at least one ASFA point, is pointed in its country of residence, or is AKC pointed is eligible to enter a Regional Invitational in an appropriate stake, including Single Stake, if offered. Proof of non-ASFA points for hounds should be in the form of a photocopy of the certificate, or a page of formal printing, included with the entry. For a Provisional breed to be eligible, the hound must have received a placement with competition. All points or placements must be earned prior to the closing date of the event. An eligible hound may be entered in any number of Regional Invitationals. Hounds entered in the Single Stake are not eligible to be entered in Breeder, Kennel, or Bench stakes.

### **NON-REGULAR STAKES OFFERED – for SUNDAY ONLY**

**KENNEL STAKE**: For hounds of any individual breeds; an entry shall consist of two hounds, designated at time of entry, in one of the regular stakes being owned and kenneled by the same person.

**BREEDER STAKE**: For any breed which shall have, designated at time of entry, two hounds bred by the same individual.

**BENCH STAKE**: For any eligible sighthound with proof on file with the ASFA of a conformation champion title from the AKC, CKC or both, or a conformation grand champion title from the UKC.

- PICK UP AFTER YOUR DOG AND YOURSELF!
- EQUIPMENT: Type of lure machine: battery-powered continuous-loop system. Back-up equipment will be available. Type of lures: highly visible plastic strips.
- A \$20.00 fee will be assessed for any returned checks. Persons exhibiting conduct detrimental to ASFA/CLCA/ any hound(s)/other person(s) will be asked to leave the trial site.
- There will be a \$5.00 fine for any owner who does not clean up after his/her hound and for any loose hound not competing in the course in progress.

## How To Enter the Trial

1. Complete the entry form(s) – one entry form for each dog and each day that the dog is entered.
  - a. If this is the first time you have entered this dog in an ASFA trial, AND your dog has an AKC QC (qualified courser) OR an ASFA Certification, you MUST include a copy of that with your entry AND a copy of your registration certification (i.e., AKC, UKC, CKC, etc.)
  - b. If your dog does NOT have an AKC QC or ASFA Cert, you are allowed to run in SINGLES, but not the regular open stake. We offer certification AFTER the trial (Saturday ONLY.) Certification forms are included.
2. Email your entries to the Field Trial Secretary at [kdarci@yahoo.com](mailto:kdarci@yahoo.com) ENTRIES THAT ARE EMAILED MUST BE ACCOMPANIED BY PAYMENT THROUGH the CLCA PayPal at: [Deann.clcatreasurer@gmail.com](mailto:Deann.clcatreasurer@gmail.com). Please add \$1.00 per hound per day entered. If the original entries along with payment are not received the emailed entries will not constitute a valid entry.

## How To Enter LCI

1. Complete the entry form(s) – one entry form for each dog and each day that the dog is entered.
  - a. If this is the first time you have entered this dog in an ASFA trial, you MUST include a copy of of your dog's registration certificate (i.e., AKC, UKC, CKC, etc.)
  - b. If your dog does NOT have a registration certificate and this is your first time entering in an ASFA trial you must complete the form titled: **Request for ASFA Lure Chasing Instinct Registration Number**
2. ## Friday & Saturday July 4-5th:

Certifications and practices will be held AFTER the CLCA trial on Friday and Saturday, WEATHER AND MACHINERY PERMITTING

We will offer limited certifications only on Saturday after the trial.

**All hounds will be inspected before running.  
Lame hounds and bitches in season may NOT run.**

**Certification:** Any entry marked “First ASFA Point Trial” Must have an ASFA Hound Certification form and a copy of the hound’s registration papers, not required for NGA greyhounds, and must present them to the Field Trial Secretary along with your entry before entering a regular ASFA trial. This applies to “First ASFA point trial” hounds entered in the OPEN, VETERAN or PROVISIONAL stake. Certification forms will be available but **MUST** be completed prior to judging. Also have your hound’s registration number available for the Certification Form.

**Certification:** \$7.00, Owners wishing to certify a hound for competition are responsible for arranging a hound of the same breed, or similar running style, to run with his/her dog for the certification.

**Practices:** \$5.00 each dog

**You can make a difference, even if you can help out for an hour or so..**

Easy ways to volunteer at a lure coursing field trial (and you don't even have to be a CLCA member):

**Field Setup/Tear Down**

- ◆ Come early (one hour before roll call) and start by carrying equipment.
- ◆ Learn as you go: how to place pulleys and tie downs; how to measure the course.
- ◆ Help pick up the course at the end of the day.

**Inspection**

- ◆ Check-in dogs; learn how to use the wicket. Help get the trial moving in the morning!

**Field Clerk**

- ◆ Volunteer for one or two breeds – get paperwork from the judges and deliver to the field trial secretary.
- ◆ Learn how scores are tabulated and recorded. Help correct math errors.
- ◆ The benefit is you will get a whole new perspective on the course and may learn by listening to the judges.

**Paddock**

- ◆ Volunteer for one or two breeds – keep the trial moving by making sure people know when they are up next.

**Help your fellow participants**

- ◆ Many people need help managing multiple dogs. Instead of sitting in your car, offer to hold a dog or release a dog.

**Scoreboard**

- ◆ Hang-up scoresheets... keep the trial moving.

**Lure Operator**

- ◆ Hang around and talk to the lure operator between courses.
- ◆ If you are interested, try running the lure around before the trial, at lunch or after the trial at practice.

**Practice**

- ◆ Give the volunteers who have been working all day a break!
- ◆ Take the practice list, inspect the dogs, call out the names.
