Large Veteran: for dogs over 17-1/2 inches at the withers who are over the age of 7 years.

<u>Sighthound Mix Open:</u> for dogs with a sighthound breed in its background who have not achieved the title of LCC.

<u>Sighthound Mix Senior</u>: for dogs with sighthound breed in its background who have achieved the title of LCC.

<u>Sighthound Mix Veteran:</u> for dogs with sighthound breed in its background over the age of 7 years. When running as a stake within a regular ASFA trial, Small will run 50% of the ASFA course as laid out for the

### **GENERAL INFORMATION**

Conditions of Entry: All entries must be one year or older on the day of the trial. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more. Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake. Hounds not present

at the time of roll call will be scratched. All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.




