




Friday July 15, 2022 750 yards, clockwise for prelims and reversed for finals

CLCA Lure Coursing Procedures

We will follow the State of Colorado and all local guidelines. As of 6/7/2022 the number of people at an outdoor gathering is **NOT limited** this may change, and we will adjust accordingly. Further, El Paso County does **NOT** require facecoverings outdoors. Therefore, face-coverings are optional – up to the individual's comfort level.
