**Equipment:** Gas-powered continuous-loop system will be used. ● Lures will be white plastic or fur. ● Back-up equipment will be available.

### ELIGIBLE BREEDS & REGISTRY

Only purebred, Greyhounds may be entered in the regular stakes.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS.

The entry for each hound entering the Open Stake, or Veteran Stake for the first time MUST include a completed & signed ASFA Certification Form or Waiver Form (with proof of title), or AKC QC, and a copy of the hound's registration certificate (certification waived for Singles Stake entries only).

### REGULAR STAKES OFFERED

**OPEN STAKE:** Any eligible Greyhound, excluding ASFA Field Champions of record that has met the certification requirements.

**FIELD CHAMPION STAKE:** Any ASFA Field Champion

**VETERAN STAKE:** Any eligible Greyhound whose age is at least six years, that has met the certification requirements. Points go toward V-FCh or V-LCM titles.

**SINGLES STAKE:** Any eligible Greyhound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed. Hounds are eligible to earn TCP and CPX titles from the Singles stake.

### NON REGULAR STAKES

**KENNEL STAKE:** For Greyhounds; an entry shall consist of two hounds, designated at time of entry, in one of the regular stakes being owned and kenneled by the same person.

**BREEDER STAKE:** For **Greyhounds**, which shall have, designated at time of entry, two hounds bred by the same individual.



**The club reserves the right to alter the course plan for weather and/or field conditions on the day of the trial.**

### COVID PROCEDURES

**Judges, workers, and exhibitors are required to wear a solid facial covering that completely covers the nose and mouth.**

- All members of the Field Committee and Lure Operators will wear facial coverings.
- All participants will wear facial coverings and practice social distancing.
- We ask that all participants park a safe distance away from one another.
- Roll Call will be performed as usual, with everyone socially distanced. The Inspection Committee will wear gloves and facial coverings. Participants with female dogs will be asked to wipe their dogs and show the wiping material to the Inspection Committee.
- The Huntmaster will stand six feet from the participants after inspecting blankets and slip leads.
- At the starting line, dogs will stand six feet apart.
- Running orders will be posted as usual, but please socially distance. If you have a smartphone, please take a photo of the running order and results and do not linger near the postings.

## OTHER INFORMATION

### Conditions of Entry:

- All entries must be one year or older on the day of the trial
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.
- Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
- Hounds with breed disqualifications, or disqualified by another organization are not eligible to enter except in the Single Stake.
- Hounds not present at the time of roll call will be scratched
- All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.
- Hound certification runs will not be offered. (AKC QC Runs are being held on Friday, Sept. 17. Purina Farms ... AKC QC's can be used for ASFA Certification purposes ...email any questions to the Trial Secretary)
- No one, except Field Committee members, will be allowed on the field without the expressed permission of the Field Chairman.
- Anyone exhibiting unsportsmanlike conduct will be excused from the field for the day.
- GCA assumes no liability for injury to any person or dog before, during or after the Trial.

### SITE INFORMATION

- Please bring adequate shade and water for your hounds.
- There will be a port-a-john on site.
- Please park in the parking lot located prior to the bridge.
- No cigarette smoking on or near the field.
