ELIGIBLE BREEDS AND REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Peruvian Inca Orchid, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis, Whippets may be entered in the regular stakes. Provisional breeds may be entered in the Provisional Stake or the Singles Stake. Provisional breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the National Greyhound Association (NGA), the UKC, the Federation Cynologique (FCI), an ASFA-recognized foreign or ASFA Board approved registry or possess a critique registration number (CRN) from the Society for the Perpetuation of Desert Bred Salukis (SPDBS). A photocopy of the acceptable registry must be submitted with each hound's first ASFA field trial entry. This requirement is waived for hounds registered with the NGA.

STAKES OFFERED

OPEN STAKE: Any eligible sighthound, excluding ASFA Field Champions of record, that has met certification requirements.

FIELD CHAMPION STAKE: Any ASFA Field Champion

VETERAN STAKE: Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Ibizan Hounds, Ridgebacks, Salukis & Whippets whose age shall be at least seven years, that has obtained an ASFA certification, AKC QC, or other qualifying waivers prior to the closing date. A copy of the certificate MUST be submitted with the entry forms. Points go toward V-FCh or V-LCM titles.

PROVISIONAL STAKE: Any eligible sighthound of a Provisional breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

SINGLES STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Provisional breeds are not eligible for these titles.

LURE CHASING INSTINCT (LCI) STAKE: Open to NON sighthounds and sighthound mixes. All entries shall be individually registered with the AKC (including ILP & PAL) or the UKC. **A photocopy of the acceptable registry must be submitted with each dog's first ASFA field trial entry.** Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registration fee at time of entry.

Small Open: for dogs 17-1/2 inches or less at the withers and/or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC.

Small Excellent: for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs who have achieved the title of LCC.

Small Veteran: for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs over the age of 7 years.

Large Open: for dogs over 17-1/2 inches at the withers who have not achieved the title of LCC.

Large Excellent: is for dogs over 17-1/2 inches at the withers who have achieved the title of LCC.

Large Veteran: for dogs over 17-1/2 inches at the withers who are over the age of 7 years.

Sighthound Mix Open: for dogs with a sighthound breed in its background who have not achieved the title of LCC.

Sighthound Mix Excellent: for dogs with sighthound breed in its background who have achieved the title of LCC.

Sighthound Mix Veteran: for dogs with sighthound breed in its background over the age of 7 years.

When running as a stake within a regular ASFA trial, Small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length.

BEST IN FIELD will be offered both days.

CONDITIONS OF ENTRY

All entries must be one year or older on the day of the trial • Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more • Bitches in season, hounds with breed disqualifications and lame hounds will be excused at roll call. • Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake • Hounds not present at the time of roll call will be scratched • All hounds will run twice, in trios if possible or braces (except in the Single Stake and LCI), unless excused, dismissed or disqualified.

REGIONAL INVITATIONAL REQUIREMENTS – FOR SATURDAY ONLY

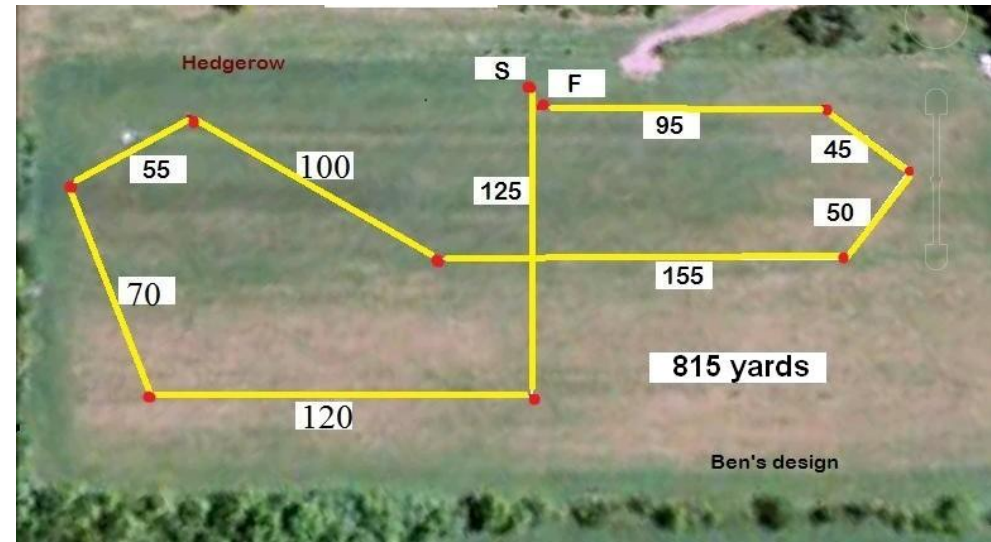
Any hound that has at least one ASFA point, is pointed in its country of residence, or is AKC pointed is eligible to enter a Regional Invitational in an appropriate stake, including Singles Stake, if offered. Proof of non-ASFA points for hounds should be in the form of a photocopy of the certificate, or a page of formal printing, included with the entry. For a Provisional breed to be eligible, the hound must have received a placement with competition. All points or placements must be earned prior to the closing date of the event. An eligible hound may be entered in any number of Regional Invitationals. Hounds entered in the Single Stake are not eligible to be entered in Breeder, Kennel, or Bench stakes.

EQUIPMENT

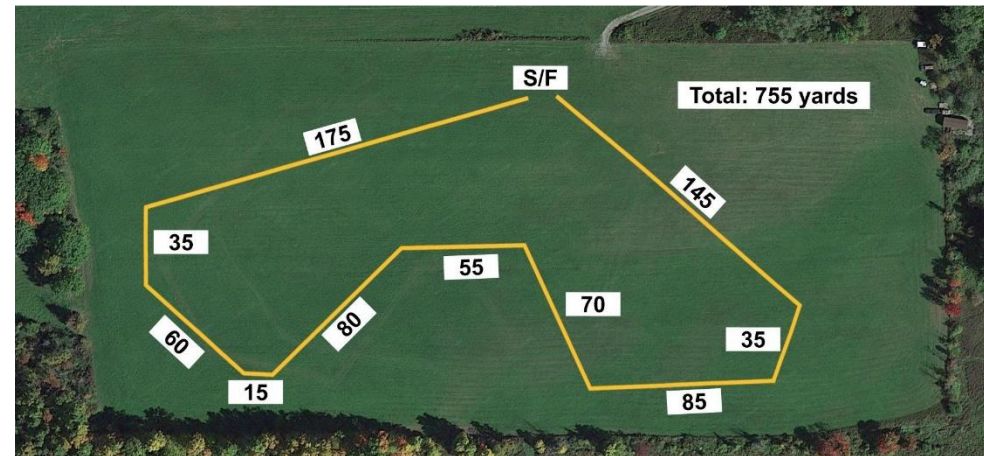
Type of lure machine: Gasoline or battery-powered continuous-loop or drag system. • Type of lures: highly-visible white plastic strips • Back-up equipment will be available.

The course will be reversed for the finals, run-offs, Best of Breed, Best in Field. • The Field Committee reserves the right to alter the course plan as required by weather and/or field conditions on the day of the trial. • Participants should provide their own shade, water and food. • There will be a \$5 fine for any hound loose on the field during another hound's course and for participants not cleaning up after their hounds.

Exit 28: Dunkin' Donuts and **TA Travel Center** with restaurant (gas & diesel), **AmBest** truck stop and restaurant, **McDonald's**.

Exit 28 (mile marker 182—Fonda, Fultonville) has two truck stops with restaurants, a McDonald's, and several gas stations. It's EZ-off, EZ-on and 12 miles from our exit 29.

DIRECTIONS TO THE FIELD

READ FIRST: Some GPS devices may take you to a cow field! Starkville (which might also be called Fort Plain, NY by some GPS maps) is 14 miles southwest of the NYS Thruway Exit 29.

FROM THE EAST or NORTHEAST: New York State Thruway (I-90 W) to Exit 29 (mm 194 – Canajoharie, Sharon Springs, Fort Plain, Cooperstown, Oneonta, St. Johnsville). Turn RIGHT at the stop sign onto NY-5 South. Continue west on NY-5 South for about 3 miles to the village of Fort Plain. Drive across a small steel bridge over the canal. Turn LEFT at the light onto NY-80 South. (*Watch the speed limits & make sure your seat belts are fastened to avoid heavy fines up here.*) Stay on NY-80 South for about 9 miles. Turn LEFT onto Elwood Road (NY-74). (If you reach NY-168 on the right, you passed Elwood Rd.) **** Continue for 1.5 miles (up the hill). We're the first farm on the right after the fields. (Amish farm is on the left). Access to the field is via the gravel driveway before you come to our house. (Signs will be posted.)**

FROM THE WEST or NORTHWEST: New York State Thruway (I-90 E) to Exit 30 (Herkimer). Turn LEFT at the traffic light. Cross over the Mohawk River & Erie Canal bridge and bear RIGHT before the traffic light onto NY-28. Turn LEFT at the next traffic light onto NY-28 South. (Fastrac gas station/convenience store will be on your right after you make the turn – it's the last store & gas station before the house from that direction). Continue south on NY-28 for about 0.7 mile. Turn LEFT onto NY-168. Continue on NY-168 for about 15.3 miles. Turn LEFT at the end onto NY-80 and immediate RIGHT onto Elwood Road. **Follow directions from ** above.**

FROM THE SOUTH (Binghamton area): I-88 E to Exit 13 (Oneonta). Turn LEFT onto NY-205 North. Follow to NY-80 North. Continue on NY-80 North through historic Cooperstown for 10 miles. Cross

the intersection with NY-20. Continue on NY-80 North for about 9 miles. Turn RIGHT onto Elwood Rd (just past NY-168). **Follow directions from ** above.**

ALTERNATE FROM THE SOUTH (Binghamton area): Continue on Rt 205 NORTH onto NY-80/NY-205. Stay LEFT at fork to follow NY-205, then make a slight LEFT onto NY-28 for about 9 miles (Richfield Springs). Make a RIGHT onto US-20 EAST and continue for about 6.3 mile to the traffic light at the intersection of NY-80 (Springfield Center). Turn LEFT at the light onto NY-80 NORTH and continue for about 9 miles. Turn RIGHT onto Elwood Rd (just past NY-168). **Follow directions from ** above.**
